TUDOR (411 – 412) PART I Walter Ludwig

The 411 Tudor pattern was introduced in about 1924. We first see it listed in Catalog 102 and Price List 208 which we date to that year. Collectors used to call this pattern Rib and Panel (a name applied by Clarence Vogel) until a factory advertising pamphlet surfaced that called the pattern Tudor. This pamphlet was the subject of the October 2006 cover story of the Heisey News).

Both names are descriptive of the pattern and reflect the main design element of the pattern. The pattern has very plain vertical panels that are separated by raised ribs. The number of panels varies according to the size of the piece; the smallest number is four and the largest is ten. The Tudor name comes from the distinctive Tudor style of architecture which used boards (or ribs) to separate areas of the external design of buildings.

The pattern started out as a major pattern with almost 75 different pieces that were numbered 411 and 412. The 412 number was used to differentiate multiple items in the pattern that were designed slightly differently. Pieces would later be added with the numbers 413 and 414 to further differentiate variations in stem lines that go with this pattern.

The pattern underwent several changes while it was in production with pieces being dropped and new pieces being added as the buying public dictated what was successful. Even though most of the pattern had been discontinued by the mid-1930s, at least one piece was added at that time.

Because the line is so extensive, I am going to concentrate in this article only on those pieces that were produced in the initial offering of the pattern in 1924. All of the catalog pictures come from Catalog 102 (1924) and the listing of production items come from Price List 208 (1924). The production list also denotes 16 items that had been discontinued by the time Price List 209 (circa

1929) was produced. Of course, by that time several new items had been added to the line. I will have a subsequent article on the evolution of this pattern. (Note that our cover photograph of the pattern includes two items that were not originally available in 1924.)

Tudor is a great pattern in crystal. Because the pattern is not at all fussy, the glassware really shines given Heisey's high quality metal. All of the discontinued pieces were only available in crystal with the exception of the 3 pint tankard which was made in Flamingo. Other discontinued pieces include the footed French Dressing which was the mayonnaise with a spout hand tooled on one side. The footed cream and sugar is now a very hard set to fine given its short production period. The oval candy box is coveted by many collectors; I have seen this item with many interesting cuttings both by Heisey and by decorating companies. The 412 footed and ruffled vases were also no longer available by 1929.

There are a few pieces which made the 208 Price List but do not appear in Catalog 102. This could mean that the price list was made slightly later than the catalog. There is no doubt that the development of this pattern was on-going. Missing in the catalog are the three three-footed bowls which were called preserve, marmalade, and nut bowl depending on how the rim of the bowl was hand tooled. I will be showing the pattern pictures from Catalog 109 in the next installment on this pattern which includes these unmarked bowls. I will also go into pieces made in color in the pattern and further developments in the pattern.



353 MEDIUM FLAT PANEL ASH TRAY NEST

In the Heisey Newsletter of October, 2010, you'll find a reprint of the June, 1927, issue of Table Talk, the Heisey Company's newsletter to its dealers. That issue touted the effectiveness of their bridge contest; big letters at the head of the article reminded dealers that the contest "Proves People Are Reading Heisey Advertisements." On the same spread were a number of quotes from prize winners, with an introduction mentioning the prizes. Men and women received different prizes, each woman getting a set of salad plates of an unstated pattern, and each man receiving a "nest of ash trays."

It isn't hard to surmise the pattern of the ash trays given away. In 1927, Heisey was possibly producing only one set of nested ash trays, and that was a three-piece set included in 353 Medium Flat Panel. For you users of the Vogel books, you won't find the Medium Flat Panel set there. You can, however, see an illustration of the set in Catalogue 102 (ca. 1924). This seems to be the only time they were illustrated. By 1929, they no longer appeared in a price list. I've included photos of the set nested (Fig. 1), and separated (Fig. 2).

Rather than calling these additions to 353 a "nested ash tray set," Heisey labeled them as an "ash tray nest," a slightly unusual turn of phrase. The 1186 Yeoman ashtray set is the only other one that might be called nested and only the large ashtray shows up regularly in that set. There are other patterns where ashtrays come in more than one size, but they were not designed to nest. This set clearly was designed to fit together. They are beautifully scaled, not only in width, but also in height. In the set before me, at least, the tops of the larger two perfectly align when nested; the smallest one is slightly raised.

To our eternal frustration, Heisey sometimes threw unlikely companions together under one pattern. Few people confronted with these ash trays for the first time would immediately think, "Oh, those must be Medium Flat Panel." Seasoned collectors must just shrug and mutter, "Whatever." The strongly incurved sides are unique, not only within pattern 353, but across Heisey glass in general. Early researchers sometimes counted sides to guess pattern affinity, but that wouldn't have helped here. These are 8-sided, whereas there are plenty of other 353 items with other numbers of sides, none of which resemble these ash trays. Nonetheless, Heisey assigned that number to them and illustrated them with the more usual pieces of the pattern.

These deeply scalloped pieces are not obviously ash trays. There being no rim rests, one merely propped the item being smoked as best one could on the piece. Of course, there are other Heisey ash trays that share this trait. Without the rim rest, one could just as easily think of these as candy dishes, dresser organizers, or pin trays. No doubt some owners did use them for other things.

In Catalog 102, the large tray is shown by itself; the two smaller ones appear only in the nest of trays in a separate illustration. Evidently, Heisey anticipated selling the large one singly more often than either of the smaller sizes and this seems borne out by availability now. While none of them are especially common, one does encounter the large tray by itself now and then; the sets are much harder to find. I have never seen either of the smaller ones offered singly, but that just may be me.

The glass in these ash trays is thinner than in many Heisey pressed items, about 3/16" thick. Compare the thickness of, say, the 434 ash tray, a generous 9/16". A nested set of such thick glass would have required much larger individual pieces. The catalogue is silent on their bottom treatment. Unsurprisingly for thinner glass, some are firepolished, such as the single large one illustrated here. However, each one in the nested set shown here is ground and polished on the bottom. Certainly, grinding helps the nested set fit solidly Vital Statistics:

together. Pieces sold singly could do without grinding, and the thinner glass is an incentive to avoid it. Based on the items I've seen, my guess is that the large ones sold singly were usually firepolished.

Some pieces were decorated by one of the anonymous decorating houses that existed at the time. The nested set illustrated here is flashed with a completely covering coppery carnival coating (Editor's Note: The set we have in the Museum has an amber stain that is then cut to clear with a beautiful floral cutting). The large single (Fig. 3) has a grey cutting of a schoolhouse and tree. The cutting wittily uses the Diamond H as a window of the schoolhouse (Figure 4). In our own collection, at least, this is the only time I've seen an incidental feature of a Heisey piece incorporated into decoration. This piece was found in Canada, but I don't know whether the cutting originated there.

500 OCTAGON CREAM AND SUGAR

500 Octagon Cream and Sugar

Octagon is a name given to Heisey's pattern 500. (In a most helpful fashion, 1229 is also called Octagon; luckily for us, it does not have a cream and sugar, so no confusion ensues. See Heisey News, November, 2010, for more on these two patterns.) Not a particularly large pattern, 500 Octagon seems designed mostly to augment other patterns, or to be used when only a few pieces were needed. Why it was given the rather peculiar number of "500" is a mystery. Heisey made a fitful start at numbering a few odds and ends in the 500 series in the 1920s, but most new patterns were by then being numbered in the 1200 series. Doubtless, some sinister Heisey factorum did it just to annoy

the sales staff and the collectors he knew would follow. Most 500 Octagon pieces are marked, including the cream and sugar; at least the ones I have seen have been. As befits the more informal look, the sugar was designed with no cover, creating a little less angst for present-day cream and sugar gatherers.

Judging from today's availability, the pattern was popular. Coming into production about 1928, the cream and sugar are available in Moongleam (theoretically—at least one piece has been found), Flamingo, or Sahara. Crystal ones with Moongleam handles are not too difficult to find. Marigold is possible. Continuing a trend started the previous decade, 500 Octagon creams and sugars were oval in general outline, and for the rest of the company's history, there were always oval creams and sugars in production. Earlier patterns' ovals were always called hotel creams or sugars, in keeping with their smaller capacity compared to those in the table sets early in the century. By the time 500 came along, table sets were outmoded, and most creams and sugars were scaled down. Thus, the Octagon set was not designated "hotel" as it might have been even a few years earlier. Octagon's "oval" is made of eight panels of varying widths.

As done with some other C&S sets, the handles were stuck. However, in this case, the design prevented Heisey from using the flexibility of stuck handles to leverage one mold into two different pieces. The rigidity of the pattern precluded using a hand tool to pull out the cream spout. Instead, the precisely angled spout required that the cream be produced from a different mold than the sugar.

The creams and sugars have recessed bottoms; a star bottom would have cluttered the design. Because the sides taper, the sets are almost stackable, but the handles make that an ugly proposition that only the space-deprived can tolerate.

Vital statistics:

Sugar - Length at rim, 3 7/16" (not including handles); width at rim 2 5/16"; height, $2\frac{1}{2}$ "; base, 3" x $1\frac{3}{4}$ ".

1231 RIBBED OCTAGON CREAM AND SUGAR

The previous article discussed the 500 Octagon The 1231 pattern is cream and sugar. approximately contemporary with them, and, being eight-sided, is called Ribbed Octagon, not an original factory name. In a sense, these two patterns complement each other, since 500 Octagon creams and sugars are essentially oval, and 1231 Ribbed Octagon creams and sugars are essentially round. A number of other patterns, of course, include both round and oval variations within the same pattern, but here, Heisey split them between two patterns. Ribbed Octagon's "round" shape is actually an octagon (surprise!) of eight panels, all the same width and all crisply divided from one another, hence the "Ribbed" part of the name. There are no actual ribs, however, just precise angles.

1231 Ribbed Octagon differs from 500 Octagon in other ways, too. Ribbed Octagon has pressed handles, rather than stuck ones, angular and much resembling the shape introduced with 393 Narrow Flute handled pieces. They are quite a bit taller than the 500's, so the taper of the body is more pronounced. Each piece has a distinct foot, a detail lacking in 500 Octagon. The base was not designed to be ground; the recessed bottom is still there, but the ring is just as it comes out of the mold. Oddly enough, the cream spout is hand tooled, having one angle of the rim pulled out and down, which introduces a bit of a curve in an otherwise straight-lined body. An angular spout was formed in the mold for 500 Octagon, but in the equally geometric 1231 a curved spout is left to the skills and mercies of a workman. different treatment is anyone's guess.

The glass in the 1231 creams and sugars is lighter weight than we find in earlier creams and sugars, another trait shared with #500 pieces. Also like the 500 pieces, no covers were made for the 1231 Ribbed Octagon sugars. Less glass, no lid (one less mold) and no grinding made them cheaper items to produce. These were probably made to compete with the tank glass manufacturers who were selling machine-made ware at cheap prices. The 1231 creams and sugars had a bit more than a dozen companion pieces, most made to appeal to the buyer wanting sets for luncheons or other light entertainment. (Except for that rum pot - ever see one of those at a luncheon? Me neither.) Many of the Ribbed Octagon pieces are unmarked, but our little creams and sugars are marked.

Vital statistics:

Sugar—Height $3\frac{1}{4}$ "; top diameter (opposite angles), 3 $3\frac{8}{8}$ "; base diameter, $2\frac{1}{2}$ ".

Cream—Height, 31/4"; top diameter (opposite angles), 3 5/8"; base diameter, 2 3/8".

Auction Location: GMP Local #244Union Hall, 350 Hudson Ave., Newark, OH 43055

Consignments:

All items consigned for sale or donated are to be made by A. H. Heisey and Company or by other manufacturers using Heisey moulds. The owner/ consignor / member, hereafter referred to as the owner, agrees to accept all responsibility for providing merchantable title for all glass sold.

Each owner may consign a maximum of forty (40) lots to the auction. A list of glass being consigned or donated and prepared by the owner is attached as an integral part of this contract. There is no limit on the number of items in each lot, but HCA retains the right to increase / decrease size / make up of each lot. Each owner may donate an unlimited number of lots to HCA for sale at the auction. HCA, however, at its discretion, will consign donated items for auction, add donated items to the museum collection, and/or sell donated items in the museum shop.

The HCA Auction Committee is authorized to reject any glass not deemed acceptable to HCA standards for this auction. These items may be returned to the consignor if they desire, at their expense. Otherwise, these items become the property of HCA.

Commission:

Owners of glassware to this sale will be charged on the following sliding scale of commission per lot: \$5.00-\$50.00= 40%; \$50.01-\$200.00= 30%; \$200.01-\$400.00= 20%; \$400.01-\$750.00= 15%; \$750.01 and over= 10%.

Settlement:

Payments (settlement) to the owner for glass sold will be made in full not later than fifteen days after the completed auction from the HCA Auction Trust Account. Said account is set up and operated consistent with ORC Section 4707.024. The owner and HCA agree that no other payments will be required to be made in less than fifteen days. HCA will pay expenses including auction site rental, advertising fees related to this auction from its' commission from this account. Collection of funds, bad checks, debts, and unpaid auction lots is the responsibility of HCA.

Responsibility:

It is the responsibility of the owner to deliver the glassware to the National Heisey Glass Museum on or by January 15, 2011. HCA accepts responsibility for the glass after it is received at the Museum and until it is sold except that any glass damaged in shipment to the Museum will be referred to the shipper and owner. All glass damaged or lost while in

the possession of HCA prior to sale will be valued by a qualified appraiser or appraisers and the owner will be paid on this basis, less commission.

Auction and Bidding:

The auction will be a reserve auction. A reserve auction means an auction in which the owner or agent of the owner reserves the right to establish a minimum opening bid, the right to accept or reject any or all bids, or the right to withdraw the real or personal property (lot) at any time prior to the completion of the auction by the auctioneer.

HCA and the owner agree that:

- 1) the items will be sold to the highest bidder without reserve,
- 2) HCA and/or its auctioneer, has the right to accept or reject any or all bids,
- 3) HCA has the right to establish a minimum opening bid,
- 4) the owner may not withdraw the lot(s) at any time prior to the completion of the auction,
- 5) in the event no bids are received on a lot, that lot becomes a donation to HCA.

The minimum opening bid per lot is \$5.00 with a minimum bidding increment of \$2.50.

The owner and HCA both agree that absentee bids will be accepted by HCA. The minimum absentee bid on a lot will be \$15.00 with a minimum opening bid of \$5.00. Absentee bids are bids left by buyers prior to the auction and are executed in a competitive manner. Per HCA policy, HCA does not use the full bid amount as a starting bid. Bidding is initiated in the audience and then offered on behalf of the absentee bidder at the next increment continuously until bidding has stopped. (Example: Absentee bidder leaves a bid with a maximum amount of \$500.00. After item is sold through competitive bidding, the absentee bidder is successful for \$325.00.) HCA reserves the right to accept or reject any and all absentee bids. HCA is not responsible for misfiled bids that are not executed.

The owner or a person on behalf of the owner may make a bid on a lot the owner consigns or has donated if the auction is a reserve auction and the auctioneer provides full disclosure before bidding that the owner retains the right to bid. Absent this disclosure, owners cannot bid or have others bid on their behalf on their own consigned or donated items. Said bidding would constitute bid rigging and be in violation of ORC 4707.023.

General Auction Terms and Conditions:

- 1) Payment: Cash, travelers check, certified check or personal check or money order with proper ID. MasterCard and Visa cards are accepted. 5% buyers premium. Buyers premium deleted for cash or check payment. Cash only payment may be specified for individual bidders at HCA's request.
- 2) HCA has endeavored to describe all items to the best of their ability, however this is not a warranty.
- 3) All items are sold as is and where is. The auctioneer has the right to make any verbal corrections at the time of sale and to provide additional information. Inspection is welcomed during preview and before the item is sold.
- 4) In the case of a disputed bid the auctioneers have the authority to settle disputes to the best of their ability and their decision(s) is/are final. Resale of items will be handled at the auctioneer's discretion.
- 5) The auctioneer has the right to set opening bids and reject any bid raise not in line with established bid increments. Items are sold without reserve, unless advertised otherwise.
- 6) All sales are final and all items must be paid for each day of sale. A moving and storage fee may be assessed for items not picked up within seven (7) calendar days after the last day of sale of the auction.
- 7) Buyers assume full responsibility for items once they are sold unless otherwise specified by HCA or the auctioneer. Buyer must have receipt in hand to pick up items.
- 8) HCA (an auction firm) and all auctioneers used by HCA are licensed by the Ohio Department of Agriculture and bonded in favor of the state.
- 9) Bidding on any item indicates acceptance of these Terms and Conditions of Auction.



2011 HCA SPRING BENEFIT AUCTION GUIDELINES

1) The owner/consignor/member (owner) and the Heisey Collectors of America, INC. (HCA). shall enter into an agreement for glassware items consigned or donated for sale for the benefit of the National Heisey Museum.

- 2) All items consigned or donated for sale are to be made by A. H. Heisey and Company or by other manufacturers using Heisey moulds.
- 3) Each HCA member is considered an owner and can donate an unlimited number of items to be sold at the auction by HCA. HCA, at its discretion, has the right to sell donated glass at auction, add any donated item it chooses to its glass collection, or sell any donated glass in the museum shop.
- 4) Each owner may consign a maximum of forty (40) lots for sale at the Spring Benefit Auction. There is no limit of the number of items in each lot. The auction committee retains the right to increase/decrease the size/makeup of any lot. The committee will not combine lots from different owners.
- 5) Owners of glassware for sale will be charged on the following sliding scale of commission per lot: \$5.00-\$50.00=40%; \$50.01 to \$200.00=30%; \$200.01-\$400.00=20%; \$400.01-\$750.00=15%; \$750.01 and over =10%.
- 6) The owner agrees to accept all responsibility for providing merchantable title for all glass sold.
- 7) HCA agrees to provide settlement in full for glass sold not later than fifteen (15) days after the completed auction. All monies received from the sale will be held in and expenditures will paid from the HCA Trust Account.
- 8) Glassware for the Spring Benefit Auction will be accepted any time prior to January 15 of the auction year.
- 9) The owner is responsible for delivery of the glass to the National Heisey Glass Museum. HCA accepts responsibility for the glass when received at the Museum, except any glass damaged in shipment will be referred back to the shipper and owner.
- 10) Glass damaged or lost while in the possession of HCA prior to the sale will be valued by a qualified appraiser or appraiser selected by HCA and the owner will be paid on this basis, less commission.
- 11) In the event no bid is received on a lot, that lot becomes a donation to HCA. The minimum mail bid on a lot will be \$15.00 with a minimum opening bid of \$5.00. The minimum opening bid on a lot will be \$5.00. The minimum incremental bid increase will be \$2.50.
- 12) The Auction Committee is authorized to reject any glass not deemed acceptable for sale in accordance with HCA standards, plus any glass, as determined by the Auction Committee, not made by A. H. Heisey and Company or not made by another manufacturer using Heisey moulds. These rejected items may be returned to the owner if they desire, at their expense. If the owner does not want the item(s) returned or refuses to pay for shipping, the item(s) become the property of HCA.
- 13) The maximum number of lots to be sold at the Spring Benefit Auction will be as determined by the Auction Committee.
- 14) The Auction Committee will generally catalog glassware for the Spring Benefit Auction in the order it is received at the museum. The committee reserves the right to place lots in a different order if it determines it will improve the auction.


