## PROPOSED UPDATES TO THE CONSTITUTION AND BYLAWS

Over the past several months, our committee undertook a review of HCA's Constitution and Bylaws. Our purpose was to address areas needing further definition, change or updating. As a result of this review, we are proposing a number of changes/updates. The proposed changes/updates were read to the membership at the April regular meeting. Discussion and voting will occur at the June annual meeting. Please feel free to contact me if you have any questions.

We have one proposed change to the Constitution. It provides further definition regarding the composition of the Executive Committee. As you know, this Committee meets each month to discuss items of importance to the operation of HCA and the Museum. The Committee includes the elected officers of the Board of Directors: President, Vice-President, Secretary, and Treasurer. It also is to include the immediate past President unless that person is unable to serve, then a Member-At-Large is "elected by and from the Board." There have been questions for many years as to what should happen when the immediate past President is no longer an elected Board member.

Our research revealed some of the immediate past Presidents served on the Executive Committee while others chose not to since they were no longer on the Board. In order to provide consistency in the way this situation is handled, we are proposing the following change:

### Composition of the Executive Committee

Article VII, Section 1, Executive Committee currently reads:

"The elected officers and the immediate past President shall constitute the Executive Committee. If the immediate past president cannot serve, a member-at-large will be elected by and from the Board. (approved 6/21/81)"

Proposed language:

The elected officers and the immediate past President shall constitute the Executive Committee. *All Executive Committee members shall be duly elected board members. The immediate past President is the person who was last president and does not currently hold that office.* If the immediate past President cannot serve, a member-at-large will be elected by and from the Board.

There are five proposed updates to HCA's Bylaws. The first deals with the number of "regular meetings" each year. The Constitution speaks to "regular meetings" and an "annual meeting." The annual meeting is held in June each year at Convention. The Bylaws currently indicate we are to have "at least three regular meetings." Currently we have two regular meetings, one in conjunction with the Spring Benefit Auction and one in connection with the Percy and Vivian Moore Weekend. There used to be a third regular meeting at a dinner held in December but it has not been held in some time. Thus, we are proposing the following update:

### Regular Meetings

Article I, Section 1 of Meetings currently reads:

"The regular meetings of the organization shall be held at least three times per year at such time and places as the Board of Directors shall designate. (approved 6/18/99)"

Proposed language:

The regular meetings of the organization shall be held at least *two* times per year at such time and places as the Board of Directors shall designate.

The second update is another "clean-up" situation. Under Election of Directors it refers to the "fourth regular meeting." As previously stated, we currently have two regular meetings and an annual meeting. The update would simply change the wording from "fourth" to "second." Change is as follows:

### Election of Directors

Article VII, Section 1(b) of Election of Officers currently reads:

At the fourth regular meeting of the calendar year, the President shall appoint a Nominating Committee of at least three members: the chairman shall be the immediate past President, then a voting member of the organization. If the immediate past President cannot serve, the chairman shall be another member of the Executive Committee, exclusive of the President. (approved 3/11/95)

Proposed language:

At the *second* regular meeting of the calendar year, the President shall appoint a Nominating Committee of at least three members: the chairman shall be the immediate past President, then a voting member of the organization. If the immediate past President cannot serve, the chairman shall be another member of the Executive Committee, exclusive of the President. (approved 3/11/95)

The third update addresses the election of directors. There have been several years where the number of Board candidates equals the number of vacancies in the election. This update proposes in those situations, ballot voting can be deemed unnecessary if approved by a majority of the voting members present. Change is as follows:

Article VII, Section 1(f) of Election of Officers currently reads:

"At the annual business meeting there shall be furnished to the voting members a ballot containing the names of the nominees for Directors, upon

which each voting member shall indicate his or her choices. (approved 3/11/95)"

Proposed language:

At the annual meeting there shall be furnished to the voting members a ballot containing the names of the nominees for Directors, upon which each voting member shall indicate his or her choices. *If the number of nominees equals the number of Director vacancies, the ballot voting shall be deemed unnecessary if approved by the majority of the voting members present.*

The fourth update just cleans up the language in Section 4 of Election of Officers. There are still references to election of the original Board of Directors. Update is as follows:

Article VII, Section 4 of Election of Officers currently reads:

"The Board of Directors shall consist of 12 (approved 6/17/05) members elected from the roll of the voting members. (approved 3/11/95) The term of office shall be for four years. The number of consecutive four-year terms that a member may be elected to the Board of Directors shall be limited to two. (approved 6/20/82) To provide for the continuity of operation, the original board of Directors shall serve for the following terms:

5 persons for 1 year July 1972 to June 1973  
5 persons for 2 years July 1972 to June 1974  
5 persons for 3 years July 1972 to June 1975  
5 persons for 4 years July 1972 to June 1976

To provide for a reduction in the number of directors for 16 to 12, only three persons shall be elected starting in the years 2006 through 2009 and thereafter. (approved 6/17/05)"

Proposed language:

The Board of Directors shall consist of 12 (approved 6/17/05) members elected from the roll of the voting members. (approved 3/11/95) The term of office shall be for four years. The number of consecutive four-year terms that a member may be elected to the Board of Directors shall be limited to two. (approved 6/20/82). *To provide for the continuity of operation, three persons shall be elected each year.*

The fifth and final update contains the most significant changes. There has been a great deal of discussion about HCA's succession plan and what might happen to the Museum and the preservation of its assets if HCA were to surrender its charter. The current language calls for a "unanimous vote of the active voting membership." We feel this is unrealistic and that a two-thirds (2/3) vote of the Board of Directors and a two-thirds (2/3) vote of the voting membership would be more realistic. We also feel it would be better not to designate a specific successor organization in our Bylaws. The new wording provides more flexibility to find an organization to preserve the Museum and its legacy in American glass manufacturing history.

Surrender of Charter

Article VIII, Section 1 of Surrender of Charter currently reads:

"If this organization deems it desirable, by unanimous vote of the active voting membership, to terminate operation of this organization, all assets, records and monies shall be turned over to the Licking County Historical Society and that such shall be used for the study and preservation of Heisey glass and other such ancillary uses of the property as may be deemed necessary. In the event the Licking County Historical Society has been dissolved then such shall be turned over to the Ohio State Historical Society for the same purpose therein stated. (approved 12/17/73)"

Proposed language:

*If this organization deems it necessary to terminate operations, all assets and records used for the study and preservation of Heisey glass, shall be turned over to an organization approved by a two-thirds (2/3) vote of the Board of Directors and a two-thirds (2/3) vote of the voting membership. Said organization shall use the assets and records to continue the study and preservation of Heisey glass.*

# 1415 TWENTIETH CENTURY

1410 milk pitcher

This month we will cover a very small pattern that came out in the early 1930s. The line seems to have had its origins in a small pitcher that has pattern number 1410. One pint milk pitchers were often part of early pattern glass lines and even appear in some of Heisey's early lines. But for some reason the style seemed to go out of favor in the 1920s because you do not see that size in patterns from that time. However, there must still have been some demand for them because Heisey and other glass houses seemed to revive the form in the early 1930s. Heisey's first attempt is the 1410 one pint milk pitcher. The pitcher is small and squat and has some very nice design elements. It rests on what might be called a two step circular foot. The handle looks somewhat inverted with a lower center of gravity than might be expected. The handle terminates at the bottom in a series of three diminishing beads.

It would appear that the company saw this pitcher as the basis of a small breakfast set. Probably in designing the other pieces to go with this set the decision was made to add other design elements to make the pattern stronger. A new foot was put on that incorporated a three step quatrefoil design. Additionally, four raised ridges that start at the top center of each quatrefoil and then extend not quite to the rim of the piece were added. On the picture only

three of these ridges are evident because the handle is where the fourth ridge would be

As I indicated this is a very small pattern, there are three sizes of sodas – 5 oz, 9 oz, and 12 oz. The sherbet would make a nice fruit server at breakfast time. The milk pitcher and the cereal bowl make a very nice combination with the cereal having the same inverted type handle as the milk pitcher. There is one other piece in the pattern and that has always been a bit an enigma. The cereal bowl is listed with a 7" plate. This plate appears to be a very plain plate with absolutely nothing to distinguish it. One can not tell if it was taken from another line (a 7" 1184 Yeoman, for instance) or was truly designed only for this pattern. A blown underplate would have seemed appropriate but with the 1415 number, it should be pressed (this is not conclusive however since the bouillon underplate in Yeoman is blown). As far as I know, no bowls and underplates have ever appeared together for sale. Will we ever solve the mystery of the 1415 underplate?

The name Twentieth Century or 20th Century (either spelling is correct) is a factory designated name for 1415. The name does not appear when the pattern first appears about 1933 in some addenda pages to Catalog 109 or in Price List 210 (June 1933). But in Catalog 211-16 (1935) and Price List 211 (1935) the name "20th Century" appears above both listings. These would be the only listings for this pattern in catalogs and price lists until Catalog and Price List 56 appeared in June 1956 when all items except the cereal bowl and underplate are offered again but only in Dawn.

Price list 210 shows all items in the pattern offered in crystal, Moongleam, Flamingo, and Sahara. By Price List 210 only crystal and Sahara are listed. In addition, the sodas and the sherbet are known in Cobalt. In fact, all items are scarce in this pattern. I have only seen cereals in crystal and Sahara. In Flamingo and Moongleam, I have only seen the 9 oz soda and the sherbet. The milk pitcher has only been seen in crystal, Sahara, and Dawn.



This is a very attractive Art Deco pattern that will be easy to pick up a few pieces but very difficult to find all items.

## 1454 DIAMOND POINT AND 1535 DIAMOND ASH TRAYS

Poor little 1454 Diamond Point. Walk into any antique mall in the land, and there they are, glittering for all they're worth, stacks of them, trying to charm you into finding a place in your home. And what do you do? You walk on by, don't you? Just admit it. These little gems of

Heisey are among the down-trodden masses, dismissed by some because they are just so common, and you can see the words bedecked with icicles as they are uttered. As if that isn't injury enough, Diamond Point suffers the indignity of being mis-identified, not just now and then, but constantly. These little ash trays, practically alone in the world but for their jelly and top hat relatives, are called many things by the unknowing: salts, nut dishes, butter pats, toy bowls, pin dishes, miniature punch bowls (yes,

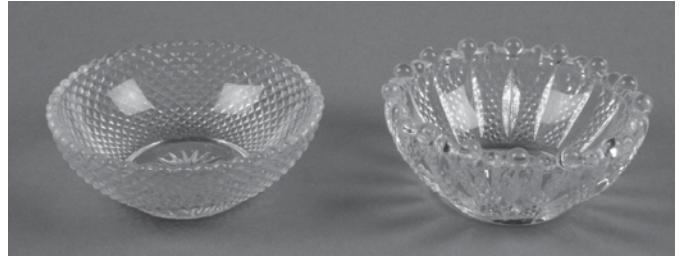


I've seen that one!), and I'm sure you can add to the list.

And yet. Just hold one in the bright light. The glass may be a bit thin, but it is usually as high quality as some of the big fancy stuff, with the brilliance we'd expect of any Heisey product. Each one is covered from top to bottom with 816 perfectly formed little diamond pyramids (864 if you count the tiny partial ones right at the bottom) never losing precision as they become tinier. (Imagine that day in the mold shop, when the foreman had that tedious task to assign. "Hey, Jimmy, I've got a little job for you today....") Why, they even have the Heisey star, delicately scaled down so that there are many fine points (20 in the example I'm looking at), not those blunt 12-point things you see in an 1183 Revere salt, for instance. And look, someone took the trouble to grind and polish the bottom so the star shows up nicely. Heisey seems to have made millions of them (just an impression - I don't have the real figures), but they appear to have marked proudly every last one. The 1454 ash tray appears in Catalog 211 (1935). It last shows up in Price List 217 (1944), and there you have to read carefully. Under the heading "Ash Trays," 1454 is listed simply as "ind. ash tray." Under the heading "Miscellaneous Items," however, both the jelly and the individual ash tray are listed, this time with sizes. The jelly is correctly shown as 3¼", but the ash tray is shown as 4", so either someone made a mistake or there is another size that has never been seen. My money is on the former.

Now, as for what to call them, it's Heisey's own fault that so few 1454 Diamond Point ash trays are actually called ash trays. There is no cue in the shape to hint at cigarettes or ashes, just a simple little bowl with a simple little design. And then they flattened some of them out and called them jellies. Really? Jellies? So often the two appear as a set that they must have been sold together at least part of the time, and that's what gets me. I can hear it now: "Gee, after that cigarette, what I could go for right now is a nice dollop of jelly." I don't smoke, so maybe

I'm missing something, but I don't see empty jelly jars stacking up in the homes of friends who do.

As long as we're dealing with these little ones, let's talk about 1535 Diamond. These ash trays endure the same name-calling as their relatives in 1454 Diamond Point, being labeled something else, and for the same reasons. Vogel illustrates the jelly in Vol. 4 with a photo taken looking directly down on the piece. Since he called it a nut, not having the documentation at the time, this sometimes leads collectors now to call the ash tray a nut dish, apparently assuming that Vogel's photo was the bowl-shaped piece. That, after all, makes more sense as a nut dish than the flat jelly. But the measurement he gives and the spread-out ovals in the pattern leave no doubt which piece he illustrated.

1535 Diamond does not share 1454's commonness. While certainly not rare, they come up seldom enough that some collectors don't know what to make of them. The pattern name took a while to be established. Vogel first gave them a number, 7018, and I've seen them referenced by name as Oval Diamond Point, Oval in Diamond Point, and Pointed Oval Point. But Heisey called them Diamond. The pattern (though not our ash tray) appears in a factory photo from the 1940's, probably around 1947 or so, since a 1567 Plantation one-light candlestick is shown with them. (See the Newsletter, July, 1978.) Apparently, the ash tray and the jelly appear in at least one price list of the time, but it isn't in any of the re-printed ones.

The 1535 ash tray is edged with 16 large beads and 16 small beads. The large beads sit atop

narrow ovals, while the small beads are actually the top of small wedges arising farther down the bowl. (The wedges are more evident on the large pieces such as the comparatively giant salad bowl. Again. Cigarettes and salad? Just what was in those cigarettes, anyway?) The diamonds are less numerous than in 1454. I'm not counting them; consider that your homework assignment. They are also less precise. (Our beleaguered mold-maker was relieved to learn both these facts, I'm sure.) The bottom is simple, plain, and recessed, although marked and ground around the rim. It is sometimes said that this is a copy of the old 150 Pointed Oval in Diamond Point. There is certainly a strong resemblance. There is, however, no way to prove that one begat the other. Given that beaded edge and the lack of a Heisey tradition of copying their older patterns, I doubt it.

# 2011 SPRING ALL HEISEY BENEFIT AUCTION WRAP-UP

Those who attended the 38<sup>th</sup> Annual Spring All Heisey Benefit Auction had a great time! Our two-day auction was held again at the GMP Local #244 Union Hall on 350 Hudson Ave in Newark on Friday-Saturday, April 8-9, 2011. This is the fourth year using this great site. Our two day auction was well attended - approximately 110 guests and members each day and we had 15 absentee bidders. We had 1166 lots of glass available from 50 consignors. We again heard many great comments about the glass we had this year - our consignors sent in nice clean glass and we only had to reject a few unsuitable pieces. The start was set an hour earlier this year on Friday to accommodate the increase of 90 lots - we had the preview on Friday from 1 p.m. to 3 p.m. with the auction starting at 3 p.m. On Saturday, we opened the doors at 8:30 a.m., had our HCA Membership Meeting chaired by President Sue Kilgore at 9 a.m., and started our auction at 9:30 a.m.

How did we do financially? Much better than anticipated! At press time, we have only preliminary numbers. We grossed nearly \$67,600 and after consigners and expenses are paid, we estimate we will net around \$19,400. We had a conservative budget estimate of \$10,000 - FYI our net income from this event had decreased three straight years. Last year we grossed \$52,190 and netted \$12,849 with our budget being \$13,500.

I want to publicly thank, on behalf of the HCA Board of Directors and Staff, the 28 volunteers who worked with us starting in January unpacking, identifying, cataloging, and repacking the glass and then working for three straight days until the auction was concluded. You make this event a success and HCA's largest fund-raiser. I have listed those who helped in a separate block. If you helped and are not listed, I apologize. I must also share with you that every board member (all but one was there) and their friends and spouses stepped up and worked as volunteers the entire time!

I would like to give special thanks: to Joe Harner, president of the Dayton Study Club and Dick Marsh, Buckeye Club member, who working together did all the little things which need doing to help make the

auction successful; to Board member Karen Taylo who ran the clerk's office and auction software program; and lastly to the Dayton Study Club and Buckeye Study Club who worked from start to finish in all parts of this auction.

A "THANK YOU" must also go to Craig Connelly, Auctioneer and his cohorts. They sold our glass and kept us in stitches! Concessionaire extraordinaire Gerry Dush and his gang again served the world's best pies and other food. GMP Local #244's own Jerry West did everything he could to provide us great facilities and went the "extra mile" to make our auction a success.

Last, I would like to thank all the consignors who consigned and donated glass to HCA and to all the auction attendees and absentee bidders who purchased that wonderful Heisey Glass. Hope to see all of you at the Convention in June. Happy Heisey Hunting!! ♦

The 1971 Indianapolis 500 is won by Al Unser for the second year in a row.

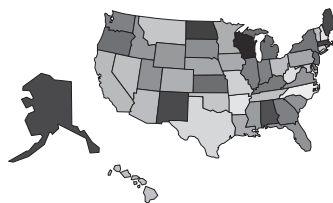

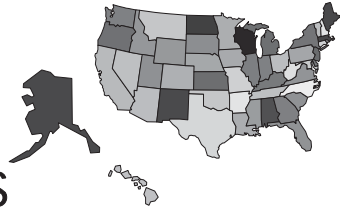
