

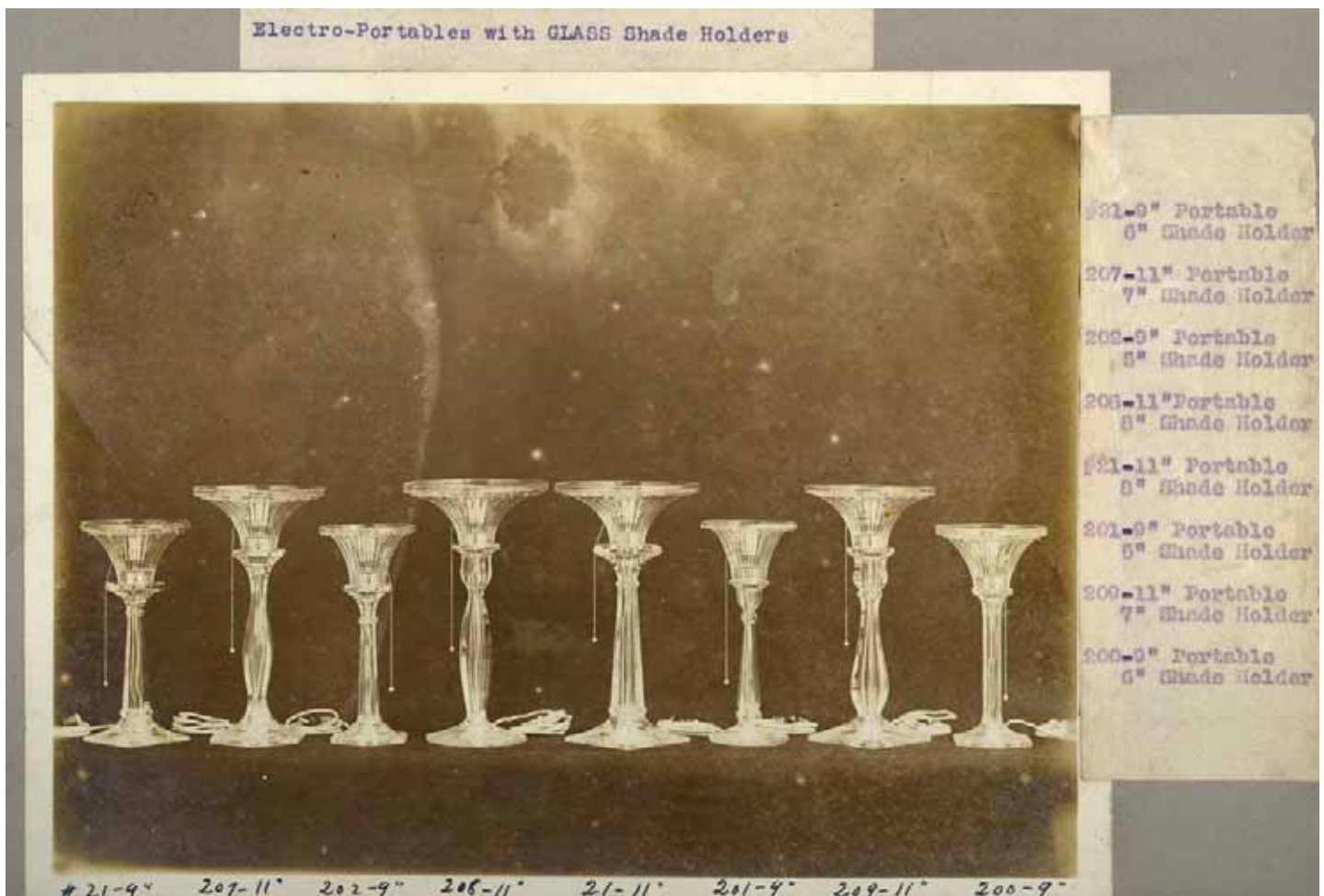

## CURATOR'S REPORT

We are now officially an icebox here in central Ohio. The temperature this morning dipped down into the single digits and the wind chill had that ugly minus sign in front of it. If you ask me, it is time to bundle up and hibernate for a couple of months. Those bears definitely have a good idea. But, unfortunately, there is work to be done here at the Museum, so I better get to it.

In December, I changed the display that the Museum has at the Midland Theater which is located right on the square in downtown Newark. This great old theater has been lovingly restored and provides a great venue for entertainments that visit Newark to perform in. The Museum has long had a display case in the lobby of the theater that allows us to promote the Museum. I mount about three different displays there a year. This time I have used only Heisey Emerald glass with a few pieces of Ruby stained Heisey to accent. It actually makes a great statement for the holidays. The display will be there through March (taking advantage of Valentine Day and St. Patrick's Day), so please stop in and take a look. The lobby is open during the day for ticket sales, so it will not be a problem.

The Museum and HCA has gotten some excellent publicity in the last month. Tom Files spoke with a reporter at the Antiques Trader and an article was published in the December 3 edition. You should be able to read the article on the Antique Trader web site. The title of the article is "A Cut Above: Exquisite Brilliant Heisey Glass."

Also, in December, our own Tanner Temnick got featured on the MTV show "Made." Tanner joined HCA when he was six years old and is now a junior in high school. He continues to volunteer at the Museum. A film crew was here in Newark as a break dance artist taught Tanner the ins and outs of the craft. One interview was held in Tanner's bedroom where his Heisey collection was much in evidence. The break dancer asked him about the pieces and he talked at length about his favorite Heisey glass pieces. The episode can be viewed on the MTV web site.

Finally, I have been working with a free-lance writer for a couple months on an article she has been writing on the 1567 Plantation pattern for the "Cooking with Paula Deen" magazine. That article will appear in the January/February issue of that magazine. The article will focus on the pattern and the way that it reflects southern hospitality. Do look for the magazine on your newsstands.

All of this publicity is very good for the Museum. This is our slow time of year, so if it encourages a few extra visitors, they will be more than welcomed here.

The Holiday Open House was a huge success for the Museum. Besides the children during the day, we saw a lot of new faces visit us during the evening hours when the Sherwood Davidson House (our neighbor and the location of the Licking County Historical Society's museum) was open. Because the weather was cooperating this year we were able to put luminaries up the path of the Museum and it looked especially beautiful to welcome our visitors. You can see a few pictures from the event on page 25 of this Newsletter.

The deadline for getting glass in for the Benefit Auction is fast approaching. We have gotten a few really outstanding items which I really can not talk about until we actually do the cataloging at the end of January. Given the way that Heisey people procrastinate, I am hoping for a big surge in deliveries at the beginning of the year. This event is so crucial for keeping the Museum going all year long.

I am happy to say that I have gotten one more Heisey promotional brochure that I will be able to feature next month. This brochure will be on the 1072 Southwind cutting. Any original promotional material that the company produces is so valuable to the Museum and forms a very important component of our Archives. If you are aware of any additional material out there, please let the Museum know. I love sharing this information with all of our members.

Next month, we will be listing all of the voting members of HCA. If you would like to become a voting member, you only need to pay a one time fee of \$25 and then your voting status will be assured as long as you are a member of HCA.

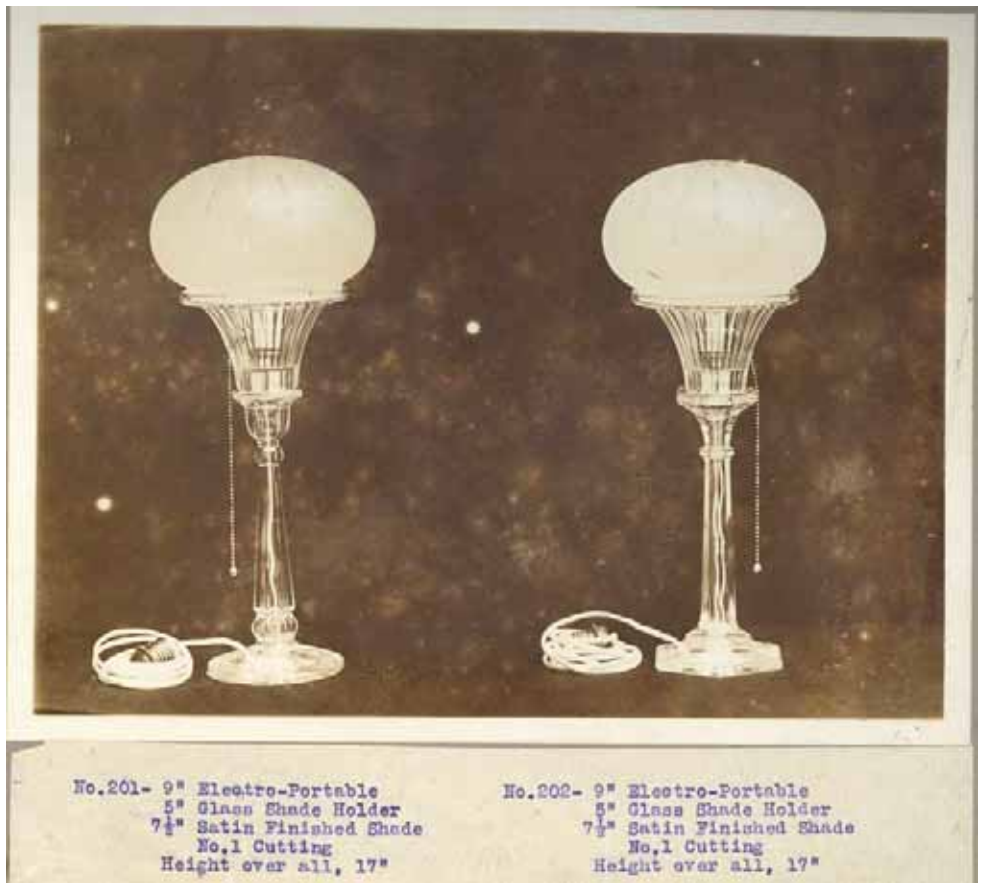
# HEISEY ELECTRO-PORTABLE LAMPS

My great helpers in the Archives are Chuck and Amy Jo Jones. Whenever they are in town they spend a couple hours up there arranging and digging around. Recently, Chuck brought me the pictures that accompany this article.

The pictures are mounted on heavy posterboard and the captions have been pasted on. Three of the pictures were taken with a black background, but the others made use of a background that resembles a starry night sky. The pictures are in black and white. These must have been used by the company to promote their line of electro-portable lamps. All but one model are shown in the pictures. The pictures probably date to about 1915 when the last of the pictured models was introduced and before the missing model was introduced in 1917.

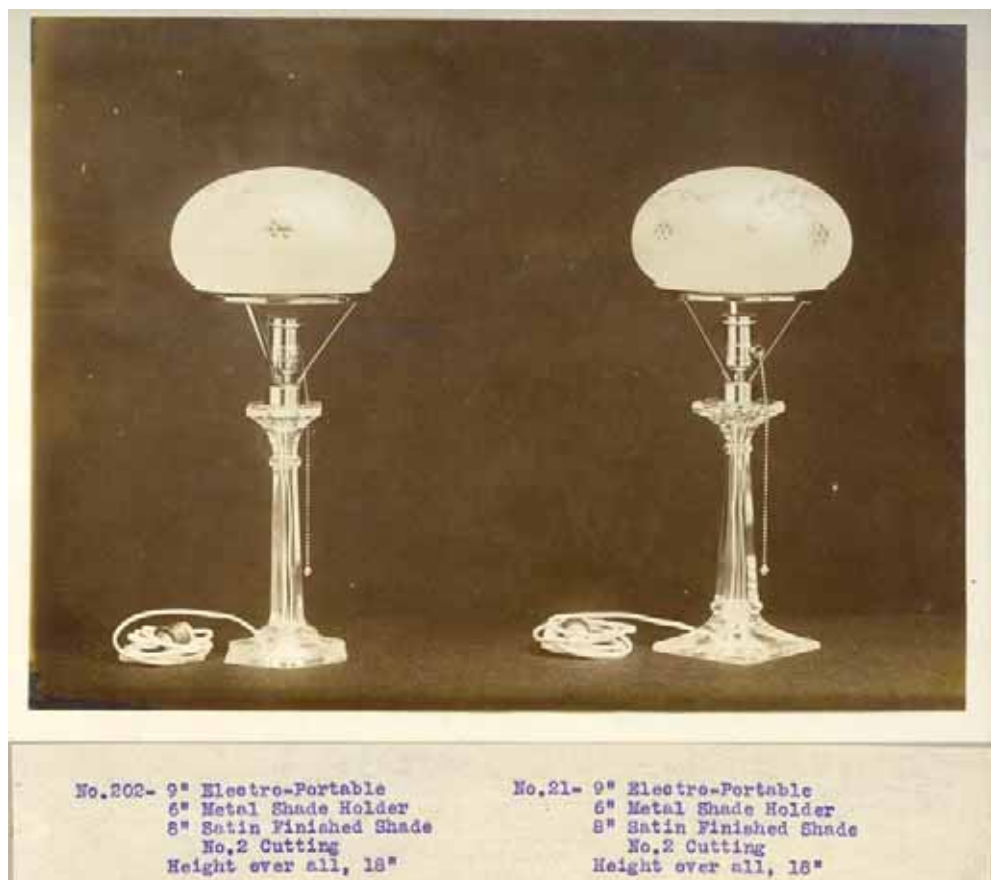
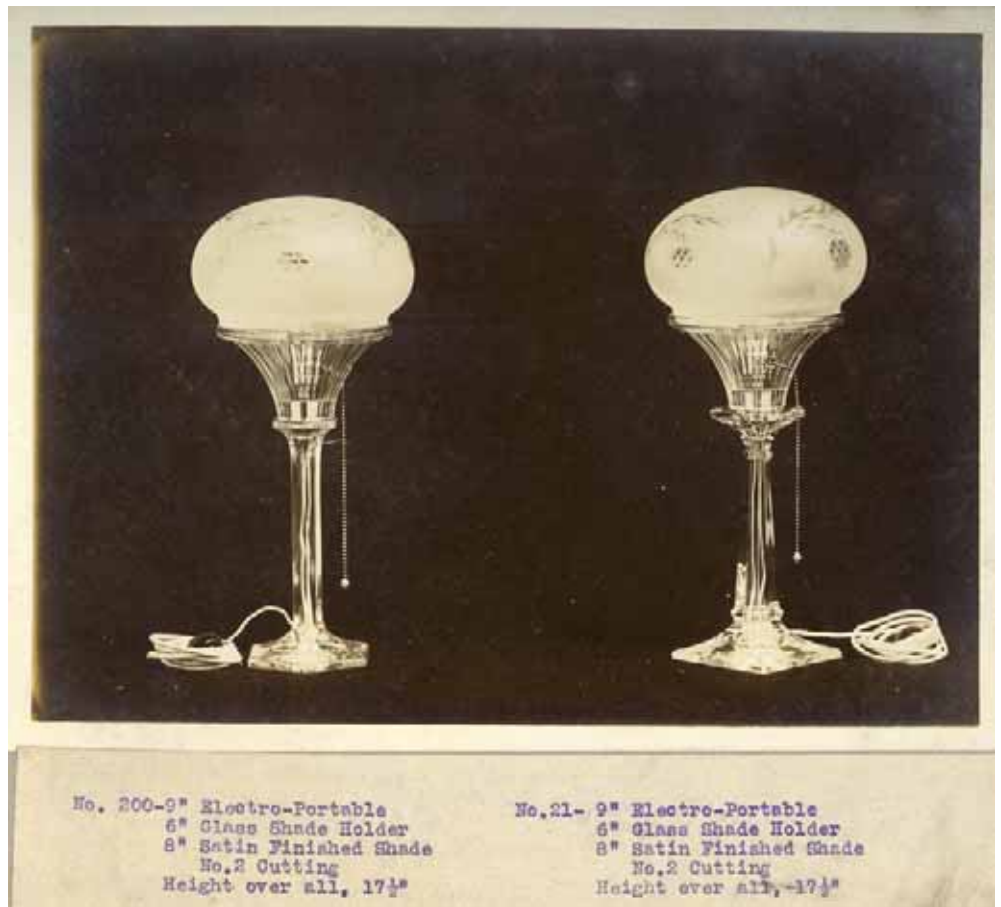
In June of 1913, A. H. Heisey & Company filed one design patent and four invention patents on a new innovation in lighting. The idea was to use a Heisey colonial style candlestick as the base of an electric lamp. The key patent was 1,222,676 which claimed the innovation of the "adaptation of a candlestick into an electric lamp by blowing a longitudinal passage through the center of the column and out to the side or rear in a manner that would not detract from the ornamental



appearance of the candlestick." The patent emphasized the economy of manufacture of this new electric candlestick, since forming the candlestick itself and blowing the passage through it could be done in "substantially simultaneous or quickly successive operation, while the candlestick is still within the mold." The other invention patents covered the actual method with which this was accomplished.

In 1914, one further patent was applied for that covered the glass shade holder which rested on the electro-portable base, "which could be held securely in place by the socket for the electric bulb and which would, in turn, serve as a support for a glass shade or globe. The shade holder would also "provide a simple means for suspending prisms from the glass member, which give a pleasing effect to the lamp."

The 9" 21 Aristocrat electro-portable lamp was the first one to be made in November of 1913. The 11" size followed in December of that year. The 9" 21 Aristocrat was in production for the longest period of time being made until 1929 and then revived in 1939 for a one year period. The 21 Aristocrat was the only lamp that was made in more than one size. In 1917 a 15" version of the lamp was also introduced but it had the shortest production period, only lasting until 1922. The 9" is also the only electro-portable that was offered in color. In





January of 1926 a half turn each was made in Moongleam and Flamingo. It is not known if more were made, but we do know that both of the color examples are very hard to find today.

In 1915, the electro-portables were expanded to include six additional bases all based on candlesticks that Heisey had in production at that time. Rather than, as with the 21 Aristocrat, use the same pattern number for the candlestick and the lamp, each of these lamps were assigned a different pattern number from the number of the corresponding candlestick. This was probably done to facilitate orders for these lamps and to avoid confusion. The new lamps were the 9" 200 Classic based on the 16 Classic candlestick, the 9" 201 Windsor based on the 22 Windsor candlestick, the 9" 202 Federal based on the 25 Federal candlestick, the 11" 207 Patrician based on the 5 Patrician candlestick, the 11" 208 Sanford based on the 29 Sanford candlestick, and the 11" 209 Regal based on the 47 Regal candlestick.

All of the electro-portable lamps could be purchased with a variety of fittings. There were two wire shade holders (No. 2 and No. 3) for silk shades. There was a choice between a metal spider and a glass spider to hold up the glass shades that surmounted the lamps. The 9" lamp bases took either the 5" or 6" glass or metal holder which would support either a 7 1/2" or 8" shade. The taller bases took either the 7" or 8" glass or metal holder



supporting a 9" or 10" shade. The smaller 7 1/2" and 8" shades were offered either plain or with 1 Lance cutting or 2 Floral cutting. The larger 9" and 10" shades were offered plain or with 3 Pinwheel cutting or 4 Feather and Star cutting. The 9" 21 Aristocrat and 9" 201 Windsor were also offered with the 4050 6" shade plain or with 861 Neopolitan cutting. This arrangement came with a bobèche and prisms rather than a spider.

Heisey's line of electro-portable lamps were a big success for the company and were readily accepted by the buying public. Although most models were eliminated in 1922, the 9" 21 Aristocrat was still in production in 1929. The 201 Windsor was revived in 1936, the 9" 21 Aristocrat in 1939, and the 11" 209 Regal in 1940.

## 1776 KALONYAL PATTERN

Production of the 1776 Kalonyal pattern started in about 1905. This is one of the few early patterns that A. H. Heisey & Company named. This pattern was shown as a new pattern in January 1906. However, an application for a design patent for this pattern was filed on September 24, 1904. It was granted on November 1, 1904, and given design patent no. 37,203. Was the name and pattern number used to commemorate the freedom for the 13 colonies? That is hard to determine. We know that 1906 was only the 130<sup>th</sup> year since July 4, 1776. That is not one of the big anniversaries that are usually noted. Anyway, the pattern had a very short life as it appeared in only one company price list, Price List #120 circa 1906. Production appears to have been from 1905 to 1907, a span of about three years.

The pattern design is a simple colonial design with its scallops, arches, and panels. Except within each panel is a raised jewel-like panel which is the identifying feature for this pattern. It was made in crystal only and you will find most pieces signed with the Diamond H. Occasionally a piece with gold or ruby decoration will turn up.

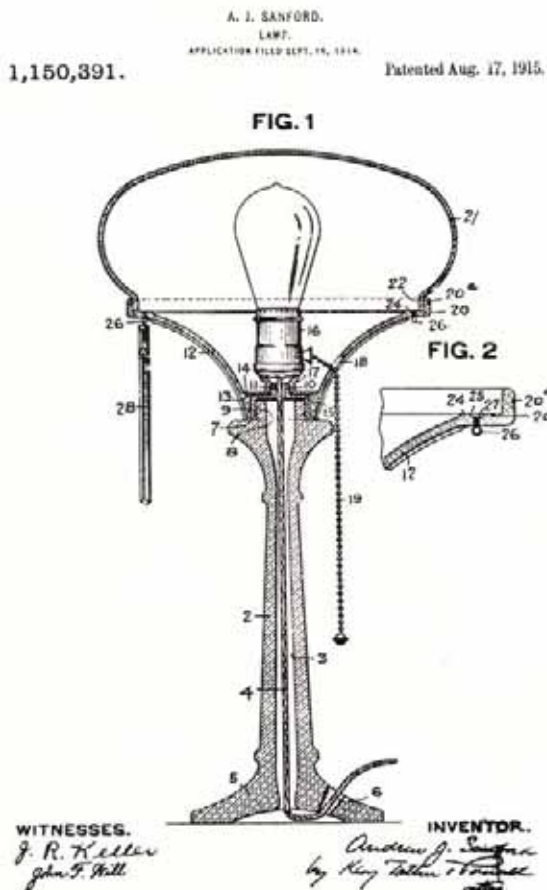


Illustration of Electro-Portable Lamp from Patent Application



Kalonyal was a very large pattern. There were 110 items offered in Heisey Price List #120. I have divided these items into two categories, tableware and stemware. There are 85 items in the tableware category and 25 items in the stemware category. Most of the stemware was offered in two styles, straight or flared. In the tableware category, there was a table set, 22 nappies, 6 plates, 6 jellies, 8 bowls, 6 punch bowls, 6 oils, and more. Not listed with the other pieces of 1776 Kalonyal in Price List #120 are a 9" candlestick and three candelabra. Instead, these are listed in the section with other candlesticks and candelabra.

There were not 110 separate molds to produce the items in this pattern. Instead, one mold might be used to produce several variations on the same piece. Thus, both a straight and flared goblet would come from the same mold. Also several variations of nappies might come from one mold.

## 2009 ALL HEISEY BENEFIT AUCTION

I hope you and yours had a very enjoyable holiday season and included among your New Year's resolutions a pledge to help your association in 2009 by sharing your resources, talents, and time. The very first thing you can do, if you haven't already, is check those curio cabinets and select and consign glass to HCA by January 15 for the 36<sup>th</sup> Annual All Heisey Benefit Auction which will be held at GMP Local #244 Union Hall in Newark, OH, on April 17-18, 2009.

As you know, the Benefit Auction is HCA's largest fund-raiser and 2009 will be another challenging year, financially, for the organization. As you read this article, you should have approximately two weeks to consign or donate your glass for the auction. We have included in this Newsletter a copy of the packing list and contract for your use. We would like you to fill out the list, as well as fill out two signed copies of the auction contract and place them both in the box of glass you bring in or ship to the Museum. FYI, the auction contract and packing list can be downloaded from the HCA website or copied from an earlier Newsletter.

As we have the last two years, we are going to only send out catalogs to those HCA members who placed absentee bids or were HCA members who purchased glass at one of our past auctions. The catalog will be on line on the HCA website on or about March 15 for anyone to use and download. In addition, for those who want a printed catalog, please contact the Museum and one will be sent to you. Sadly, many members do not participate in the auction, so we are trying to save money by reducing our printing and postage costs.

We will again let absentee bidders make their own arrangements to have their glass shipped. That worked very well the last two years. We will again provide a list of area vendors to pick up your glass, pack it, and send it to you. We simply do not have the volunteers, materials on hand, and staffing capability to do this task any longer. We will be giving instructions about this in future Newsletters, as well as in the catalog.

### **Consignments:**

All items consigned for sale or donated are to be made by A. H. Heisey and Company or by other manufacturers using Heisey moulds. The owner/ consignor / member, hereafter referred to as the owner, agrees to accept all responsibility for providing merchantable title for all glass sold.

Each owner may consign a maximum of forty (40) lots to the auction. A list of glass being consigned or donated and prepared by the owner is attached as an integral part of this contract. There is no limit on the number of items in each lot, but HCA retains the right to increase/decrease size/make up of each lot. Each owner may donate an unlimited number of lots to HCA for sale at the auction. HCA, however, at its discretion, will consign donated items for auction, add donated items to the Museum collection, and/or sell donated items in the Museum Shop.

The HCA Auction Committee is authorized to reject any glass not deemed acceptable to HCA standards for this auction. These items may be returned to the consignor, if they desire, at their expense. Otherwise, these items become the property of HCA.

### **Commission:**

Owners of glassware to this sale will be charged on the following sliding scale of commission per lot: \$5.00-\$50.00= 40%; \$50.01-\$200.00= 30%; \$200.01-\$400.00= 20%; \$400.01-\$750.00= 15%; \$750.01 and over= 10%.

### **Settlement:**

Settlement for glass sold will be made in full not later than fifteen days after the completed auction from the HCA Auction escrow account. Said account is set up and operated consistent with ORC Section 4707.024. Collection of funds, bad checks, debts, and unpaid auction lots is the responsibility of HCA.

### **Responsibility:**

It is the responsibility of the owner to deliver the glassware to the National Heisey Glass Museum on or by January 15, 2009. HCA accepts responsibility for the glass after it is received at the Museum and until it is sold, except that any glass damaged in shipment to the Museum will be referred to the shipper and owner. All glass damaged or lost while in the

possession of HCA prior to sale will be valued by a qualified appraiser or appraisers and the owner will be paid on this basis, less commission.

**Bidding:**

The minimum opening bid on a lot will be at least \$5. The minimum incremental bid increase will be \$2.50. In the event no bid is received on a lot, that lot becomes a donation to HCA.

The owner and HCA both agree that absentee bids will be accepted by HCA. Per HCA policy, the minimum absentee bid on a lot will be \$15 with a minimum opening bid of \$5. Absentee bids are bids left by buyers prior to the auction and are executed in a competitive manner. We do not use the full bid amount as a starting bid. Bidding is initiated in the audience and then offered on behalf of the absentee bidder at the next increment continuously until bidding has stopped. HCA reserves the right to accept or reject any and all absentee bids. Example: Absentee bidder leaves a bid with a maximum amount of \$500. After item is sold through competitive bidding, the absentee bidder is successful for \$325. HCA is not responsible for misfiled bids that are not executed.

**Absolute Auction:**

All items are to be sold at an **absolute auction** and not at a reserve auction **except** HCA and the owner agree there will be a minimum opening amount (see Bidding above) on all lots without exception. Owners cannot bid or have others bid on their behalf on their own items.

*“Absolute Auction “ and “Reserve Auction” as defined by ORC. 4707.01:*

“Absolute Auction” means an auction of real or personal property to which all of the following apply:

- 1) The property is sold to the highest bidder without reserve.
- 2) The auction does not require a minimum bid.
- 3) The auction does not require competing bids of any type by the seller or an agent of the seller.
- 4) The seller of property cannot withdraw the property from auction after the auction is opened and there is a public solicitation or calling of bids.

“Reserve Auction” means an auction in which the seller or an agent of the seller reserves the right to establish a minimum bid, the right to reject or accept any or all bids, or the right to withdraw the real or personal property at any time prior to the completion of the auction by the auctioneer.

**General Auction Terms and Conditions:**

- 1) Payment: Cash, travelers check, certified check, or personal check (if approved by HCA). MasterCard and Visa cards are accepted. 5% buyers premium. Buyers premium deleted for cash or check payment. Cash only payment may be specified for individual bidders at HCA’s request.
- 2) HCA has endeavored to describe all items to the best of their ability, however this is not a warranty.
- 3) All items are sold as is and where is. The auctioneer has the right to make any verbal corrections at the time of sale and to provide additional information. Inspection is welcomed during preview and anytime before the item is sold.
- 4) In the case of a disputed bid the auctioneers have the authority to settle disputes to the best of their ability and their decision(s) is/are final.
- 5) The auctioneer has the right to reject any bid raise not in line with established bid increments.
- 6) All sales are final and all items must be paid for each day of sale.
- 7) Live telephone bidding may be available at HCA’s option and under special terms (contact HCA).

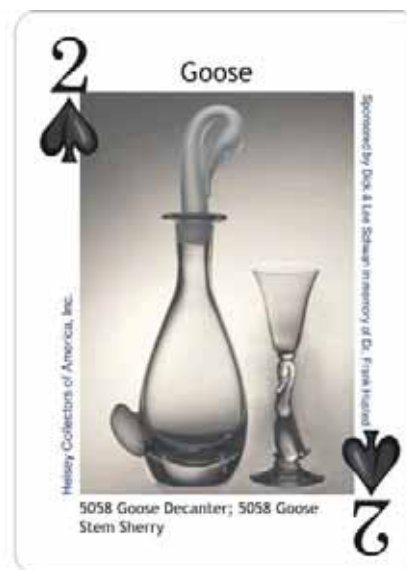
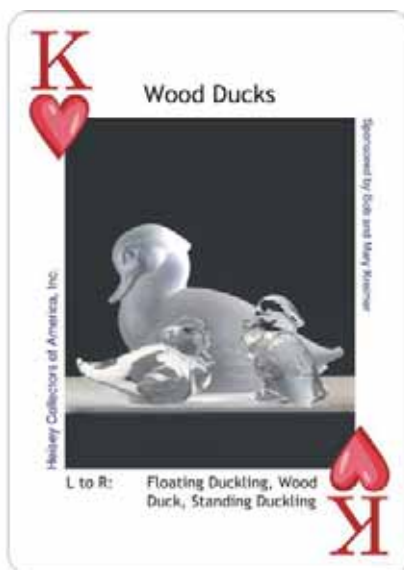
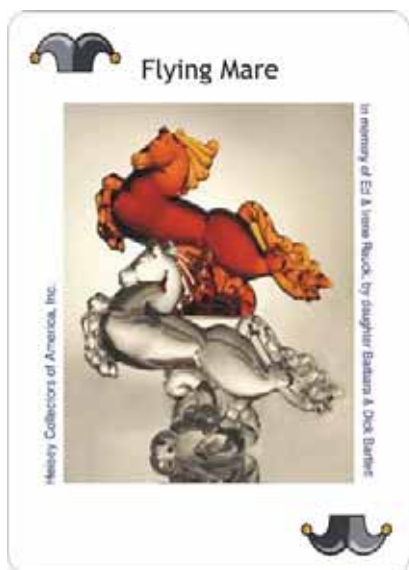

# HCA 2009 BUDGET

The Board of Directors approved the 2009 HCA Operating Budget in the amount of \$207,900 at their meeting on December 12, 2008. The approved budget is shown on page 17 of this Newsletter. The final numbers for 2008 will appear in a subsequent issue.

An endowment income amount of \$74,000 is being used to balance the budget. This amount is the estimated 2008 earned income less fees from the endowment fund provided us by our fund administrator, Park National Bank. We have drawn down all available amounts of yearly earned income, less fees for five consecutive years to cover our operating costs.

This is my first year as HCA Treasurer and this budget is "bare bones." I am anticipating a decrease in membership, as we have been experiencing over the past three years and a decrease in cash donations. We received a most welcome and generous donation from the Percy & Vivian Moore Weekend in Jackson, Michigan, however, in 2009 the weekend will be in Newark. Past experience has shown that these weekends when held in Newark are far less financially successful. I am hoping that the exciting new plans for the Convention will yield no decrease in that income. Though our 2008 auction proceeds were lower than budgeted, I am anticipating that our new auction policy will enable us to maintain income in that area as well.

Our employees are very cognizant of our situation and are keeping costs down as much as possible. We have included a 3% increase for all employees in the 2009 budget. The awarding of the increase will be determined by annual review. We have carefully monitored expenses and have experienced the same cost increases you experience in your household. Utility bill increases; increased health insurance premiums, and property insurance raises affect us, also. The Board has ordered an audit and the estimated cost of that has been included in the accounting line. We do not anticipate any special maintenance needs this year as we had last year with the HVAC for the Archives. As in 2008, additional costs, if

necessary, will be taken from the Capital account. We hope to cap the Grounds Maintenance costs by employing a competitive bid process to acquire those services. We anticipate the computer maintenance costs to drop once the web site has been updated, but we will be including a monthly fee to keep it updated.

The budget is prepared by taking the first 10 months of costs and estimating the expenses for the last two months to arrive at the estimated 2008 operating expenses; then looking at the trends and costs over the past three years and developing the 2009 estimated revenues and expenditures. It is planned that any excess funds not spent will be placed in a reserve account for expenditures for needed projects in the future. Our Museum isn't getting any younger and needs continued maintenance.

The budget reflects a large reliance (35.5% of total revenue) on earned income and reserves to fund the organization and Museum operations. These economic times are unpredictable and though Park National Bank has assured us that we will likely not experience a reduction in that income, we have no such assurances about other areas of our revenue stream. We must continue to come up with innovative ways to increase revenues and reduce costs without reducing member services. Your Board of Directors and Staff are trying to do their part. We have received some great ideas in this past year and committees are working on turning these ideas into actions.

On behalf of the Board of Directors, I want to thank you for your interest in the finances of YOUR association, HCA, and your past support. We hope you will continue to support your organization with your time, talents, and financial resources in 2009 to keep our Museum a first class showplace and educational resource for members and public alike.

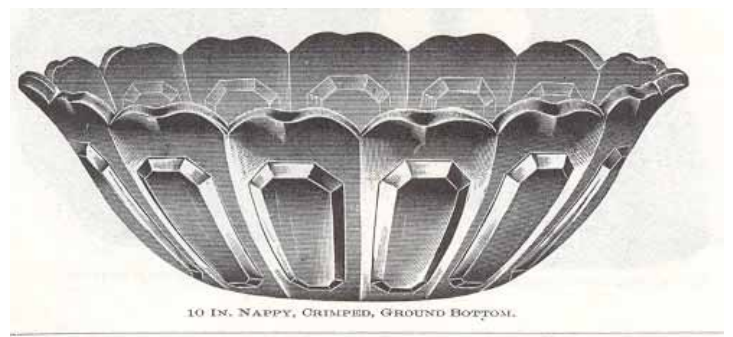
## A WAY TO HELP HCA HCA Endowment Committee

Looking for a good way to help HCA and save money on your taxes? One of the byproducts of the recent government "bailout" program has given you just such an opportunity. If you are age 70 1/2 or older and have IRA or 401(k) retirement accounts, the rules say you must start withdrawing required minimum distributions (RMDs). These distributions are added to your taxable income each year.

However, the bailout plan provided an extension, which could benefit you and HCA. Through 2009, the donation of your RMD to HCA will prevent the donation from being counted as taxable income to you. The donation will satisfy your required distribution under IRA and 401(k) rules. This is possible because HCA is an accredited 501 (C) 3 tax - exempt organization.

Tax laws are quirky, and Congress can always enact changes. If you are in a position to help HCA through this provision, check first with your tax advisor for details to make sure you qualify for this benefit. If conditions fit your circumstances, contact HCA's Endowment Fund administrators at Park National Bank for instructions. Call 888-545-4762 toll free or 740-349-3702 and ask for either John Uible or Brad Zellar.

This could be a win-win for HCA and you! ♦

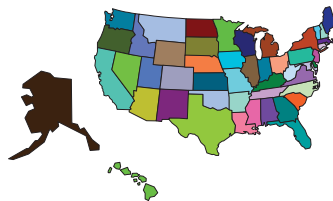

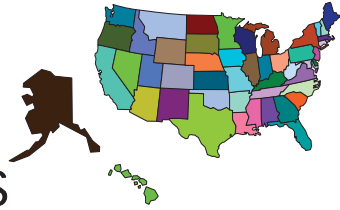

Town & Country 1637A in "Dawn", 9 oz. tumblers and 6" plates; also in Dawn we saw 1632 Lodestar cocktails (beautiful); 1255 Pineapple and Fan toothpick in Emerald; a pair of Moongleam 129 Tricorn candlesticks; and a pair of 1510 Square on Round 2-light candlesticks; a dainty covered lemon dish in 1509 Queen Ann; a 3 lb. 465 Recessed Panel candy jar with ornate butterfly cutting; two footed salvers, one in 1220 Punt Band and the other 300 Peerless; a 9" 1469 Ridgeleigh ball base; a 4" rose bowl in 1205 Fancy Loop; a one-half gallon tankard in 393 Narrow Flute with beautiful designs of silver deposit; a 201 Harvey colonial tumbler in Amber; even a 4232 crystal favor vase; a cut 3389 Duquesne cordial; 4052 National 8 oz. old fashion with 980 Moonglo cutting; and a 1401 Empress 10" round salad bowl with a beautiful cutting!

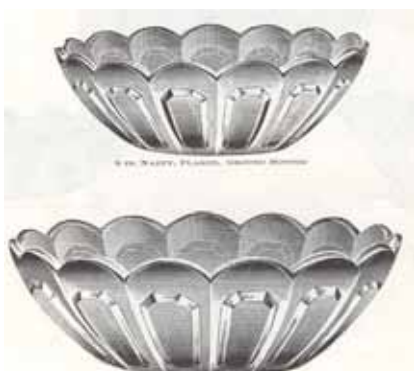
## OPEN HOUSE – 2008
