

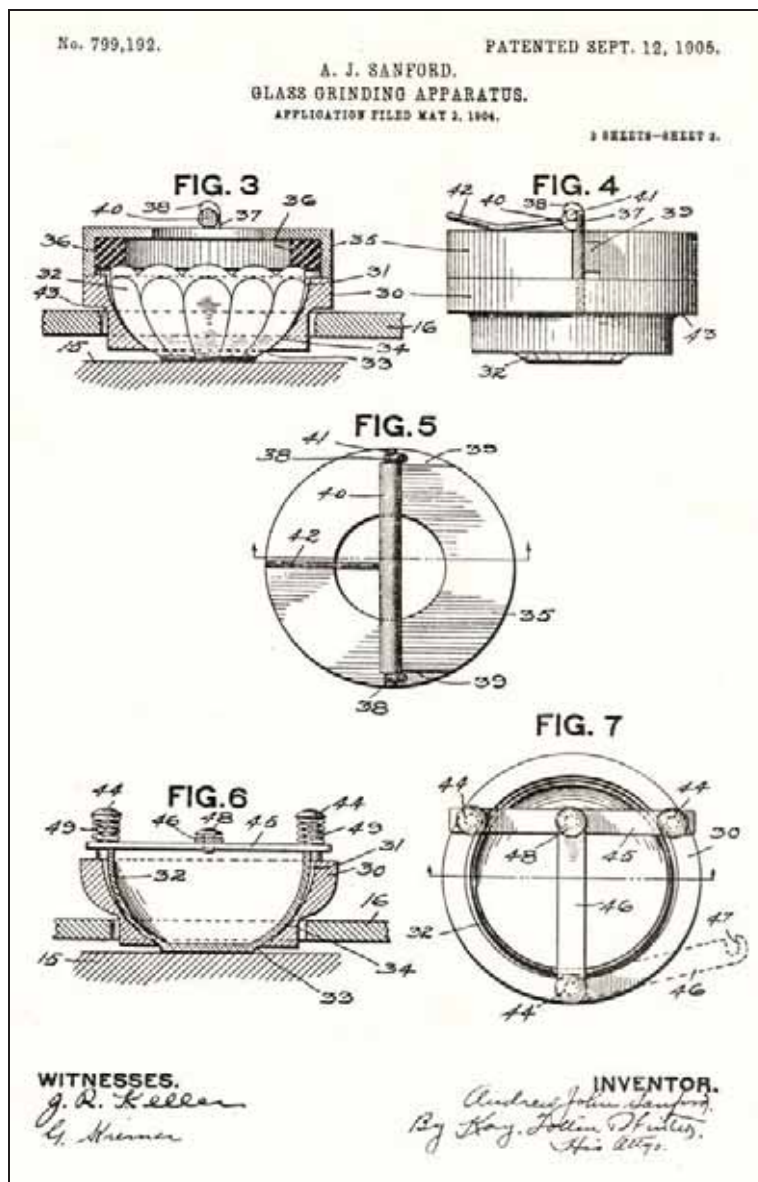

Convention Seminars

We will look at different themes in etchings and why the company thought they would be successful. Special attention will be given to custom work that the company did for individual clients. I hope that many of you will be able to attend these seminars and learn more about the story behind Heisey etchings.

Our dining room table display has changed with the season and now has a beautiful display of Heisey 1184 Yeoman pattern brought in by Phyllis McClain. Phyllis has a wonderful knack of adding just the right accessories to the table to make it a real show piece. Do stop in at the Museum to see this great spring themed table.

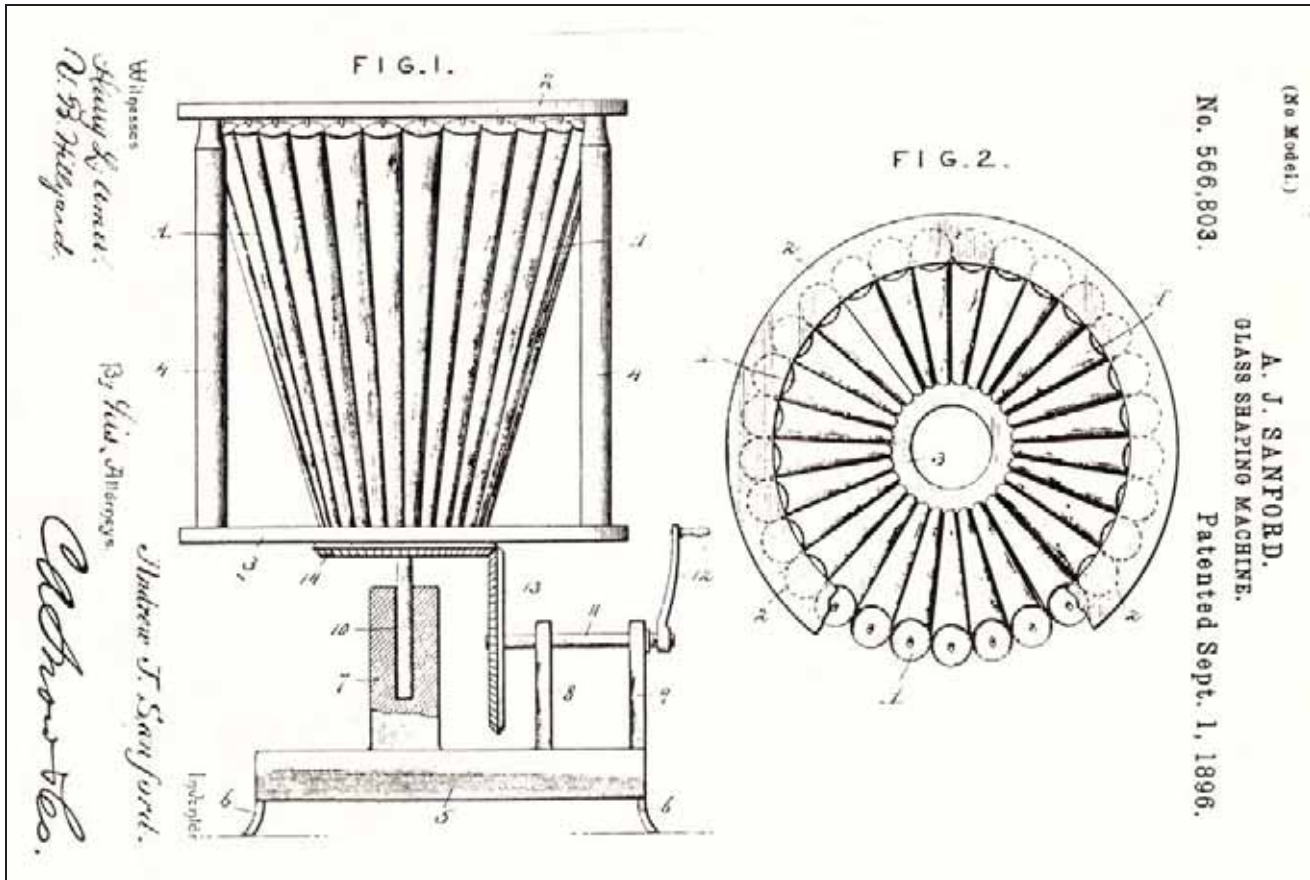

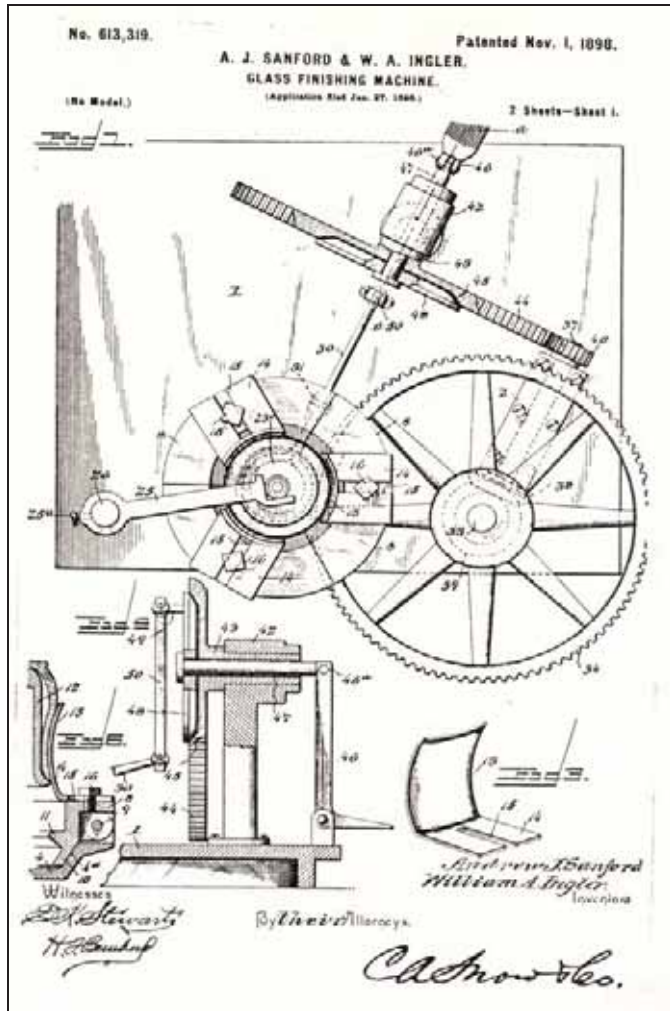
UTILITY PATENTS ASSOCIATED WITH A.H. HEISEY & COMPANY (PART 2) Walter Ludwig

Last month, we started our look at the utility patents that were assigned either to the Heisey Company or an individual associated with the company. In that article we only had space to look at those patents that had been granted to A. H. Heisey before he founded A. H. Heisey & Company in Newark, Ohio, in 1896. This month we will look at patents granted from 1896 until 1905. All of these patents deal with the process of finishing glass after it has been molded. Obviously, this was a labor intensive process that was in need of improving both to cut costs and to produce a better finished product.

The first one we will look at is Patent 566,803 which was granted to Andrew J. Sanford of Zanesville, Ohio, on September 1, 1896. I am in a bit of a dilemma as to whether this patent should be included or not. There is no disputing that Andrew J. Sanford was one of the key employees that A. H. Heisey hired early on to start the factory here in Newark. Sanford became head of the mold shop at the factory and was constantly on call to fix anything that might go wrong at the factory. It is entirely possible that Andrew J. Sanford was employed by Heisey to supervise the construction of the glass factory here at Newark. This patent was applied for on April 17, 1895, so it is also possible that it predates Sanford's employment by Heisey. But since it is for a "glass-shaping" machine I am including it in this article to show that Sanford was quite familiar with the workings of a glass factory.

The piece of equipment is actually used to finish a blown or molded piece of hot glass to give it

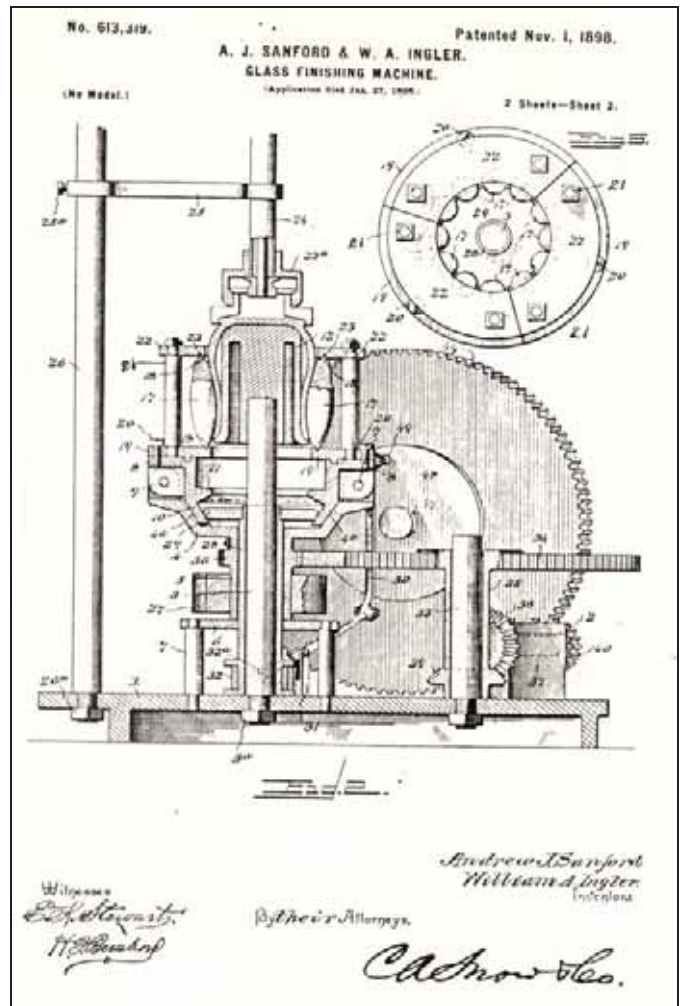
finishing properties to contour to the shape of the cylindrical shaped hopper. This process can add flutes to the piece, as well as, giving it its overall finished appearance.

Our next utility patent was granted on November 1, 1898, to A. J. Sanford of Newark, Ohio, and William A. Ingler of Zanesville, Ohio. This patent was applied for on January 27, 1898, and granted as Patent No. 613,319 on November 1, 1898. As you notice Andrew Sanford is now a resident of Newark and is definitely in the employ of A. H. Heisey & Company at this time. This patent covers a glass-finishing machine for which the description in the patent runs to five pages.

Once again we have a machine that will improve the way that a glass article is handled in the finishing process of making it into a useful



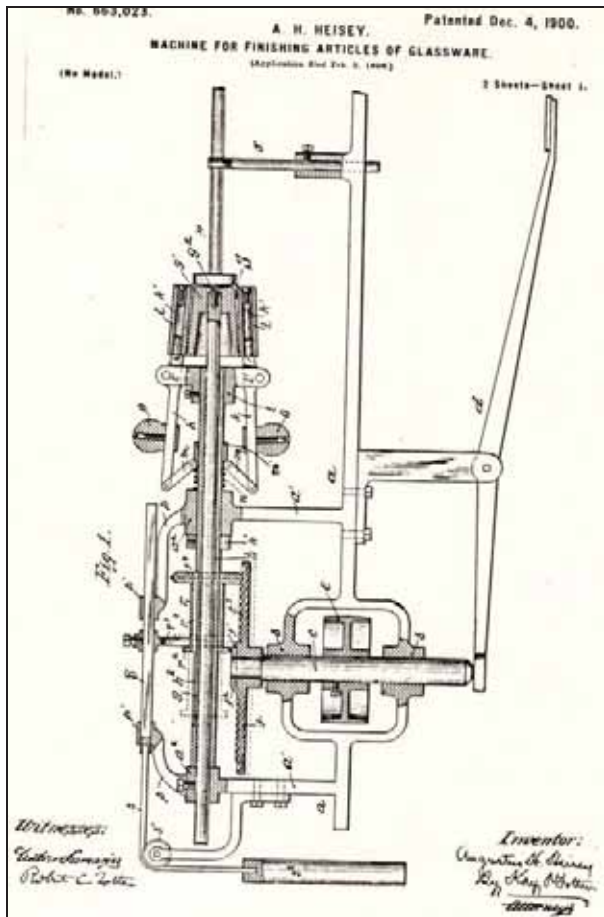

piece of glass. “Our invention is an improvement in machines for finishing glass articles by the abrasive action of a buffer on the surface of the article; and the object that we have in view is to provide a simple mechanism by which differently-shaped articles may be finished rapidly and economically.

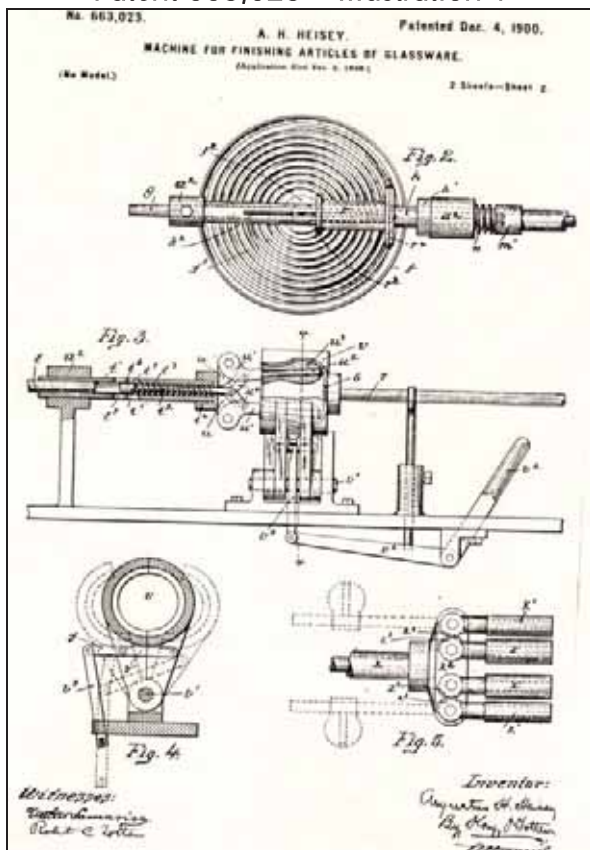
“A further object that we have in view is to provide an improved mechanism by which the buffer or the buffer-roll may be brought by gentle motion into contact with the work, thus obviating marring of the surface of the work, and at the same time we obtain a positive motion to the driving mechanism.”

The illustrations certainly make this look like a formidable machine.

The third invention in this series was granted Patent No. 663,023 on December 4, 1900 in the



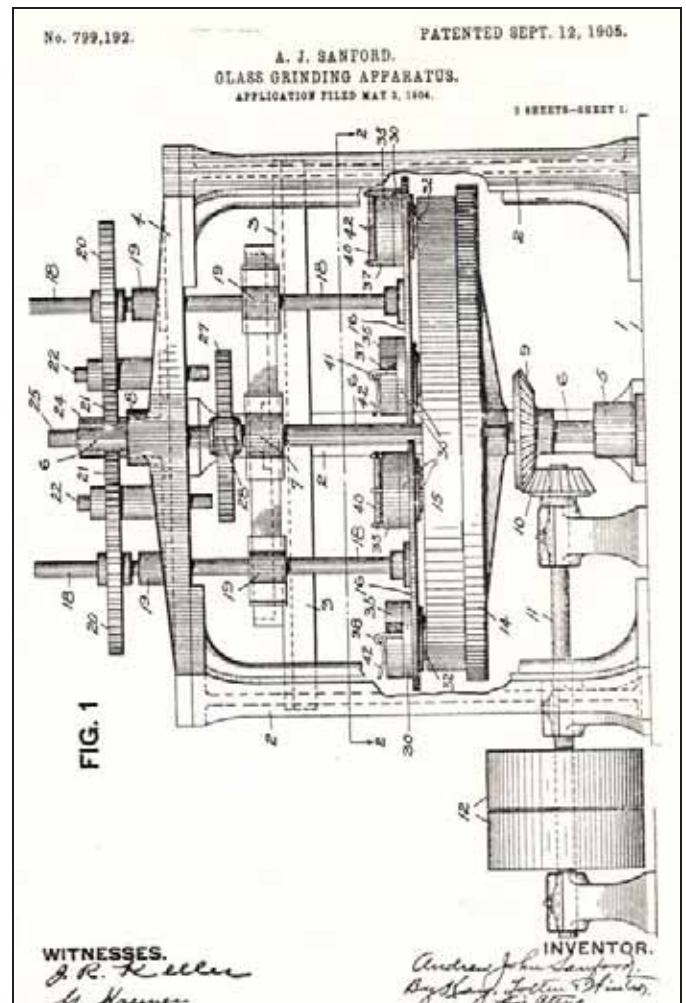
Patent 663,023 – Illustration 1

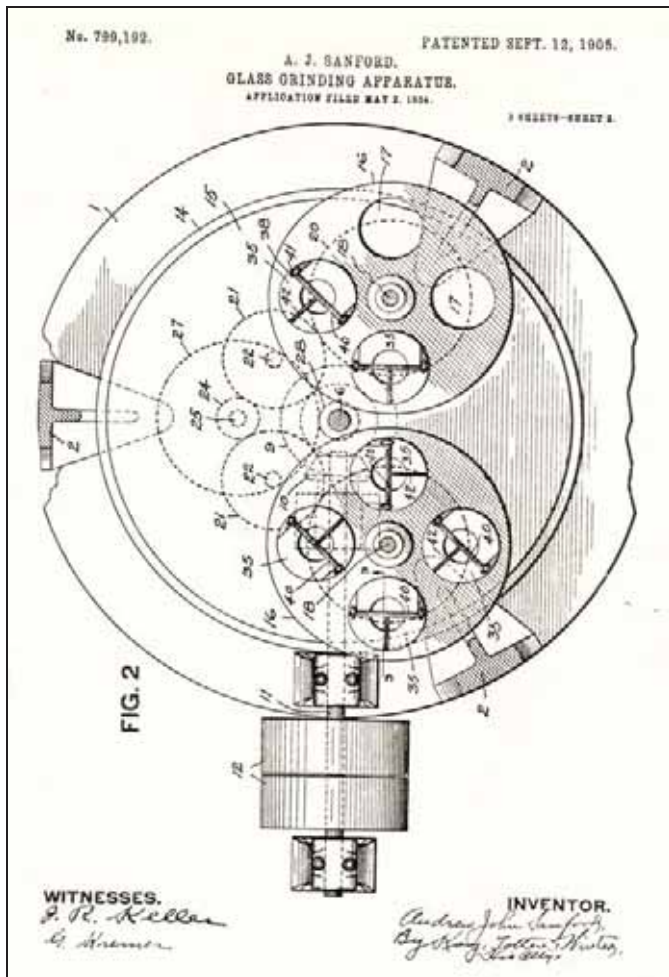
name of A. H. Heisey of Idlewood, Pennsylvania. (You will notice that A.H. Heisey's official residence was still in Pennsylvania at this time and not in Ohio.) The application for this patent was filed on February 4, 1898.

This was another glass finishing machine. "The object of my invention is to provide a machine in which the finishing-tools which revolve around the article are gradually brought into contact with the article, their pressure against the article being governed by centrifugal force."

The final two inventions in this series will be considered together. They are for "a glass grinding apparatus" and are covered in Patent numbers 799,192 and 799,193. Both patents were applied for on May 2, 1904 and granted on September 12, 1905. In both cases the inventor is listed as Andrew John Sanford of

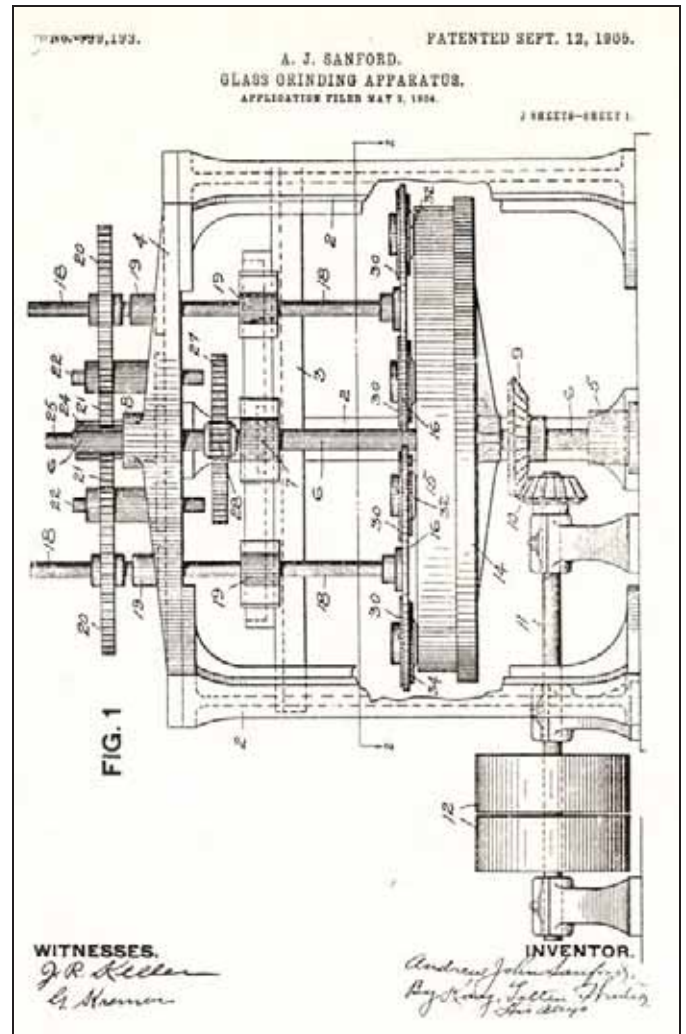
Newark, Ohio, with the assignor listed as A.H. Heisey & Company of Newark, Ohio. This means that Andrew John Sanford is acknowledged as inventor of the product, but that the actual owner of the patent is A. H. Heisey and Company.

Both of these patents are for a holder to be used in conjunction with ordinary glass-grinding machines in order to finish off an article of glass. The difference between the two patents is what the particular article to be finished was. In the case of 799,192 the article was nappies or bowls, while for 799,193 a more general term of "flat ware" was used.

The reading of 799,192 is "The object of my invention is to provide a holder for the article to be ground and which may be used with ordinary types of glass-grinding machines, such as tumbler-machines, and which is adapted

especially for holding nappies, bowls, and similar flaring glass articles."

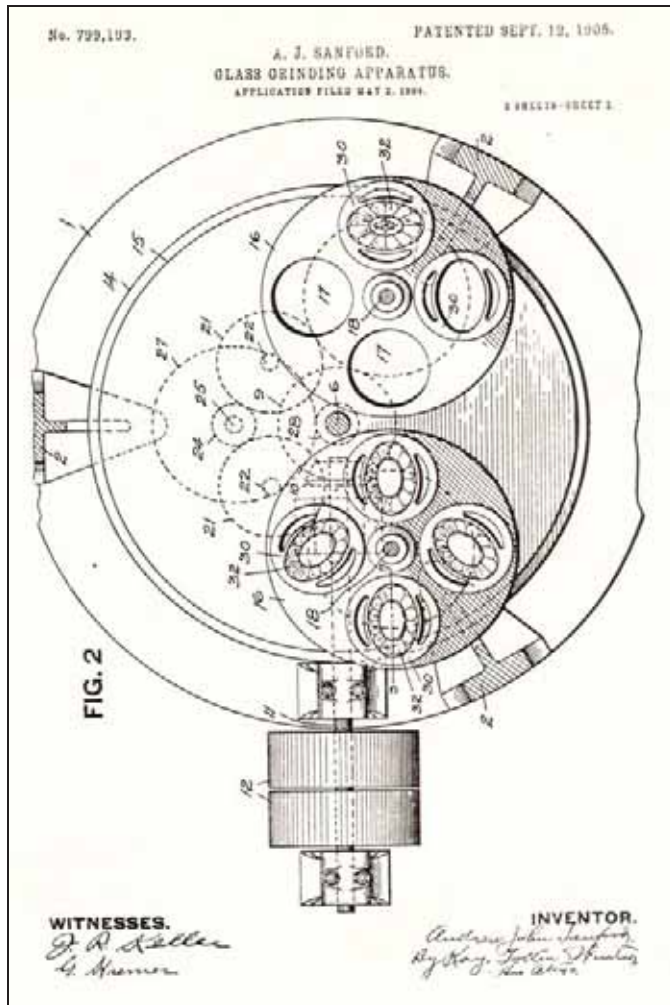
Patent 799,193 reads, "The object of my invention is to provide means whereby ordinary types of glass-grinding machines, such as tumbler machines, may be used for grinding the glassware commonly known as 'flat ware.'"

Both patents then continue with the same words, "In the manufacture of pressed glassware the pressing and reheating process leaves on the bottom of the article more or less pronounced fins, ribs, and other projections, which must be removed by grinding. In the case of tumblers and a few other practically cylindrical articles this grinding has been accomplished by means of machinery. The type of machine in most general use for this purpose comprises a horizontally-arranged stone rotated at a high

speed and a disk or disks located above the stone and slowly rotated in a direction opposite the rotation of the stone, which disk or disks are provided with openings therethrough, into which the tumblers or similar articles are set with their bottoms resting upon the rapidly-rotating stone. The disks hold the tumblers from being carried around by the stone and also carry them slowly in the opposite direction, the combined effect of the stone and disks imparting rotation to the tumblers.

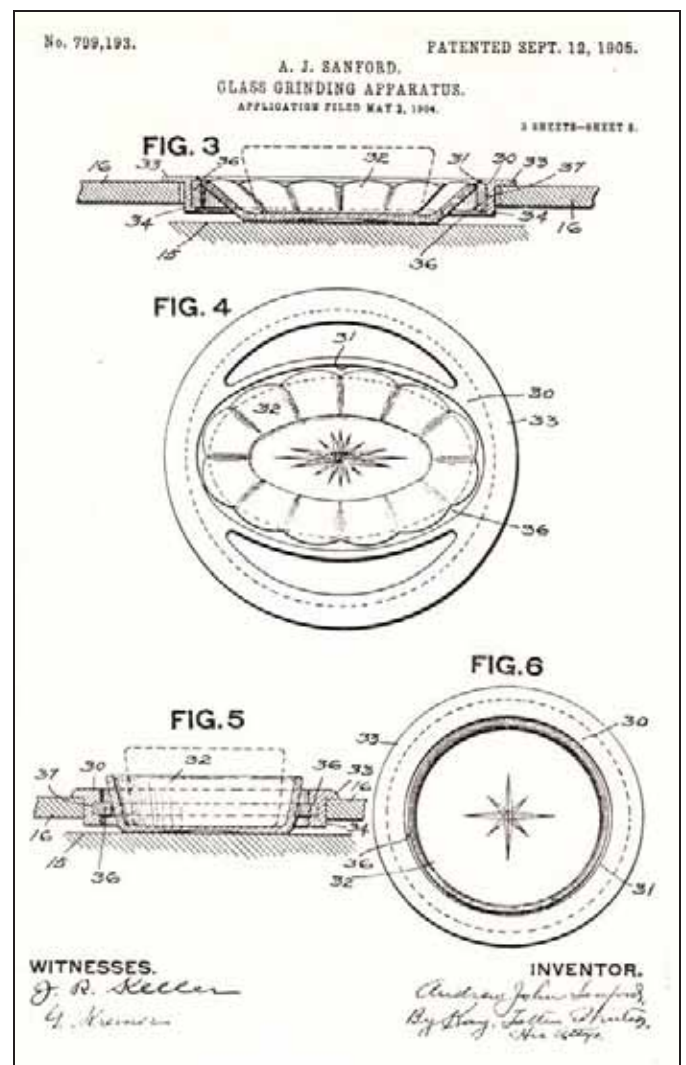

At this point the two patents diverge.

Patent 799,192 (for bowls and nappies) continues, "To produce the necessary friction between the tumblers and the stone to produce a grinding effect, the custom is to place a bag of shot or other suitable weight into the tumbler. While such machines have been in quite general use for grinding tumblers and a few other

practically cylindrical articles, they have been found unadapted for grinding nappies, bowls, and other glass articles having a flaring shape. This is due to the fact that the thin disks bear against the rounded or flaring surfaces of the nappies and cause such articles to be lifted from the stone and rolled or tumbles in the opening in the disk, thus quickly ruining such articles. As a consequence nappies, bowls, and the like have heretofore had their bottoms ground by holding them by hand against the side of a vertically-rotating stone. This work is quite tedious and slow, and the labor incident thereto adds considerably to the cost.

"The object of my invention is to provide a suitable holder for nappies, bowls, and similar articles in which such articles can be clamped and which can be placed in the opening in the

disk or disks of ordinary tumbler-grinding machines and which will hold the articles in true vertical position with their bottoms bearing against the stone and preferably being of sufficient weight to supply the necessary adhesion between the article and the stone."

Patten 799,193 (for flat ware) continues similarly, "While such machines have been in quite general use for grinding tumblers and a few other practically cylindrical articles, they have been found unadapted for grinding flat ware, such as plates and other low flat dished. This is due to the fact that the disks of such machines are comparatively thin, so that only a shallow bearing is presented, against which the edges of the article must rest. As the latter are low and flat, they are liable to slip underneath the disk between the same and the grinding-stone, and this results in either breaking the article or at least grinding it so irregularly that it has to be discarded. This liability is increased by the fact that the top surface of the stone is seldom, if ever, true, as it generally wears away irregularly, and as a consequence the article rises and falls slightly during the grinding process, and the thin disks have not a bearing surface of sufficient height to permit or any appreciable rise and fall of the article. For these reasons grinding-machines of the character described have never been adapted for grinding flat ware, and such ware has heretofore been ground only by holding it by hand against the sided of vertically-rotating stones. This work is quite tedious and slow, and the labor incident thereto adds considerably to the cost.

"The object of my invention is to provide an improved holder to cooperate with the disk of a grinding-machine of the character described and which is to be used in the grinding of flat articles to prevent the difficulties just referred to."

The drawings for the two different patents are of the same different parts of the machine and differ only slightly. The first illustration is of the machine as a whole. The second looks at the apparatus for holding the item to be ground in relation to the grinding surface. The third

illustration (and those that follow) shows the article being ground in the specially built holder for the object. I have used this third page of illustrations for patent 799,192 as the cover of this issue of the Newsletter. You can clearly see a colonial Heisey bowl as it is held in the holder. The third illustration for 799,193 shows a colonial oval celery dish in a similar holder.

Next month we will continue to look at the utility patents associated with A. H. Heisey & Company. One of them will be for an interesting piece of glass that Heisey added a metal piece to in order to create something very different. ♦

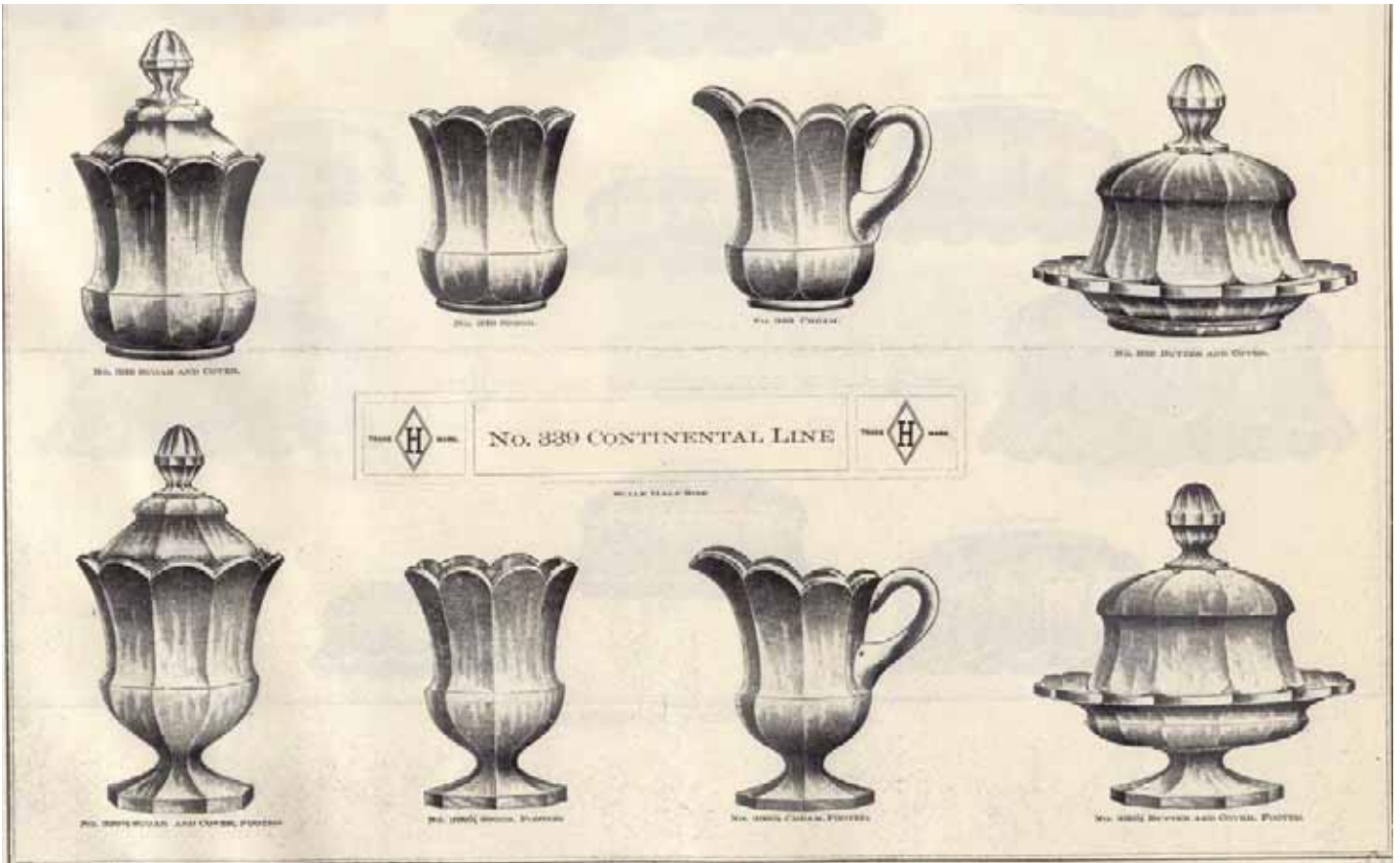
339 CONTINENTAL

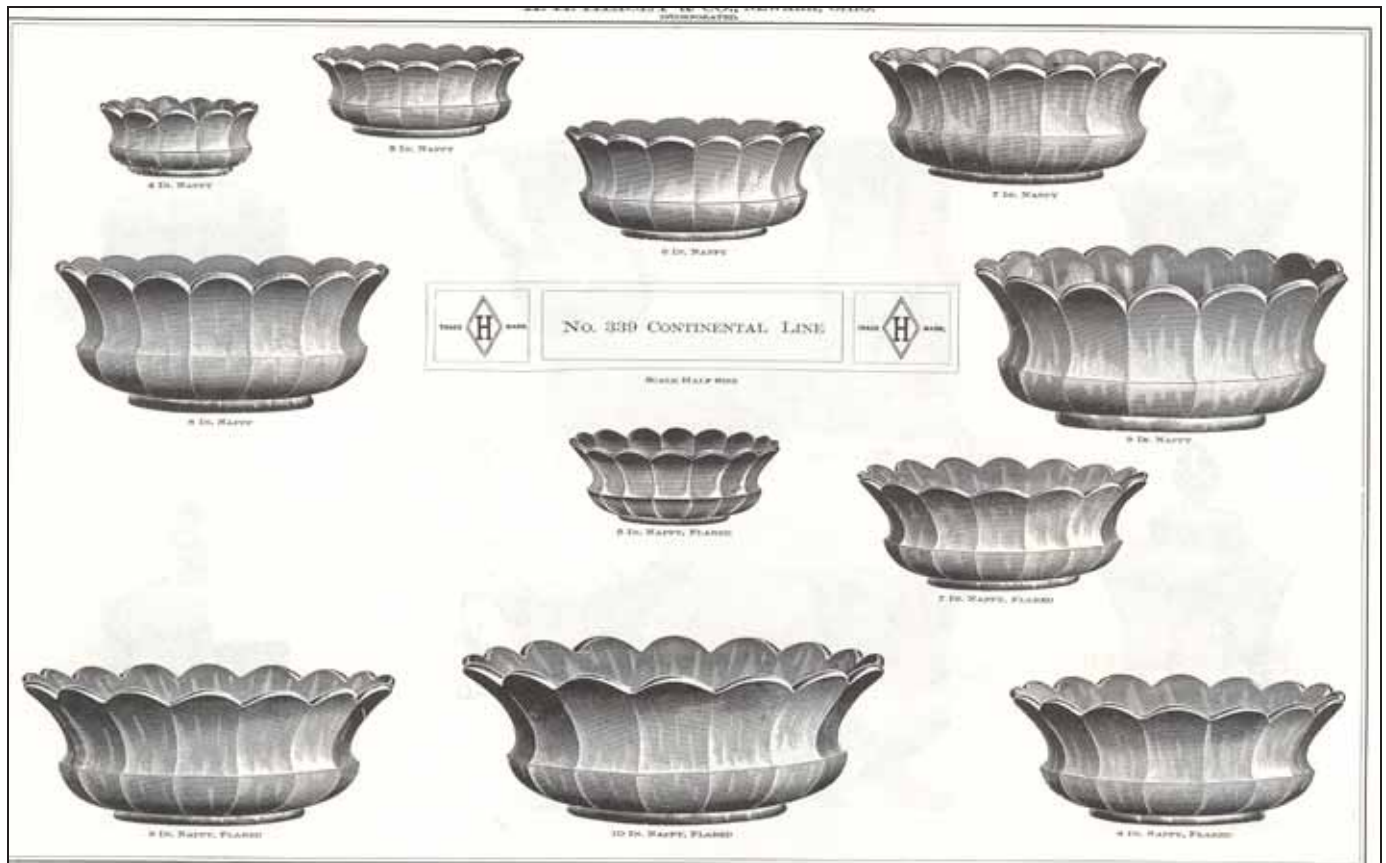
The 339 Continental pattern was introduced in late 1902. A total of 67 items were offered in Heisey Price List #100, circa 1903. Most items were still offered in Price List #142, circa 1908. There were only 10 items left in Price List #155, circa 1910. In Heisey Catalog #75, circa 1913, all 339 Continental items were gone except the tumblers, water bottle (with the pattern changed to 400 Colonial Scalloped Top), sherbet, egg cup and oyster cocktail. The water bottle continued to the 1940s, and the other four items ended in the late 1910s. The life of the pattern is set at 1902-1911 or about 10 years. Heisey named the pattern Continental.

The pattern was made in crystal only except for the water bottle which has been found in Flamingo. This places the water bottle in the late 1920s. Most 339 items were offered with a #64 gold decoration. The gold was placed around the top edge, and a gold band was placed around the body just above the swell. Some 339 items have been found with the #65 engraving. Outside firms may have added ruby decorations to items in 339.

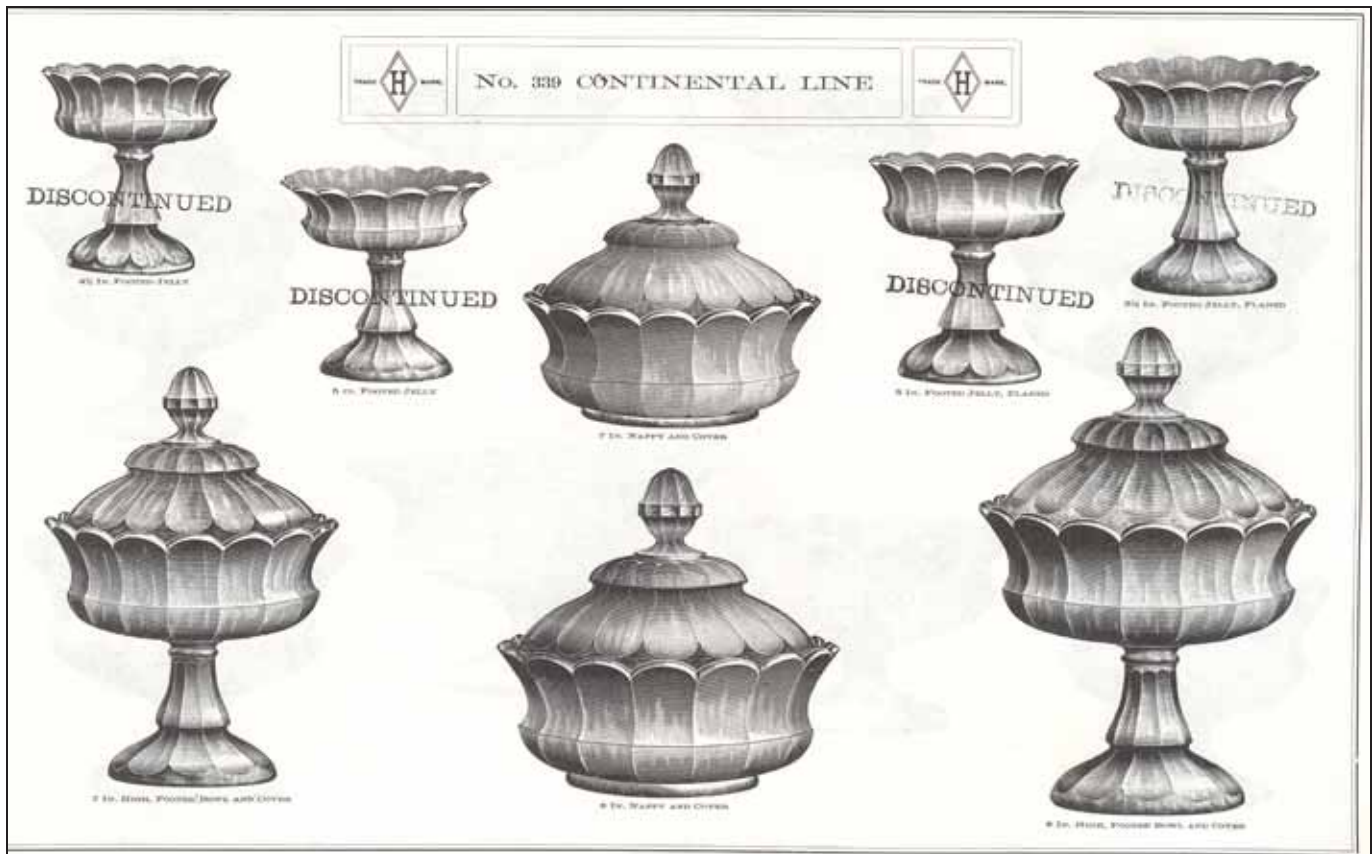
Continental is a colonial design with long, wide panels with scallops at the top where feasible. The vertical panels increase in diameter as you

go up from the bottom, and then make an abrupt turn inward gradually decreasing in diameter for a while. This is what is called the swell. On the butter lid the swell is reversed. All items are signed with the Diamond H except the mold blown items such as the water bottle or cruet. The Heisey star is in the bottom of applicable items.

There are two table sets in the pattern. One is normal, and one is footed. The footed set is given number 339 ½. The fifth and last item with the 339 ½ number is a 10 in celery tray. Within the 67 items, there are 32 different sizes of nappies and bowls, covered or uncovered; a goblet and wine, 2 sizes of tumblers, 2 styles of salt and pepper, 2 cake servers, 3 sizes of pitchers, an oil bottle (cruet), a toothpick and a punch cup. There is no punch bowl.

The catalog pages for the pattern note that a patent had been applied for on the pattern. However, we can find no record that a patent was ever granted for the 339 Continental pattern. This may mean that the patent office

did not find that the pattern was sufficiently different from other colonial patterns (either produced by Heisey or other companies) for the claim that it was a new innovation in pattern to be upheld.

We have received 936 lots of some wonderful glass for the benefit auction, and as Walter said, some exceptional pieces which one rarely sees for sale. Our curator, Walter Ludwig, has given you a glimpse in an article elsewhere in this Newsletter.

The auction catalog, preview hours, auction hours, absentee bid instructions, absentee bid form, bidding information, and most importantly the list of sale items are on our website - www.HeiseyMuseum.org . You have time to look and evaluate items and prepare for this great auction! Also listed are names and addresses of area hotels/motels to assist you in making reservations. You will want to arrive in time to attend the two-hour preview on Friday April 17, 2009, 2:00 p.m. to 4:00 p.m. with the auction beginning at 4:00 p.m. On Saturday April 18, 2009, the doors will open at 8:30 a.m., the annual membership meeting will be held at 9:00 a.m. with the auction beginning at 9:30 a.m.

As we have done for the last two years, we have decided not to have a full mailing of the auction catalog this year. The time has past for you to call the Museum and have a copy mailed to you. We will have copies available at the auction for a minimal fee of \$3.

As you know, the Benefit Auction is HCA's largest fund-raiser and 2009 will be another challenging year financially for the organization. This auction is slightly larger than last year's auction and we have an abundance of nice damage free glass this year. If you can't make it to Newark for the auction this year, I encourage you to put in an absentee bid. Again, forms and instructions are available on our website. This is a way for every member to support your association!!

2009 BENEFIT AUCTION PREVIEW

WOW! Have you taken a look at the Auction Catalog? It was mailed to everyone who asked for it, but it is also available on-line at the Museum web site (www.HeiseyMuseum.org). Do take a look at it because there is glass there for every collector. There are the show stoppers that make any collection unique, there are the more common pieces that can fill out a set or get a collection started. My space in this article is limited, but I will try to point out some of the more unusual pieces that are available for you to bid on at the auction that will be held April 17-18 here in Newark.

The auction starts off with a big one, a beautiful 1235 Beaded Panel and Sunburst punch bowl and base (1). This is quickly followed with a 1550 Fish bowl (4) and a bit later with a 14 Kingfisher floral block in Hawthorne (19). All

this and we have not even gone through 20 lots in the auction.

This is the auction if you like animals and animal related items because there are so many that you seldom see. There is a 1 Airedale (262) as well as a 1 Filly Head Forward (255). There are in Honey Amber a 1522 Standing Colt (416) and a 1540 Plug Horse - Oscar (417). Other animals include wood ducklings both 21 floating and 22 standing in lot 265 and a Flamingo 14 Kingfisher flower block (144). There is the smaller of the two 5058 Penguin decanters (235) as well as a large group of rarely found figural stems: 5058 Goose Stem sherry (429), 5058 Goose Stem cocktail (245), 5066 Horsehead cocktail (241), 5065 Colt Stem cocktail (242), and 5063 Bantam Rooster cocktail (243). A real beauty is the 4045 9" ball vase with 825 Sea Glade cutting (123) – the fish swimming around the bowl make this a gorgeous presentation of this rarely seen Heisey decoration.

The other category that the auction has a great number of lots in is 515 Heisey Rose. There is complete serving for four in all of the stems and plates as well as a large number of accessory and serving pieces. Unusual pieces include the 4164 Gallagher jug (55), a 1519 Waverly covered lemon with original store sticker (919), and two 5012 Urn bud vases in different sizes, 8" (909) and 6" (910).

This is a good auction for toothpick collectors with many unusual ones coming on the block. There is a 1776 Kalonyal (316), a 341 Puritan footed (308), a 325 Pillows (424), and a 1200 Cut Block with Ruby staining and "Pan American Expo" souvenir (312) among the more than twenty being offered.

Did you want to hear about some of the true rarities in this auction? Well, there is nothing rarer than the two 300 Old Williamsburg 18" candle lamps (142 & 143) that showed up this year. What makes them so special? I am glad you asked, they have 507 Orchid etching on them – and it is not just the globes that have the

etch, but the bases on these are also etched. We have no record of Orchid ever appearing on any hurricane globe and there is no record of an etching ever appearing on the base of a hurricane either. Together these make a truly unique presentation of Heisey's most popular etching. Do check the catalog because there are some condition issues with these rare pieces – but I doubt if you will ever have another chance to add a piece like this to your collection.

Other rarities include a pair of 4182 Thin 6" plates with 507 Orchid etch (286), a pair of 141 Edna candlesticks (406), a 352 Flat Panel knife rest (485), a 1503 Crystolite pressed goblet (620), a 150 Banded Flute root beer mug (978), and the 1 Tea Drip with sterling rim (981).

Rarities in color include a 134 trident 2 light candlestick with Sahara top and Alexandrite base (403), a 1404 Old Sandwich 16 ounce cream in Cobalt (405), and a 3386 Diamond Rose pilsner in Sahara (499). In Vaseline there is a 1192 Inside Scallop shallow 8" nappy (404) as well as a 1184 Yeoman 9" plate (735). Lot 627 is a rare 337 Touraine sherbet in Amberina.

Among the early patterns there are several lots of 1280 Winged Scroll in Custard including a table set (28), tankard and three tumblers (25), and a 13" tray (422). In the same pattern in Emerald there is a 4" pin tray (421). Another outstanding early piece is a 1200 Cut Block tall celery (407).

There are two lots in the auction with Krall bird cuttings. Lot 503 is a 4163 Whaley beer mug and lot 525 is a 4054 Coronation cocktail shaker. I should also mention that there are a group of 10 lots (676 – 685) of 1401 Empress Moongleam that could be the start of a really nice collection.

Space prevents me from listing all of the great items in this auction. I will add that there are three lots of tools that came from the Heisey factory (350, 950A, and 950B). Please do come (or send in an absentee bid) because this is one you do not want to miss. ♦

Financial Management Update

There has not been a Treasurer's report since November because we are in a transition period with our financial management and reporting. We have not had a Business Manager since early December and your Executive Committee has been working with our remaining staff and our accountants to make sure the tasks that are necessary to the every-day running of our organization get done.

We have updated access to all of our accounts; located and properly stored important documents, keys, and cards; and are in the process of streamlining our financial reporting systems.

I want to thank Vice President, Charlie Wade for all he has done to make sure bills get paid and various other things get taken care of. I want to thank Walter Ludwig for picking up additional duties and making sure deposits and payroll get done in a timely manner. I also want to thank the other members of the Endowment Committee (Linda Bishoff, Robert Loch, Dick Smith) and Budget Committee (Tom Files) for their patience and input during this difficult time. Their analysis and advice have been appreciated.

Wells & Priest, our accountants, have recently provided a draft financial report, which was reviewed and approved at our last Executive Committee meeting. As soon as a few corrections are made to that, we will be back to regular financial reporting and I'm hoping to have the first quarter 2009 report for you soon. We are still working on the 2008 year-end report, I ask just a bit more patience and will be happy to try to answer any specific questions.

I never expected to be quite as involved in the hands-on financial management of HCA as I've been these past few months and it's been quite an eye-opener. Fortunately our 2008 Endowment income is \$78,000 and I have

authorized the first drawdown of those funds to operating accounts. It is vital that all of our fund-raisers be as effective as possible this year.

There is some beautiful glass in the Benefit Auction and I hope everyone will come and buy! The Convention Chairs (Mary Ann Spahr and Judy Rhoads) have great plans for us in June and I hope everyone will attend and make that a success as well. ♦

2008 END OF YEAR ENDOWMENT REPORT

With the 4th Quarter 2008 Endowment report from Park National Bank, I received the following notes from our fund manger, John Uible

"The time-weighted total return was -16.77% for 2008 as compared with the benchmark return of -18.61

"For the calendar year, the Dow Jones Industrial Average (DJIA) produced a return of -32% for its worst performance since 1931. The Standard & Poor's Index (S&P 500) posted a return of negative 36.5%, its worst performance since 1937, while the NASDAQ Composite Index came in at negative 40.5%, the worst performance in its 38-year history."

Though we have lost principal in our endowment, we have lost less than many investors, thanks to Park's prudent management. Our own decision to increase percentage from growth to income has helped us retain our principal. And, keep in mind, that ours is a long-term investment.

The good news for us is \$78,000 in 2008 income is available for 2009 operating support. The anticipated 2009 and 2010 income picture is not so rosy, so it is vital that we all continue our support of the Museum and make our fund-raising activities as effective as possible. ♦
