## This way, please...The King House



As we continue our tour, we enter the King House. In 1831, Samuel King, one of Newark's first Criminal Law Attorneys decided to build a magnificent Greek Revival style home. This home was moved from 2nd Street in Newark to its permanent home in Sixth Street Park where it became The National Heisey Glass Museum. Let's take a look at Rooms One and Two of the King House.

In room One, you will find the desk of A.H. Heisey. This desk was built in Pennsylvania, and brought to Newark by A. H. Heisey when he came here to open The Heisey Glass Company in 1896.

On the left side of the desk you will find a cabinet full of #1201 Fandango, and to the right, a cabinet of #305 Puntty and Diamond Point. You will also find a display of Cordials on the right. On the opposite wall you will find a large assortment of Tumblers and Bar ware.

## Message from the President

The reports are in and the HCA Percy Moore Omaha Weekend 2012 was a great time for those in attendance. Hosting an event of this type takes great volunteer coordination and planning efforts and certainly the dedicated members of the Great Plains Club proved once again their commitment to HCA by hosting this weekend in Omaha. Over \$10,000 was raised for HCA and on behalf of the members of HCA and Officers, Directors and staff we all want to thank the dedicated members of the Great Plains Club for their efforts and Rex and Pat Lucke's for opening their home and hosting the brunch. Later in this newsletter we have more information on this event.

The Board of Directors quarterly meeting was held at the Oak Hills Country Club, in Omaha. Regretfully as I shared previously due to professional commitments I was unable to attend. Your Board confirmed the selection of a new location for the 2013 Heisey Convention Antique Show and Sale in Newark at the Lou and Gib Reese Ice Arena (located across from the OSU Newark Campus). Look for more 2013 convention details from Convention Chairman Gordon Cochran in the future. This change in location was necessitated by the conversion of OSU and COTC to mandated semester school schedules. The show committee lead by Charlene Bowman looked at several location options and made the recommendation to the Board, they all felt this was this best location for 2013. Several inquires were made about this being a new convention home and with the challenges in sourcing the necessary space and calendar dates the only answer is possibly. We may return to the OSU / COTC Newark Campus or seek another location in 2014 depending upon what options we have and how this facility works out for us this year. Also the Board approved the production of new convention souvenir for 2013 and we'll have more information on this as plans move forward.

Several projects remain on-going at the Museum Campus, the Curators Lab is being cleaned and freshened up, the second floor King House Conference Room is coming along and the plans for the new guest engagement area are progressing. We also are looking into relocating the Louise Ream Library to the first floor in one of the buildings (office or King House); many have suggested it's difficult to get into today and we agree. The challenge will be funding any major renovation effort.

HCA mourns the loss of two of our members: Richard L. Young, of Ohio died on July 22, 2012 and is survived by his wife Marsha. Bill Losch of California died on June 5, 2012. Bill and his wife Betty were very active in the Heisey Club of California (HCC) joining it in the 1970s and were active members of the club for many years. We extend our condolences to both the Young and Losch family.

Remember, HCA started with a small group of volunteers working together and they built this dedicated organization; today we are stewards of the work of the past. We are all working diligently to address, refine and improve the organization. If you have any suggestions or some professional experience that would benefit HCA or perhaps your study club is looking for a project? Contact any member of the Executive Committee or Board of Directors and we'll do our best to engage you in the "World of Heisey".

# Administrative Notes

Here in early September and feeling the effects of autumn, it is a welcome change from what has been a very hot summer. We are now past the Percy and Vivian Moore Outing and moving toward the Fall Select Auction. The year is moving on, and I am enjoying and learning as each new event comes.

With Charlie Ward and Dick Smith's help, I'll be in charge of the absentee bids at the Select Auction. It is another learning experience, and I'll do my best to fairly treat both sellers and bidders. The glass to be auctioned is on display in the multi-purpose room; it is beautiful. I hope to see many of you here on October 13th.

The Christmas Ornament program is moving along well. At the time of this writing we have sold 245 ornaments. We are looking at a probable top number of 300, so if you plan to purchase one, you'd better hurry. We have received the first 100 bulbs and are sending them out now. I'm planning to give them as Christmas presents to my kids and grown grandkids as I enjoy giving a unique gift.

If you tried to call the museum on September 8, 9, 10 or 11 you probably didn't get an answer. Unbeknownst to us, the main telephone line was down and we were not receiving calls. We discovered it when a caller sent us an email wanting to know if we were open. We quickly discovered the problem, called the telephone company who repaired it quickly. The repair man did warn us that the trunks coming in are old and we may face replacing the system soon.

The review of the computer systems is progressing albeit slowly. We are contacting both hardware and software vendors and are concluding an inventory of the current system. I visited The Works in Newark, and reviewed their software system. The Works system is one we will explore.

In the past couple months we have been using the email system to communicate with you. It is called the H Gram or Heisey E-Gram, and seems to be working well. We have gotten very few system rejections and a number of answers and comments. One thing I did notice was that although I use a large font in the message, the delivered message comes through to you much smaller. We will work on it to resolve the issue. If anyone has not been receiving these messages, please let us know.

Charlie Ward and I visited Mosser Glass about a week ago. I had the pleasure of meeting Tim and Sally Mosser and the watch ongoing glassmaking. I found this fascinating, and only wish that I could have been there to see the A. H. Heisey Company in operation.

I recently completed a study of the sales reporting and cash handling procedures at the Heisey Museum and a report was presented to the Board at their last meeting. The Internal Control was adequate, given we have a very small staff handling multiple duties. By utilizing an outside Accounting Firm to handle ultimate disbursements, all bank reconciliations and financial reporting we have disbursed responsibilities to assure your monies and records are safe.

I recently met with Leigh Ann Miller of the Granville Fellowship (a senior organization in Granville) to develop interactions between our organizations. We will probably be hosting one of the luncheons which has 10 – 20 people and one or more of the Bridge Parties 20 + people. They will also put an article in their monthly newsletter about us. This added exposure in the local area should bring some additional members and volunteers.

As I reported last month, we have been somewhat active in tours. In October, we have booked tours with Valencia/Manchester Tour which is a group of WWII Veterans, and the Fidelity Group of about 35 people. Sharon Gray has been contacted by a member of the Denison University Alumni who is planning next year's female graduation outing. She believes a visit to Heisey Museum would be a wonderful experience for the graduation seniors. Stay tuned, we'll let you know more as we learn more.

# From the Archives

Last month *From the Archives* featured a biography of Rod Irwin, the A. H. Heisey & Co. sales manager. The article was compiled from an interview Louise Ream conducted with Ruth Irwin, Rod's widow, and published in the December 1975 issue of the *Heisey News*. Mrs. Irwin stated that Rod started work as a salesman for the Heisey company in 1914, but when World War I began, he went with Company A of the 117<sup>th</sup> Ammunition Train, a unit of the 42<sup>nd</sup> Division when they mobilized to go to France on August 5, 1917.

Recently, we came across a letter written by Rod to A. H. Heisey on February 10, 1918, from "*Somewhere in France*" while he was serving with the army. The letter was in response to a letter written to Rod by Mr. Heisey prompting Rod to state "*Your most welcome letter received several days ago. The A. H. H. & Co. stationery and signature was certainly a treat for sore eyes.*"

In the letter, it was interesting to read how Rod, after only three years with the Heisey company, was ever the company man who would attempt, while in Europe, to assist Mr. Heisey with his problems back at the factory in Ohio. He addresses a concern A. H. Heisey related to him:

*I regret to hear the factory is having so many losses on account of your need for plastic clay. Mr. Heisey, France is one grand clay pot and as for its plastic and adhering ability, it simply pulls your knee caps off. I read of the rain and mud before coming over here, but those fellows that wrote about clay and mud were never in or around our camp. Now I'll keep in mind what you told me about the German plastic clay. About July 1<sup>st</sup>, I will be in Germany wiring you [to learn] how much you will need. Ships are very scarce!*

In closing he writes:

*I hope this finds everyone at the factory in the best of health. Extend my best wishes to Clarence, Wilson. . . and their families, also [that] you will find a remedy for the broken pots. . .*

Plastic clay was something with which I was not familiar. Google to the rescue! Quoting from the website of the International Mineral Association headquartered in Brussels, Belgium:

Plastic clay is an extremely rare mineral, found in localized deposits at a handful of locations around the world. It's a sedimentary material, made from kaolinite, or decomposed granite that has been mixed through river action with other clays, sands, gravel and vegetation.

The plasticity of this mineral ensures that the main use of plastic clay is as a base material in the manufacture of ceramics. Plastic clays have a wide range of colors, but when fired, selected clays give results that are pure white.

As head not only of the A. H. Heisey & Co. glass manufacturing company, Mr. Heisey was, from 1894 (approximately) to his death in 1922, the president of the Pittsburgh Clay Pot Company, which at the time was the largest of its kind in the country. It manufactured clay pots used in melting glass, crucible steel, and other metals. These two enterprises could explain his keen interest in finding the best clay. From an account in the *Clay Record*, July 15, 1901, the Pittsburgh Clay Pot Company was almost totally destroyed by fire resulting in a loss of \$280,000:



*The collapse of the buildings, intense heat, and great streams of water, shattered all the pots in stock, and rendered the raw Belgian clay in stock unfit for use.*

Although this incident happened many years before A. H. Heisey's letter to Rod, the need for the finest clay had to have been constant.

World War I's commencement in July, 1914, halted a significant German export to the United States. This commodity was optics, the finest of which were produced in Germany and critically required by the U.S. for military equipment and weaponry. According to the *National Glass Budget – the Weekly Review of the American Glass Industry*, dated June 28, 1913, the largest German exporter was the Carl Zeiss factory employing more than 4,000 persons, 3,700 of whom were skilled workers. Approximately 50% of their product was exported. When this was abruptly halted because of the war, American glass companies rushed to try to duplicate the quality of the German optics.

Soon it was apparent the lack of a source for fine clay hindered the quality of the glass required for optics. Silica based clay in the pots reacted to the silica in the melted glass causing some of the pots to melt into the glass resulting in lack of clarity. In the spring of 1917, the National Research Council devised a plan to speed up and improve the optical glassmaking process. The Council recommended the National Bureau of Standards join with the Pittsburgh Plate Glass Company, and the Geophysical Laboratory of the Carnegie Institution partner with Bausch and Lomb to see who could produce the best optical glass. Bausch and Lomb and the Geophysical Laboratory won the challenge. The clay for the better quality pots had been found in Kentucky. However, labor issues due to the Wartime Car Administration necessitated the shipment to Pittsburgh not of the raw clay, but of the pots, resulting in much breakage.

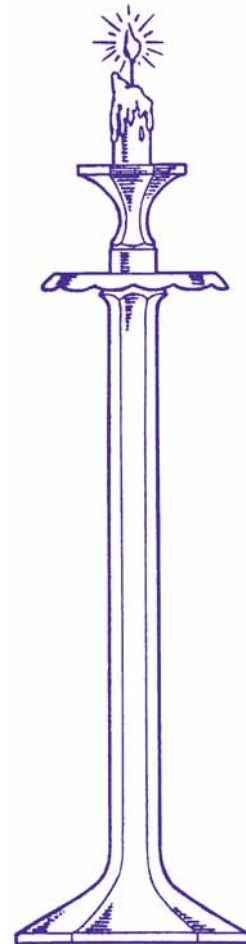
Unfortunately, we have found no more correspondence between Mr. Heisey and Rod Irwin so perhaps we will never know if any German clay shipments were sent to Newark. In addition, there is, so far, no documentation in the archives suggesting the A.H. Heisey & Co.'s involvement in America's quest for the perfect optical glass. In any case, the project would have required the

finest pots like those produced at the Pittsburgh Clay Pot Factory of which A. H. Heisey was president. As Heisey collectors, we certainly know the quality of any product made under the helm of A.H. Heisey was the very best.

We have set the date and reserved the Union Hall for this important event—it will be Friday-Saturday, **April 5-6, 2013!**

This HCA event is our largest fundraiser to benefit the museum. Very dedicated volunteers put this event together for YOU. HCA makes its money from the consignment fees collected, the auctioning of donated glass, and from glass not sold at the auction but later in the gift shop. As always, we are looking into ways to improve and expand our auction to make it better for purchasers and consignors. We are also looking for activities that would fit nicely with the auction. If you have any ideas let any Board member or me know.

In this issue of Heisey News you will find a consignor's packing list and the HCA Spring Benefit Auction contract. You can copy these for use. They will be on our website soon for you to download and use. As before, each member and household member can donate unlimited amounts of Heisey glassware and can consign up to forty (40) lots each. There is no limit to the number of items in each lot and we are encouraging each consignor to size each lot so it is valued at more than \$25.00. The Auction Committee reserves the right to modify lots but will do so sparingly. Please note that we are again accepting glass made from Heisey moulds by other manufacturers. Glass not made from Heisey moulds will not be sold and will be returned at the consignor's expense or become a donation to HCA.

Please read over the auction agreement carefully, as it, once signed, is an agreement between you and us. Please use the packing list to list items and group them into lots as you wish them to be. Remember to put a "D" beside the lot number(s) on the packing lists for those lots you wish to donate to HCA. Please be certain the packing list includes ALL of your items, that you fill in each line completely—Pattern #/Name, description, cut/etch, color, if marked, and provide the condition. Don't forget to sign and date the two copies of the auction contract and submit it along with your packing lists. Both should be in your box of consigned or donated glass. We will return one signed copy to you. Those who donate glass will be given a donation slip after the auction to use at tax time.

The success of this auction depends on the quality and quantity of glass consigned and donated. We are requesting you to send (donate, consign) GOOD DAMAGE FREE GLASS. Please look through your Heisey and donate and/or consign some to us to help support YOUR museum. **Consignments and donations for the auction must be received by Saturday, January 15, 2013.** The sooner your items are received the better since your consignment needs to be logged in, checked for damages in shipping, contracts executed and returned, and boxes resealed and locked away ready for cataloging.

Many dedicated HCA members including most board members volunteer to help to make this auction a success. Our work begins in earnest soon after January 15th. We, as always, need help to catalog the glass which normally takes us three weekends. We will need help in April setting up the glass for the auction, help at the auction itself, and after the auction to cleanup and take glass back to the museum for our successful absentee bidders. If you would like to volunteer please contact the museum or me. We are counting on your participation to make this auction the best ever!

Four things make for a great auction: great facilities, great glass, help from volunteers, and a great group of buyers with deep pockets to purchase the glass. We have the first thing—we hope to get the last three! Please contact the museum or me if you would like to volunteer to help. ## Consignments

All items consigned for sale or donated are to be made by A. H. Heisey and Company or by other manufacturers using Heisey moulds. The owner/ consignor / member, hereafter referred to as the owner, agrees to accept all responsibility for providing merchantable title for all glass sold.

Each owner may consign a maximum of forty (40) lots to the auction. A list of glass being consigned or donated and prepared by the owner is attached as an integral part of this contract. There is no limit on the number of items in each lot, but HCA retains the right to increase / decrease size / make up of each lot. Each owner may donate an unlimited number of lots to HCA for sale at the auction. HCA, however, at its discretion, will consign donated items for auction, add donated items to the museum collection, and/or sell donated items in the museum shop.

The HCA Auction Committee is authorized to reject any glass not deemed acceptable to HCA standards for this auction. These items may be returned to the consignor if they desire, at their expense. Otherwise, these items become the property of HCA.

Owners of glassware to this sale will be charged on the following sliding scale of commission per lot: \$5.00-\$50.00= 40%; \$50.01-\$200.00= 30%; \$200.01-\$400.00= 20%; \$400.01-\$750.00= 15%; \$750.01 and over= 10%.

## Settlement

Payments (settlement) to the owner for glass sold will be made in full not later than fifteen days after the completed auction from the HCA Auction Trust Account. Said account is set up and operated consistent with ORC Section 4707.024. The owner and HCA agree that no other payments will be required to be made in less than fifteen days. HCA will pay expenses including auction site rental, advertising fees related to this auction from its' commission from this account. Collection of funds, bad checks, debts, and unpaid auction lots is the responsibility of HCA.

## Responsibility

It is the responsibility of the owner to deliver the glassware to the National Heisey Glass Museum on or by January 15, 2013. HCA accepts responsibility for the glass after it is received at the Museum and until it is sold except that any glass damaged in shipment to the Museum will be referred to the shipper and owner. All glass damaged or lost while in the possession of HCA prior to sale will be valued by a qualified appraiser or appraisers and the owner will be paid on this basis, less commission.

**Auction and Bidding**

The auction will be a reserve auction. A reserve auction means an auction in which the owner or agent of the owner reserves the right to establish a minimum opening bid, the right to accept or reject any or all bids, or the right to withdraw the real or personal property (lot) at any time prior to the completion of the auction by the auctioneer.

HCA and the owner agree that:

1. The items will be sold to the highest bidder without reserve,
2. HCA and/or its auctioneer, has the right to accept or reject any or all bids,
3. HCA has the right to establish a minimum opening bid,
4. The owner may not withdraw the lot(s) at any time prior to the completion of the auction,
5. In the event no bids are received on a lot, that lot becomes a donation to HCA.

The minimum opening bid per lot is \$5.00 with a minimum bidding increment of \$2.50.

The owner and HCA both agree that absentee bids will be accepted by HCA. The minimum absentee bid on a lot will be \$15.00 with a minimum opening bid of \$5.00. Absentee bids are bids left by buyers prior to the auction and are executed in a competitive manner. Per HCA policy, HCA does not use the full bid amount as a starting bid. Bidding is initiated in the audience and then offered on behalf of the absentee bidder at the next increment continuously until bidding has stopped. (Example: Absentee bidder leaves a bid with a maximum amount of \$500.00. After item is sold through competitive bidding, the absentee bidder is successful for \$325.00.) HCA reserves the right to accept or reject any and all absentee bids. HCA is not responsible for misfiled bids that are not executed.

The owner or a person on behalf of the owner may make a bid on a lot the owner consigns or has donated if the auction is a reserve auction and the auctioneer provides full disclosure before bidding that the owner retains the right to bid. Absent this disclosure, owners cannot bid or have others bid on their behalf on their own consigned or donated items. Said bidding would constitute bid rigging and be in violation of ORC 4707.023.

**General Auction Terms and Conditions**

1. Payment: Cash, travelers check, certified check or personal check or money order with proper ID. Visa, MasterCard, and Discover Cards are accepted. 5% buyers premium. Buyers premium deleted for cash or check payment. Cash only payment may be specified for individual bidders at HCA's request.
2. HCA has endeavored to describe all items to the best of their ability; however this is not a warranty.
3. All items are sold as is and where is. The auctioneer has the right to make any verbal corrections at the time of sale and to provide additional information. Inspection is welcomed during preview and before the item is sold.
4. In the case of a disputed bid the auctioneers have the authority to settle disputes to the best of their ability and their decision(s) is/are final. Resale of items will be handled at the auctioneer's discretion.
5. The auctioneer has the right to set opening bids and reject any bid raise not in line with established bid increments. Items are sold without reserve, unless advertised otherwise.
6. All sales are final and all items must be paid for each day of sale. A moving and storage fee may be assessed for items not picked up within seven (7) calendar days after the last day of sale of the auction.

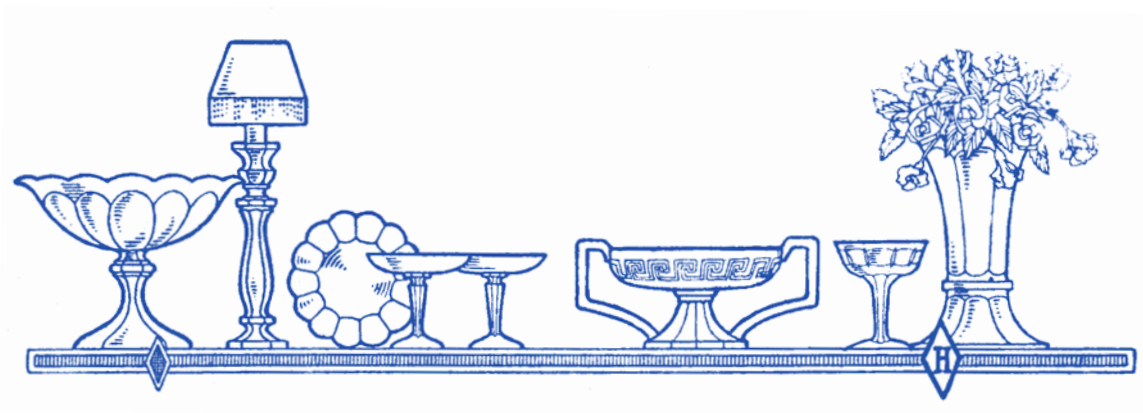

# There's Magic in Moonglo...

The following excerpt on Heisey's 980 Moonglo cutting is taken from the forthcoming *Encyclopedia of Heisey Glassware, Volume II: Cuttings and Engravings* by Neila M. Bredehoft, Thomas H. Bredehoft and Louise W. Ream.

## 980 MOONGLO

Gray with Hand Polished Punties

Introduced in 1942

Discontinued circa 1956

Sometimes Heisey spelled this as Moon Glo. Note that some cocktail shakers have a cut band around the base which appears to be the same as 976 ST. GEORGE WATERFORD. These were made for a short time during the early production of MOONGLO.

MOONGLO was normally sold with the punty of pressed ware left gray, but for a time in 1952 a special assortment was offered to buyers in which the punties were also polished on pressed ware. There were special cocktail shakers made with the following: "Champion Mound Builders Country Club 1945" and "Winner First Flight Mound Builders Country Club 1945". These words were engraved on MOONGLO cut shakers.

MOONGLO was cut by several former Heisey employees after the plant had closed and is sometimes found on other glass than Heisey because of this. Also, Glastonbury, Emil Krall's independent backer, advertised a cutting extremely similar to Moonglo, called Chantilly. It is found on stems not at all like known Heisey stemware.

Hand-blown MOONGLO, with its fluid design hand-cut into the crystal, radiates an easy charm that refuses to be tied to any one period. This cosmopolitan pattern is obtainable in a complete assortment of stemware and beverage items complemented by hand-cast table accessories."

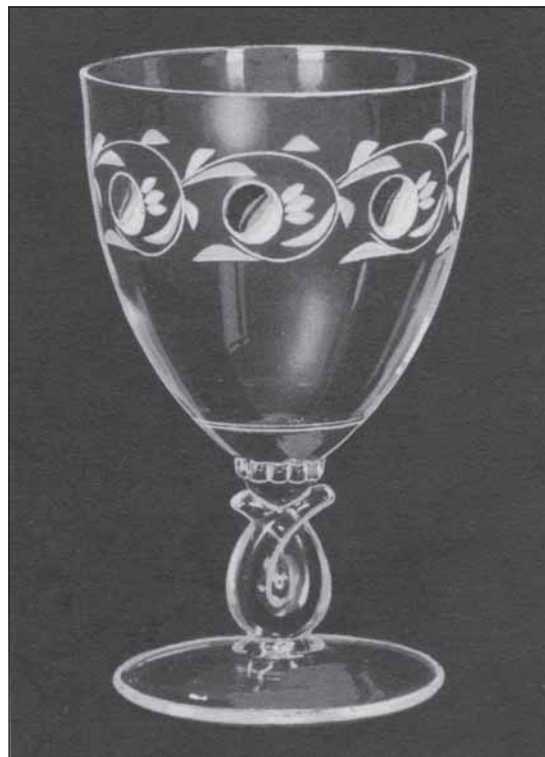

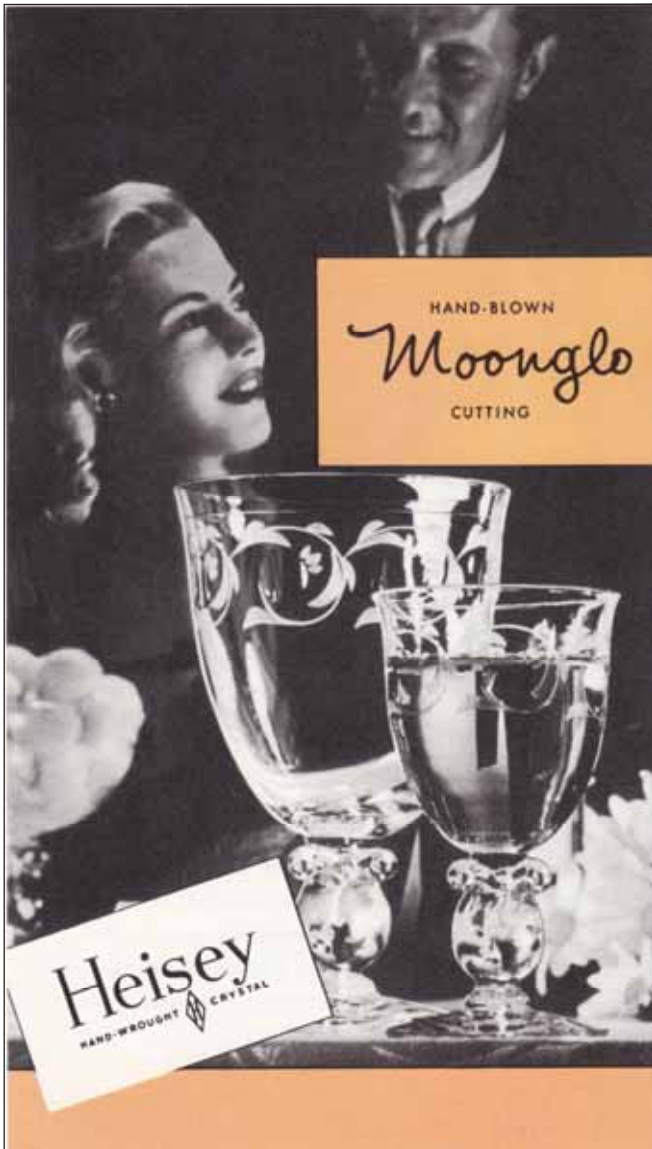

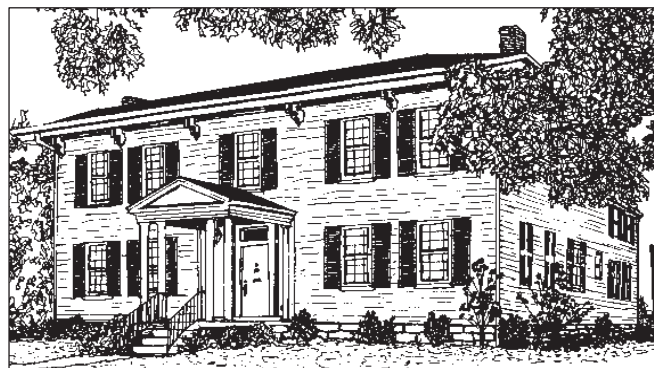
