First Quarter Financials

Karen Taylo

The first quarter of our 12 furlong race has been run. I've included the Budget VS Actual report, as of March 31, 2019, for your review.

Revenues did not meet budget mainly due to two line items: Sales and Cash Donations. Sales are traditionally slow in the first three months of the year. Membership and Admissions both show positive numbers for the quarter. You will note a line item for Dreams/Other Donations. The Dreams donations are not included in the Total Income as they were not budgeted.

Expenditures came in about \$2400 under budget for the first quarter. We chose, again this year, to make a single payment for the insurance to take advantage of a significant pay-in-full discount. To match the Dreams/Other Donations revenue, there is a Museum Expense – Dreams expense line. There is also an expense line for the Video project (Advertising – Video Project). Both of these expense lines are excluded from the Total Expenditures as they are not part of this year's Budget.

Members express satisfaction with museum, make suggestions for improvements

(Sixth in a series of articles on results of the HCA Member Survey. See October and December 2018, February, April and May 2019 issues for previous stories.)



The Member Survey conducted by Heisey Club of America (HCA) last summer provided data confirming what board members have long suspected - the organization is comprised largely of older generations. More than 85 percent of members are age 55 or older; just over 65 percent are 65 years and older. This piece of demographic data is firmly in the minds of HCA board members as they make decisions for the organization.

"This presents a challenge we must address if the Museum and organization are to continue flourishing in the years to come," said HCA President Michael Maher. "We are fortunate to have gathered a lot of great suggestions from our members. It is clear this is a concern for many."

The survey provided many responses to open-ended questions asking how HCA can attract younger generations to the Museum and interest them in Heisey glass. The board is studying these suggestions in shortand long-range planning efforts now underway.

The suggestions included such things as scavenger hunts through the Museum as well as games, hands-on activities and regular programs appropriate for children of various ages. For young adults, suggestions include hosting a wine tasting using Heisey wine glasses or a "Meetup" gathering at the Museum, and using social media to promote the events.

The importance of education was a strong theme. There were suggestions to attract tours of school and community groups to the Museum or to provide classroom presentations at local schools emphasizing the science of glassmaking, glass as an art form, and the importance of the A.H. Heisey Company in the history of area. One member suggested inviting teachers to the Museum and providing them with a packet of materials that tie in with the state's curriculum standards, free family passes to the museum and passes to the June glass show.

Various ways of getting Heisey glass into the hands of younger generations were suggested as a way to spark interest — give young visitors to the Museum an opportunity to hold and examine the glass, give Heisey glass as bridal shower and wedding presents. Capitalize on the wine craze that is sweeping today's young adults by giving them the gift of Heisey goblets and a couple of bottles of wine.

Some suggested helping young people see how Heisey glass can fit into their lives by creating YouTube videos demonstrating how it can be used for everyday family meals as well as a variety of special occasions ranging from baby showers and ice cream parties to craft beer gatherings and cigar parties. Encourage young people to consider the value of bringing grace and beauty to their table settings occasionally with Heisey glass.

One member suggested emphasizing the economical cost of many pieces, which can often be purchased for less than the cost of high quality new glass, as well as its relative durability. An Ipswich water glass or an Old Williamsburg goblet will likely outlast a thin tumbler from the local department for many years! Invite people to compare the quality of Heisey platter or punchbowl with comparable new items being sold today.

One person suggested younger generations might be motivated to care about Heisey glass by emphasizing its heritage value as an important product handmade made locally by American craftsmen and women rather than in a remote overseas factory.

The importance of family connections was highlighted. Current HCA members can make a point of sharing their Heisey glass with the youngsters in their families — using it for family gatherings, talking about its importance in family history, allowing them to choose pieces for themselves. Dan and Sue Kilgore are firm believers in the value of family connections. They helped their daughters choose their own Heisey patterns to collect when they were young and they now buy gifts of Heisey for their grandchildren, starting with each child's first Christmas. "We believe in giving memories, things you will keep for a long, long time and that will become part of your history," said Sue.

There were also suggestions for promoting Heisey more widely to the public through an ad campaign focused on younger generations, setting up displays at fairs and festivals and other public places, encouraging members to speak about Heisey to various organizations in their communities.

As the board considers these suggestions, it will also have to consider the budget impact as well as the capacity of staff and volunteers to carry them out.





Proposed Bylaws Changes

Constitution and Bylaws Committee

ARTICLE I Meetings

Section 2 Annual Meetings

The annual meeting shall be held in June for the installation of elected directors and for the presentation of annual reports and transaction of other business. The election of Directors shall be held at the annual meeting which may be designated as the "election meeting." The term of Directors shall officially begin at the close of business of the annual meeting. Charter directors shall hold office until the regular election occurring during the annual meeting in June 1973.

Proposed change:

"The annual meeting shall be held in June for the installation of elected directors and for the presentation of annual reports and transaction of other business. The election of Directors shall be held at the annual meeting which may be designated as the "election meeting." The term of Directors shall officially begin at the close of business of the annual meeting."

This proposed change would remove the last sentence of Section 2 which references "Charter directors" holding office until June 1973.

The last sentence of this section does not serve any current purpose so we are proposing its removal.

ARTICLE II Duties of Officers

Section 4 Treasurer

It shall be the responsibility of the Treasurer to have custody of all funds, accounting for same to the organization at its annual meeting and at any other time upon demand by the Board of Directors and to perform such other duties as pertain to the office including causing an audit to be made. The Treasurer shall be responsible for the collection of dues and funds of the organization and deposit them in the bank or depository named by the Board of Directors. Upon retirement from office, the Treasurer shall turn over to the successors or to the President all funds, books and accounts or any other organization property in the Treasurer's possession. The Treasurer shall furnish bond in the amount determined by the board of Directors, the cost of which bond shall be paid by the organization. (approved 3/11/95)

Proposed change:

"It shall be the responsibility of the Treasurer to have custody of all funds, accounting for same to the organization at its annual meeting and at any other time upon demand by the Board of Directors and to perform such other duties as pertain to the office. The Treasurer shall be responsible for the collection of dues and funds of the organization and deposit them in the bank or depository named by the Board of Directors. Upon retirement from office, the Treasurer shall turn over to the successors or to the President all funds, books and accounts or any other organization property in the Treasurer's possession. The Treasurer shall furnish bond in the amount determined by the board of Directors, the cost of which bond shall be paid by the organization. (approved 3/11/95)"

This proposed change would remove ""including causing an audit to be made" from the first sentence of the section.

The phrase "causing an audit to be made" is awkward and, to some, may sound as if the Treasurer should do something to cause an audit. The Treasurer's responsibilities would include any audit process deemed necessary and is covered by the phrase "to perform such other duties as pertain to the office."

ARTICLE III Board of Directors

Section 2 Functions

(a) The Board shall be responsible for the appropriation of all funds of the organization and shall, through the President or other duly authorized member of the Board, approve all vouchers before payment at the direction of the Treasurer. The Board shall designate the bank or depository in Licking County, Ohio for funds of the organization and determine the amount of the bond which shall be given by the President and Treasurer. The board shall receive and approve the Budget and the annual audit of the financial transactions of the organization. (approved 3/11/95)

Proposed change:

"(a) The Board shall be responsible for the appropriation of all funds of the organization and shall, through the President or other duly authorized member of the Board, approve all vouchers before payment at the direction of the Treasurer. The Board shall designate the bank or depository in Licking County, Ohio for funds of the organization and determine the amount of the bond which shall be given by the President and Treasurer. The board shall receive and approve the Budget and the annual financial statement of the organization."

This proposed change would replace "annual audit of the financial transactions" with "annual financial statement".

This change would reflect current practice. Wells & Priest, our CPA firm, provides an Annual Financial Statement which is reviewed and approved by the Board of Directors.





Monthly Money Watch


Year-to-Date as of April 30, 2019

Money Out - Expenses

This month we turn our attention to Expense line items:

- ♦ Salaries and Wages: All the wages paid to our employees. Wages are the largest expense in our Budget.
- ♦ Payroll Taxes: The Museum's portion of the employee's FICA and Medicare taxes.
- Bureau of Workers Comp: Payments to the Ohio Bureau of Worker's Compensation,
- Cost of Sales: Cost of Sales reflects the "cost" of the items sold throughout the year, even if we purchased the items 10 years ago. Since this figure does not represent a true cash expenditure, it is added back in at the end of the Budget (Less Cost of Sales). However, since other items (not Special Project items) are purchased throughout the year to sell in the gift shop, we must account for the cost of those purchases (Plus Inventory Purchases).
- Shipping and Handling: Shipping and handling costs.
- Accounting Expense: Monthly fees paid to Wells & Priest for processing and paying our bills, processing our payroll, balancing our accounts and producing our Financial Statements. They also produce and file our IRS Form 990 each year.
- ♦ Legal Fees/Retainer: Expenses related to legal advice.
- Office Supplies and Postage: Paper, pens and stamps, oh my!! Not to mention all the other office supplies used by the staff and volunteers throughout the year.
- Repairs and Maintenance: Expenses related to repairs/maintenance at the Museum and the Warehouse. Examples would include elevator maintenance, fire extinguisher inspections, carpet cleaning, plumbing and the cleaning service employed by the Museum.
- Lawn/Grounds Care: Monthly expenses for grounds maintenance, along with expenses related to winter ice/ snow removal
- ♦ Employee Relations: Expenses meant to promote employee relations.
- Museum Expense: General expenses incurred by the Museum that cannot be coded to one of the expense line items. Examples include flowers, plaques and nametags, small furniture items, etc.
- ♦ Utilities: Electricity, trash, gas, water, telephone.....for both properties, the Museum and the Warehouse (electricity and water only).
- Newsletter Printing & Postage: Cost of printing and mailing the Newsletter each month.
- Dues & Membership Expense: Membership dues paid to other organizations. Examples include membership in the Licking County Historical Alliance and the Licking County Chamber of Commerce.
- Advertising: Expenses related to advertising the Museum.
- Outreach: Expenses related to community outreach.
- Insurance: Commercial Property, General Liability, Directors & Officers Liability, Commercial Umbrella, Inland Marine (Collection/Mould coverage), and President/Treasurer Bond.
- ◆ Travel Expense: Travel expenses related to the off-site Percy & Vivian Moore Weekend.
- ♦ Computer & Website: Expenses related to our computer system and website maintenance. This includes a monthly charge for daily, offsite backups of the system to safeguard our data.
- Acquisitions: Expense for items purchased to add to the Museum collection.
- Bank Service Charges: Credit card processing fees make up the majority of this expense line item. Park National Bank service charges on our accounts are minimal (\$95.60 for 2018). There is also an annual fee for the Safe Deposit Box (\$90) and the Line of Credit (\$150).
- Auction Firm License/Bond: In order for HCA to conduct our Benefit and Dave Spahr Select Auctions, we must have an Auction Firm License and a \$50,000 bond. Both expenses are booked here.
- ♦ Special Project Expense: Expense for the purchase of beads, ornaments, Convention souvenirs and other special project items.
- ◆ Leased Equipment: Lease payments for two pieces of equipment, the large Canon printer and the Pitney Bowes postage meter.
- Miscellaneous: Is there anything we haven't talked about? Yes? It goes here!
- Less Cost of Sales & Plus Inventory Purchases: See Cost of Sales.




TABLE TALK

Table Talk was a monthly publication of A. H. Heisey & Co. that provided useful information on how to sell Heisey glassware. Its target audience included glassware buyers and sellers in department stores, jewelry stores and establishments that sold quality glassware. Typical focused on how to coordinate with Heisey national advertising campaigns and included related clip art that could be used for local advertising. Additional content provided tips on how to display the glass in attractive table settings and store window displays, information on the production process that could be useful in selling, examples of how the glass was being displayed in several high-end establishments and trends in elegant glassware including new colors and etchings. This is the first time that this material is being reprinted in one volume. This 296 page book presents 67 issues from 1926 to 1946.
