# 2019 46th ANNUAL SPRING ALL HEISEY BENEFIT AUCTION WRAP-UP

Auction was a wonderful HCA Event! Our two day Auction was held again at the GMP Local #244 Union Hall on 350 Hudson Avenue in Newark on Friday-Saturday, April 5 - 6, 2019. Our Auction was well attended with over 114 guests and members each day and we had 13 absentee bidders. We had 1,252 lots of glass from 37 consignors. The preview on Friday was from 9:30 AM to 10:30 AM with the Auction starting at 10:30 AM for the first 600 lots. On Saturday, doors opened at 8:30 AM, with our HCA Membership Meeting conducted by President Michael Maher at 9:00 AM, and we started our Auction at 9:30 AM for lots 601 – 1,252.

How did we do financially? We grossed \$71,194.39 (glass sales and buyer's premium) and after consignors and expenses are paid, we will net around \$17,500. We had a 2019 budgeted amount of \$16,000. Our average price per lot this year was \$56.68, about the same as last year's average of \$57.44. We had 18 lots of donated glass which brought \$1,525, while last year we had 32 lots generating \$2,690 – resulting in \$1,165 less than last year.

On behalf of the HCA Board of Directors and Staff, I would like to thank all the volunteers who worked, starting in January, unpacking, identifying, cataloging, and repacking the glass and then working for three straight days until the Auction was concluded. You make this event a success and HCA's largest fundraiser.

Special thanks to Walter Ludwig who graciously lent his time and Heisey expertise whenever asked; Dan Kilgore and his crew who ran the holdback area – a most difficult job; Jack Burriss who helps coordinate the event: and to Karen Taylo and Christa Myers, who performed clerking duties; and lastly to the Dayton and Buckeye Study Club members who worked tirelessly from January to April to make the Auction a success.

A big thank you goes to Craig Connelly, Auctioneer and his cohorts. They not only sell the glass; they keep us in stitches while doing so! Thanks to Kevin Burchett for continuing his role as our Auction Firm Manager. GMP Local #244's own Jimmy Gill worked to assure the hall was in tip-top shape all three days.

Also, thank you to all the consignors who consigned and donated glass to HCA and to all the Auction attendees and absentee bidders who purchased that wonderful Heisey Glass.

Hope to see all of you at the Convention in June.


# **2019 HCA Board of Directors Candidates**

# Members express satisfaction with Museum and make suggestions for improvements



(Fifth in a series of articles on results of the HCA Member Survey. See October and December 2018, February and April 2019 issues for previous stories.)

America (HCA) expressed their satisfaction promptly, with the National Heisey Glass Museum in written comments gathered through an online survey HCA conducted last June. Members also had many suggestions to make the museum even better.

This article focuses on the survey item that asked participants how HCA could improve the museum. The dozens of comments on this item were reviewed and grouped by topic for analysis. By far the greatest number of similar comments (17) indicated that the museum is great as it is and the status quo should be maintained. Members commented on improvements in recent years, including a series of beautiful, seasonal table settings and other interesting displays, a more visible gift shop and beautiful grounds. "Always a treat to visit!" commented one member.

The new museum doors were a big hit with at least one member, who described them as "a beautiful addition to the museum." Installed last year, the new custom-made glass doors were created from pieces of real Heisey glass in crystal and a variety of colors.

Several survey respondents indicated that museum curator/director Jack Burriss is doing an excellent job but could use more support to make the museum a highlight of downtown Newark.

A number of comments were related to the physical appearance of the museum. Some were very specific, such as removing clutter in some areas, making sure lights work in all display cases, replacing a scratched display case in the second floor gallery, and replacing carpet in some Suggestions for improving outreach and galleries.

Suggestions related to operations include such things as expanding hours and being open during holiday periods when people are in town and want to visit, answering

A number of members of Heisey Club of the phone and sending thank you notes building a volunteer and program.

> Several suggestions were made for improving the gift shop. One person suggested offering more gift items such as tie tacks, bracelets and more ornaments, while others suggested another eliminating non-Heisey items and reproductions from the museum.

> Programming also received attention from members. Suggestions included such things as enhancing self-guided tours with the use of an app or audio device, providing interactive programs for all ages and hands on activities for children, creating a scavenger hunt that encourages children to find different types of glass, and holding special events with expert speakers and inviting the public free of charge.

> There were several suggestions for expanding the museum to create more space for programming as well as displays and storage. One person suggested that a portico be added and another asked for a glass-making addition.

> A number of comments were related to greater resources and information. Several people addressed Heisey company archives, citing the need to preserve them appropriately, catalog them and then provide members with access to that information. There was also interest in more information about items in display cases and clearer photos of Heisey glass in Heisev News.

> Some suggested greater use of technology, including an updated video and creation of a virtual museum on the website.

> marketing of the museum included marketing it in the Newark area and placing advertising signs on highways leading to Newark, offering free passes to get more people into the museum, offering reduced cost membership for the first year and

having Heisey family homes designated as historic landmarks.

Watch for more member suggestions in upcoming issues of Heisey News. The next article will focus on members' suggestions for interesting younger generations in Heisey Glass and attracting them to the museum.

# TREASURER'S REPORT

# Money In - Revenue

This month we are looking at our Revenue line items:

- Membership is where we book both the Associate and additional member fees. This is also where the One-time Voting Membership fee is booked.
- Newsletter Ads includes the revenue from the Dealer Directory ads, along with any ads placed by individuals or groups in the Heisey News.
- Cash donations include not only money given by members and visitors, but by Amazon Smile and other charitable endeavors such as the annual Giving Tuesday.
- Donations This designation is used to identify money that has been given for a specific project. This is not a budgeted line item meaning we don't set an amount each year as part of the budget process.
- Acquisitions Donations would include any donation made specifically for acquiring items to add to the Museum collection. This is not a budgeted line item.
- Sales are generated through the Museum Gift Shop and also through eBay.
- Shipping generates revenue (and expense) by shipping gift shop items throughout the year. This line item also includes the money paid by members for the first class mailing of the Heisey News.
- Glass Identification is provided for individuals in the community for a \$5 fee. It's a small revenue source but is included in the budget process.
- Admissions includes the revenue from individuals visiting the Museum as well as from tour groups.
- Miscellaneous...need more be said? This "catch-all" line item includes revenue generated from renting of the Multi
  -purpose room....and other money that doesn't "fit" in any of the other line items.
- Interest Income is for just that, the interest generated from several of our PNB accounts.
- Benefit Auction, Dave Spahr Fall Auction, Convention and P & V Moore Event line items reflect the Net revenue from each of the events. The "actual" numbers change in the months leading up to and following the event as we take in revenue and pay expenses.
- Special Project Income is another unbudgeted line item.

Next month we will look at Money Out - Expenses.

# Proposed Bylaws Changes Constitution and Bylaws Committee

ARTICLE I Meetings

# Section 2 Annual Meetings

The annual meeting shall be held in June for the installation of elected directors and for the presentation of annual reports and transaction of other business. The election of Directors shall be held at the annual meeting which may be designated as the "election meeting." The term of Directors shall officially begin at the close of business of the annual meeting. Charter directors shall hold office until the regular election occurring during the annual meeting in June 1973.

# Proposed change:

"The annual meeting shall be held in June for the installation of elected directors and for the presentation of annual reports and transaction of other business. The election of Directors shall be held at the annual meeting which may be designated as the "election meeting." The term of Directors shall officially begin at the close of business of the annual meeting."

This proposed change would remove the last sentence of Section 2 which references "Charter directors" holding office until June 1973.

The last sentence of this section does not serve any current purpose so we are proposing its removal.

ARTICLE II Duties of Officers

# Section 4 Treasurer

It shall be the responsibility of the Treasurer to have custody of all funds, accounting for same to the organization at its annual meeting and at any other time upon demand by the Board of Directors and to perform such other duties as pertain to the office including causing an audit to be made. The Treasurer shall be responsible for the collection of dues and funds of the organization and deposit them in the bank or depository named by the Board of Directors. Upon retirement from office, the Treasurer shall turn over to the successors or to the President all funds, books and accounts or any other organization property in the Treasurer's possession. The Treasurer shall furnish bond in the amount determined by the board of Directors, the cost of which bond shall be paid by the organization. (approved 3/11/95)

Proposed change:

"It shall be the responsibility of the Treasurer to have custody of all funds, accounting for same to the organization at its annual meeting and at any other time upon demand by the Board of Directors and to perform such other duties as pertain to the office. The Treasurer shall be responsible for the collection of dues and funds of the organization and deposit them in the bank or depository named by the Board of Directors. Upon retirement from office, the Treasurer shall turn over to the successors or to the President all funds, books and accounts or any other organization property in the Treasurer's possession. The Treasurer shall furnish bond in the amount determined by the board of Directors, the cost of which bond shall be paid by the organization. (approved 3/11/95)"

This proposed change would remove ""including causing an audit to be made" from the first sentence of the section.

The phrase "causing an audit to be made" is awkward and, to some, may sound as if the Treasurer should do something to cause an audit. The Treasurer's responsibilities would

include any audit process deemed necessary and is covered by the phrase "to perform such other duties as pertain to the office."

ARTICLE III Board of Directors

# Section 2 Functions

(a) The Board shall be responsible for the appropriation of all funds of the organization and shall, through the President or other duly authorized member of the Board, approve all vouchers before payment at the direction of the Treasurer. The Board shall designate the bank or depository in Licking County, Ohio for funds of the organization and determine the amount of the bond which shall be given by the President and Treasurer. The board shall receive and approve the Budget and the annual audit of the financial transactions of the organization. (approved 3/11/95)

# Proposed change:

"(a) The Board shall be responsible for the appropriation of all funds of the organization and shall, through the President or other duly authorized member of the Board, approve all vouchers before payment at the direction of the Treasurer. The Board shall designate the bank or depository in Licking County, Ohio for funds of the organization and determine the amount of the bond which shall be given by the President and Treasurer. The board shall receive and approve the Budget and the annual financial statement of the organization."

This proposed change would replace "annual audit of the financial transactions" with "annual financial statement".

This change would reflect current practice. Wells & Priest, our CPA firm, provides an Annual Financial Statement which is reviewed and approved by the Board of Directors.

# The Northwoods Heisey Study Club Northwoods members learn about Cabochon and Patio

The Northwoods Heisey Study Club March meeting featured a well-illustrated program by Bev Heise on two Heisey glass patterns and a show and tell of a variety of wonderful glass.

The business meeting included re-election of current officers: Doug Olson, president; Bob Heise, treasurer; Mary Olson, secretary. Other business was discussion of an appropriate memorial for recently deceased member Gordon Olsen, the meeting schedule for the year, plans for the club's mini-auction and raffle in May to raise funds for the National Heisey Glass Museum, and the national convention in June. Bev and Mary announced they will team up on a table display for the convention.

Business was conducted quickly to get down to the main event, Bev's presentation on two patterns introduced in 1951, a small pattern called Patio (#1624) and a much more extensive pattern called Cabochon (#1951, #6091 and #6092).

The Patio line, which was advertised only in the 1953 catalog, included four items: tumbler, ice tea, sherbet and juice. It was made in both crystal and an amber color called Sultana. Bev shared a tumbler in Sultana from her collection, commenting that it was seemed to have a very sleek, modern design at a time when Heisey was making a lot of stems with etches and cuttings. Production of the line ceased by 1955 though it is thought it had been discontinued earlier but warehouse stock was being sold through 1955.

The #1951 Cabochon line, designed by Horace King, combines circle and square shapes. Bev defined a cabochon as "a stone cut in a convex shape but not faceted like a diamond." Considered to be Heisey's last major line, it was produced from 1951 through 1957 and included 35 items. It is described as an informal pattern with a modern feel. Imperial Glass Corporation reproduced fourteen items after Heisey ceased production.

Bev showed a two-light candlestick prominently marked with a diamond H and a covered candy dish in zircon that clearly demonstrates the combination of square base and round bowl. Other pieces in the pattern include various bowls, plates, relishes, sugar and creamer with tray, flared vase and more.

Cabochon #6091 is a crystal stemware line of eight items with pressed stems and blown bowls. Bev showed a cordial with 520B Leaf cutting designed by Eva Zeisel. It was also decorated with a number of other cuttings, including Hollyhock, Silver Iris, Cattail, Starlight, Baroness, Debutante and South wind.

Cabochon #6092 is a line of blown tumblers with solid bases, all in Sultana with crystal bowls. Bev said King felt the base was too heavy to be artistic.

In the spirit of St. Patrick's Day, Chuck Bingham brought an item in green, the #1201 Laverne floral bowl in Moongleam. He said the bowl was made from 1924 to 1933, also in Crystal, Flamingo and experimental Vaseline.

In selecting items from their collection for show and tell, Marv and Joann Christenson reflected on the beauty of Heisey after more than 100 years of use. They chose two very early items to share. The first was a #1201 Fandango toothpick. In 1892 Heisey made 62 items in this pattern, but by 1903 only 11 items remained and by 1909 only one item remained, an ice cream set. Items were made in Crystal and Emerald. "The piece is just as bright and shiny as when it was made," said Marv. "It is at least 110 years old."

The second item they shared was a #1205 Fancy Loop nappy. Introduced in 1896, this pattern included 75 items. By 1903 it had been reduced to 12 items and it was discontinued in 1909.

Virginia Johnson shared a #1469 Ridgeleigh item listed as Individual Vase #4 that her daughter and son-in-law purchased recently at an all-glass estate sale in St. Paul.

Doug Olson also shared a piece of Ridgeleigh, an oval floral bowl in Sahara that he bought at the same estate sale. He also shared two Flamingo salad plates from the same sale that look nearly identical. One was #1225 Ridge and Star made from 1924 to 1935 in Crystal, Moongleam and Hawthorne as well as Flamingo. The other was #407 Coarse Rib made from 1923 to 1937 and in the same colors. He also shared a #3362 Charter Oak goblet in Flamingo.

Bev shared a #310 Ring Band toothpick in opal decorated with blue flowers. This pattern was introduced in 1900 and made for several years. She also shared a #1220 Punty Band salt and pepper in opal. It was a souvenir of Lake Park, Iowa. Close inspection by eagle eye Courtney Markuson revealed a punctuation error in decoration; there was a comma after Lake and another after Park!

Bev also shared a #47 Regal candlestick, which had been made between 1912 and 1929. It featured gold decoration by Honesdale and a Diamond H visible at top of the column, but somewhat obscured by the decoration.

In anticipation of the *Off to the Races* theme for the 2019 HCA convention, also Bev shared her recent acquisition of #1540 Oscar horse, which was made between 1941 and 1946.

Following Show and Tell, Bev and Bob served a variety of refreshments suited to the St. Patrick's Day theme using their Ipswich tableware in Moongleam and Crystal.


