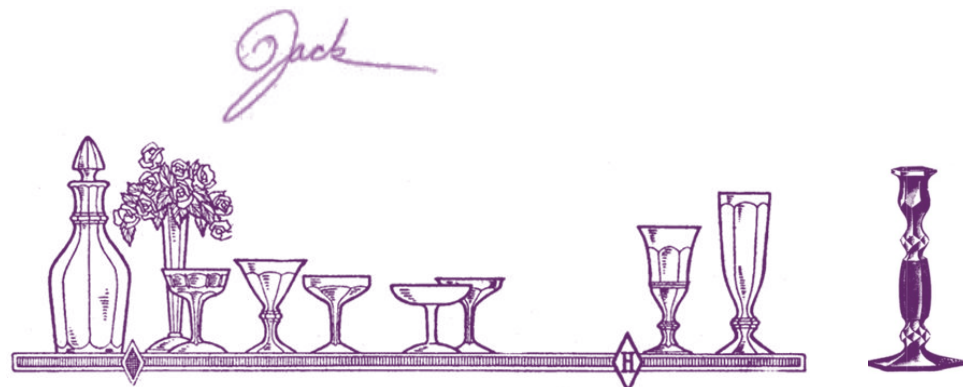
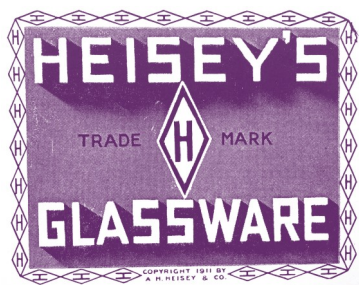

TREASURER'S REPORT

When I speak with friends, family, or acquaintances about collecting Heisey glass, I always mention the group of wonderful collectors with whom I am associated. You, the members, are the heart of HCA. I wish I could say I knew each of you personally, but I can't. I can say I know your generosity and willingness to help when the Museum needs it....Thank you for your continued support.

Cash Donations to the Operating Fund

The response to the Study Club and Membership eGrams has been tremendous with donations totaling \$13,827.25 in the month of April. Michael Maher's Facebook challenge (#COVIDCocktailChallenge) saw another \$2,461 in donations sent directly to the Museum as well as a number of puckered faces from the cocktail mixtures concocted by our members. Our donation total for April: \$16,288.25. This will go a long way to support the Museum during our shutdown.

Financial Reviews

Anna, Jack and I continue to meet on a weekly basis to discuss all things financial! The Museum staff have done a great job in monitoring employee hours and non-essential expenses. Many thanks to Anna and Jack for answering my endless stream of questions each week.

Paycheck Protection Program

The CARES Act provided small businesses, including nonprofits, an opportunity to apply for Small Business Administration loans through the Paycheck Protection Program (PPP). The loans were designed to stabilize small businesses during the pandemic and help them retain their employees. The loan amount can be forgivable to the extent it is used for payroll costs, mortgage interest, rent payments and utility payments. Loan payments are deferred for the first 6 months. The interest rate is set at 1% with a two year term.

HCA applied for and was approved for a PPP loan in April. The funds will not only cover our current payroll for 8 weeks, but will allow us to restore our Guest Member Services Associates (GMSA) staffing to previous levels for the same time period. We are excited to have our employees back on the job. Rest assured, Jack had a long list of "things to do" waiting for them when they returned!

I would like to recognize and thank several people who were instrumental in helping us secure the PPP Loan:

Jenny Morehead, Park National Bank Commercial Lender. Jenny responded quickly to my inquiry regarding the loan, sent me the necessary paperwork and quickly processed the completed paperwork once returned to PNB. Mindy Ragno, Wells & Priest. Mindy provided the payroll reports needed to complete the PPP loan application the same date as requested.

Tiffany Brandt, Heisey Collectors of Texas. Tiffany helped complete the application with insight as to specific information requested by the SBA and by PNB.

OBWC Refund

We received a refund of \$1170 from the Ohio Bureau of Workers' Compensation. Governor

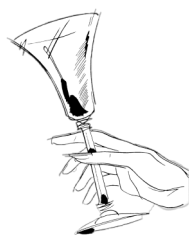
DeWine recently authorized the refund of 2018 Workers' Compensation premiums paid by Ohio businesses. Thank you Governor DeWine!

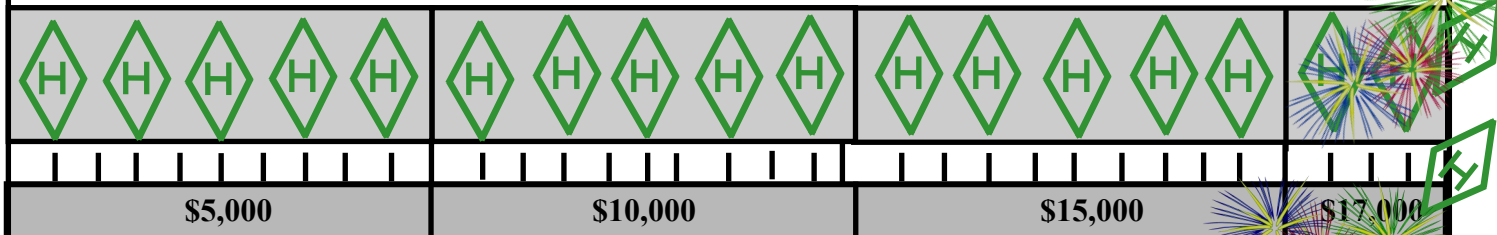

Reminiscing

The year was 1972. So much was going on in the world: President Nixon visited China, Hollywood released The Godfather, the Vietnam War was raging, Bobby Fischer became the first American chess champion, the Dow Jones Industrial Average closed above 1,000 for the first time, Eugene Cernan becomes the last person to walk on the moon and in a little town in Ohio over 200 people gathered for the First Annual Convention of the Heisey Collectors of America.

Here is a partial reprint of the registration form from the May 1972 Heisey News:

So, one might wonder, how the first Convention turned out? Well, let's hear it straight from Louise Ream. Reprinted from the July 1972 Heisey News:

Convention by Louise Ream

"Over 200 people were pre-registered for at least part of the convention events. With a membership of less than 550 people at the time, this was a very good attendance for the first year.

Many new members were obtained during the show and the battle for youngest is probable now ended. Christy Robinson, age 3½ weeks was present during the convention and wore her badge. She is the daughter of Mr. and Mrs. Jerry Robinson of Villa Park, Illinois.

Conventioneers spent much time at the display studying the glass and at the show finding choice pieces. Several people brought glass for "the show and tell" on Thursday and we hoped we could tell them it was all Heisey and much of it was. At this meeting, all of the patterns of early years were available for examination.

At Friday morning's seminar Steve Bradley presented an excellent slide show, principally on stems but he also showed many cuttings and etchings and all of the known colors. His photography is outstanding. Most people who attended this meeting agreed with us that Steve should put out a book on Heisey stemware. How about it Steve?

Wayne McPeck, member of the board of directors of the HCA and co-author, along with his wife Carole, of 'Verlys of America Decorative Glass', which was recently published, gave a short talk on this beautiful glass. It was made at the Holophane Company which is directly across the street from the old Heisey factory. Some Verlys items were actually made by Heisey in the late years which is why this glass seems to belong at a Heisey show.

The Friday night buffet and auction preview drew the largest attendance of any of the scheduled events. Special guests were Mrs. T Clarence Heisey, widow of one of the sons of the founder of the company, her son Thomas C. (Tim) Heisey, Mr. and Mrs. A. H Heisey, another grandson of the founder, and his daughter Tina Veazie. Tim and Gus each said a few words to the guests. The Heiseys also spent much time with us at the show and display which we appreciated.

Joseph Lower, of Decatur, Indiana, who represented the Heisey Company in New York City for 25 years and later served in the same capacity for Imperial for ten years, was, together with his wife, a most welcome guest. Kay and Stanford Darling whose 1964 article was reprinted in the June 'News' were among those present.

Lucille Kennedy, assistant to Carl J. Uhrmann, president of Imperial Glass Corp., was the guest speaker. Lucille started working for Imperial 30 years ago in the order department. She later became assistant to the sales manager, then secretary to the sales manager, advanced to special sales assistant when she started traveling to the china, glass and gift shows. She later became assistant to the president who was then Carl Gustky. Joe Lower told us that she is the best informed person in the handmade glass industry today.

She spoke to us about Imperial's position as far as Heisey reissues are concerned. She told those present as she has told us so often, that when Imperial took over the Heisey molds they first filled orders which Heisey already had and then continued to make some of these patterns and added new ones. They did not dream that Heisey glass would become so immediately collectible and never once thought of removing the mark.

When this fact was called to their attention, and also the fact that many unscrupulous people were selling Imperial for true Heisey, they began taking steps to remove the mark from the molds put into service, which they still do. She assured us that they will never again use the Heisey mark and promised to inform HCA if they put any new molds into use.

In answer to a question as to whether they planned to make clear animals again, she said she doubted it very much since the molds are so bad. She did say that if ever they did, they would sign them with the IG. Lucille is a delightful person and everyone there thoroughly enjoyed her talk.

Saturday's auction drew a very large crowd and rare Heisey sold for good prices. Animals were popular with the bidders as they always seem to be. A delicious breakfast at the YWCA preceded the annual meeting on Sunday. Club members thanked the local members of the HCA for their hard work in making the week's events so successful. Some presentations were made for the museum fund which is another story in this issue. Ideas were presented for next year and the active members voted to recommend to the board of directors that the Convention, show and display be held again next year.

Some pictures from the show and Friday night buffet are in this issue and more will be printed as space permits.

One of the nicest compliments we received was from a Cambridge collector who thinks he may switch to Heisey 'because Heisey people are so friendly' and we agree. Thanks to all who came and the rest of you must come next year."

We will miss getting together this year to continue the long tradition of wonderful gatherings in June. Let's heed Louise's final words: Thanks to all who have attended Convention recently and "the rest of you must come next year"!!

Is It Is, or Is It Ain't a Heisey Toothpick?

With the “Stay at Home Orders” and nothing to do, (really, I have a lot I should be doing but would rather not) I have been scouring the internet for Heisey glass. One thing I have noticed is there is a lot of confusion about what is a toothpick holder, and is it really Heisey? There has been much written about Heisey toothpicks over the years so, being the contrarian, I decided to write about what is not a Heisey toothpick. The following are some of my observations and information I have gleaned over my years of collecting Heisey glass.

In the booklet “Heisey Toothpick Holders” by Nancy and David Jones, they divided confusing and deceptive items into five categories, (I’ve paired it down to four): Fakes, Reproductions, Whimsies and Misidentified Items.

The first category is Fakes, and the first rule of collecting Heisey is, if it says: “A.H. Heisey & Co. Founded 1896,” it is not Heisey. Many pieces of Heisey can be found as souvenirs, but Heisey never advertised themselves that way. In the mid to late 1960’s through the 1970’s, Guernsey Glass made a bunch of these advertising pieces in various colors to latch onto the collectability of Heisey and Cambridge Glass. They were in such a rush, that the earlier toothpicks they produced said “A.J. Heisey.” So much for proof reading! These toothpicks do not even remotely resemble any Heisey pattern ever made.



Not all toothpicks marked with the Diamond-H are actually Heisey Glass. Two known toothpicks, Inverted Strawberry (which was originally a Cambridge pattern), and Stars and Stripes can be found with the Heisey mark. They are found in multiple colors and the quality of the glass is poor. Again, somebody trying to cash in on the popularity of Heisey!

Second, and this is a tricky one, not all Beaded Swag toothpicks are Heisey! Mosser Glass made a Reproduction of the Beaded Swag toothpick. Since the molds for this were probably long gone, Mosser must have made the mold from an original Heisey toothpick. The Mosser toothpick is much thicker and heavier than



its Heisey counterpart. The Mosser version is usually found in Milk Glass and is very opaque and of lower quality than Heisey’s Opal. It usually has a nice painted design on it with the artist initials. My parents found one in Robin’s Egg Blue with “A.H. Heisey & Co. Founded 1896.” (Both a Fake and a Repro!) Imperial Glass was not known to have reproduced any of the Heisey toothpicks.



There are two Toy Beer Mugs, Nos. 616 and 617, found in the original Vogel Book I, page 105. These Toy Beer Mugs were produced by multiple glass companies in the early 1900's and sold as souvenirs with ruby stain. It's not clear if Heisey ever marked these, and without the mark, it is impossible to tell who really made them. The No. 617 was reproduced in the 1960's or 70's in multiple colors, and sometimes appear as a souvenir. These Toy Beer Mugs are often sold as toothpicks. They fall in the Fake, Reproduction and Misidentified categories.

Third are the Whimsy items. These are all actual pieces of Heisey that have been reworked into a toothpick holder. The best examples of this are candlesticks that have had damage to the base. Break off the base and polish, leaving the candle cup, and "Presto," you have a toothpick holder. Another example of a Whimsy is the No. 1 Spool which was used



on some of the nicer Heisey Candelabras to conceal the metal ferrule that connected the base to the arms. It came out of the mold with a wafer shaped foot on one end. This was meant to give the workers something to hold onto when it was removed from the mold and still hot. With the foot still on, it looks like it belongs in one of the Flat Panel patterns. I have even seen a salt shaker with the threads

ground off, sold as a toothpick. Keep an eye out, Heisey workers were notorious for making "End of the Day" whimsies and you never know what you might find.



Some Heisey toothpicks were reworked after coming out of the mold. The 379 Urn Individual Nut was produced from the toothpick mold by flaring it out to produce more of a bowl shape. I don't know if this is considered a whimsy or was an example of Heisey getting more than one item out of a single mold, they were known to do that on occasion.

Fourth, we have Misidentified Heisey items. In the land of "Heisey Smalls" toothpicks reign supreme, so it's no wonder people misidentify something as a toothpick. Either the dealer was unable to identify a piece, or they were just too lazy to look it up. Misidentified items consist of (but are not limited to) Match Holders, Cigarette Holders, Wine Stems and Bar "Shot" Glasses. To begin with, Heisey Toothpick Holders were produced from 1896 through 1913 or so, when it was then considered bad manners to pick one's teeth at the dinner table. It is possible to find souvenir toothpicks dated later than 1913, but these would have been from existing stock. Any misidentified item produced before 1913 was either a Match Holder, Wine Stem or Bar Glass.

For the time before 1913, there were only two Heisey match holders in production. The first was the 1280 Winged Scroll Match Holder, which was part of a couple of different Smoking Sets. It is a straight sided piece that has none of the curves and style of its toothpick sister. The other match



holder is the No. 56 Sweet Scroll, which was part of a line of Novelty items produced by Heisey in the early 1900's. All of the Novelty items produced by Heisey were in Milk Glass and are far inferior in quality to the glass Heisey is known for. I don't want to say these

pieces were made in Opal because they are more opaque than Opal. The Sweet Scroll Match Holder has the number 56 and a squat Diamond-H on the bottom. After 1930, we have the 1550 Dolphin Match holder and the 1454 Diamond Point Top Hat Match/Cigarette Holder. Both the Dolphin and Top Hat were reproduced by Imperial Glass.



Also, after 1930, most of the items you will see offered as toothpicks are actually cigarette holders. The 1404 Old Sandwich, 1428 Warwick, 1469 Ridgeleigh (4 different holders), 1503 Crystolite (3 different holders), 1519 Waverly (without top), 3390 Carcassonne, 5012 Urn and 4035 Bethel Urn Cigarette Holders all fall into this category. Any of the Heisey Cigarette holders would look lovely holding frilly toothpicks on a buffet table full of Heisey platters, relish trays and bowls loaded with hors d'oeuvres. Imagine the table set with all Orchid Etch! Nobody smokes anymore, so why not use them as toothpicks?

The wine stems from the period before 1913 would barely be considered as Cordials today because they are sooooo small. The 341 Puritan is the only stemmed toothpick and is about the same size as the wines, but it has a scalloped rim making it quite difficult to drink from. (Fun Fact: I purchased my Puritan toothpick as a Cordial.)



Bar Glasses are a different story all together. Where most of the toothpicks have scalloped or beaded rims, four did not. The 150 Banded Flute toothpick is the hardest one to distinguish because there were a variety of bar glass in differing sizes in this pattern. It is identical to the 2 oz. bar glass, and the same size as the 1-1/2 oz. bar with "sham" bottom. The 337 Touraine toothpick could easily be confused as a bar glass, except Heisey didn't make a bar glass in Touraine. The 379 Urn toothpick has a flat, thick, six-sided rim that

would be hard to drink from, and no bar glasses were made in this pattern. The 433 Greek Key toothpick and the 2-1/2 oz. bar are the same item. When surfing the internet, you will often find a Heisey bar/shot glass offered as a toothpick, so beware, unless you are also starting a shot glass collection.

The 1225 Plain Band Toy Spooner is the toothpick holder that has been flared out. The Plain Band Custard and the bottom of the Toy Sugar without a lid are often misidentified as toothpicks. (The toys are pictured on the upper and lower right.)



Anything you see offered as a toothpick holder that has handles is usually an individual sugar or creamer. The 393 Individual Cream and Sugar are frequent flyers on this list. The 1200 Cut Block Individual Sugar is a little taller and wider than the toothpick, making it easy to confuse

the two if not side by side. Two of the more devious pieces in this category are the 393 and 394 Narrow Flute Individual Domino Sugars, as neither one looks like a typical sugar and hardly anybody uses sugar cubes today. When compared to the 353 Medium Flat Panel Toothpick, it's easy to see why somebody would confuse the Domino Sugars for a toothpick holder.



Beware of a Mustard or Lavender Jar missing its lid, identified as a toothpick holder. If it is small and has the Heisey mark, somebody will call it a toothpick. Anything small, including Oyster Cocktails will be listed, and can be used as toothpick holders. Although I've never been lucky enough to have found one, keep an eye out for any of the Heisey Favor Vases offered as a toothpick. They are the right size, and who today knows what a favor vase is? You just might nab a bargain!



Last, we have two Heisey Toothpicks that are not considered toothpicks by collectors! The reason being is these were part of a Hostess Helper set and used to hold frilly toothpicks to spear hors d'oeuvres, not pick teeth. They are 1485 Saturn and 1567 Plantation, which looks just like the Saturn toothpick without the ring optic. The sets consisted of three toothpicks in metal hangers on the outside of a large ice bowl with a mayo in the center. The

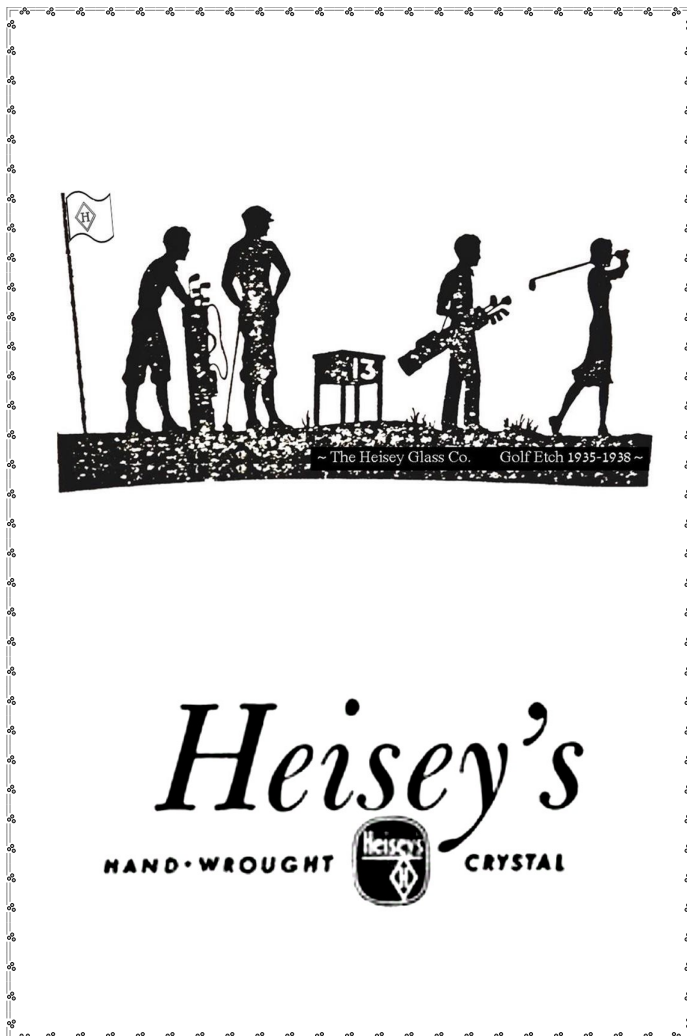
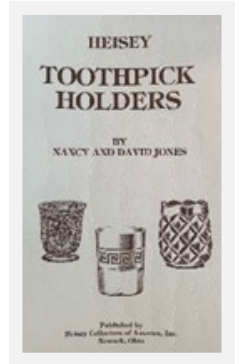


September, 1950. The ice bowl for the Plantation Hostess Helper is quite difficult to find, as are the toothpicks and metal rings.

I hope this was some help to all of you Heisey folks who are just starting to collect toothpick holders. The great thing about toothpicks is that they were made for a limited time and they are small,

so your collection won't take up a lot of room! For information on what is a toothpick, I suggest you track down the "Heisey Toothpick Holders" booklet by Nancy and David Jones.

First Quarter Financials by Karen Taylo

Well, it's been an interesting first quarter of the year. I hope everyone is well, maintaining social distancing and wearing a mask when you venture out into the world. The pandemic has touched so many aspects of our daily lives and, as you would expect, with the closure of the Museum, it has also affected our financial wellbeing. With that in mind, let's review the Budget VS Actual report as of March 31, 2020.

As a reminder, the Museum was under full operational status for the first half of March. As soon as the decision was made to close the Museum, measures were instituted to reduce non-essential operational costs. Those measures remain in place today.

Also, there are two revenue line items not included in the Total Income: Donations – Dreams/Other, and Donations – Museum Capital Fund. These funds were donated for specific projects and are not budgeted so, therefore, are not included in the total.

On the Revenue side, you will note positive variances in most areas, including Cash Donations. After the Museum closed, members and study clubs began answering the call for cash donations before the call was even made! A separate article recognizes those who have donated over the past months. Sales, which had been fairly robust in January and February, took a hit in March. The negative amount under Benefit Auction Net reflects the cost of catalog production and envelopes. The Convention Net negative variance resulted from venue deposits offset by some glass show revenue we received during the first quarter. With the cancellation of the Convention, we have requested refunds of our deposits from the venues.

Our YTD Total Available Funds shows a positive variance of \$559.

Expenditures came in \$455 under budget for the first quarter. We chose, again this year, to make a single payment for the insurance to take advantage of a significant pay-in-full discount. The insurance renewal amounts came in a little higher than anticipated.

While Salaries and Wages are over budget YTD, they were under budget for the month of March. Repairs and Maintenance costs included repairs to bathroom plumbing, and the Archives HVAC unit. The Special Projects Expense reflects payment for inventory items ordered earlier in the year.

Ending the first quarter on a positive note is a result of our member's dedication to the Museum. It's also the result of the Museum staff embracing and supporting the new normal of day-to-day operations. I want to thank everyone for their continued support. Please stay safe and healthy!
