

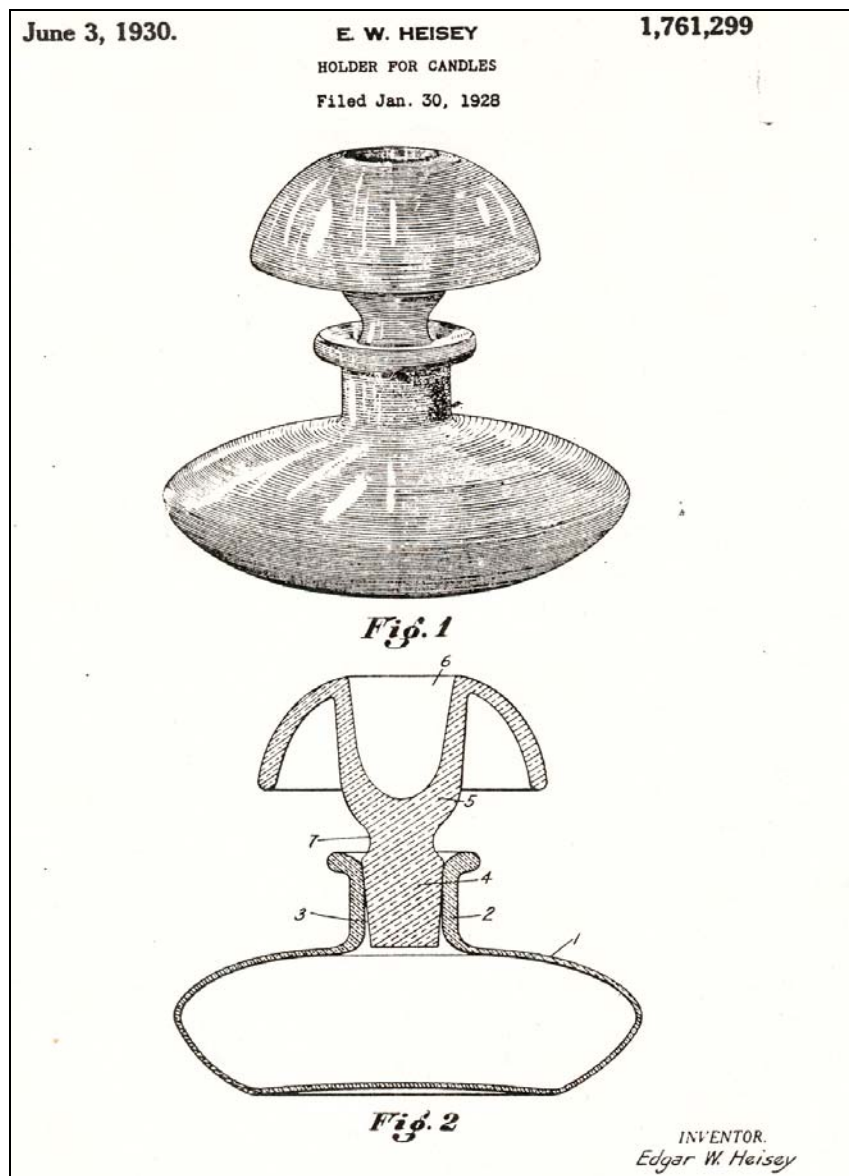

UTILITY PATENTS ASSOCIATED WITH A.H. HEISEY & COMPANY (PART 7)

I want to thank all of the reader's of this Newsletter for staying with me as we have gone through the Heisey utility patents. Up to this point most of the patents dealt with some of the processes that go on inside the glass factory. We have had a lot of patents that dealt solely with the finishing process that Heisey put the glass through after it was molded. Some of these patents were rather dry and hard to really understand. But they have their place in the story of A.H. Heisey & Company. The patents could also be appreciated as pieces of industrial art that tell a different story of the company than the glass that they produced.

Well, now is the time for some of the most interesting patents that we will cover in this series. These are patents for true innovative pieces of glass that the company produced. The patents that will be covered in this article were issued from June of 1930 up to May of 1934.

The first one we will investigate is patent 1,761,299 issued on June 3, 1930 to E. W. Heisey for a "holder for candles." You can see the design drawing that accompanied this patent on the front cover of this Newsletter. I am sure that many of you recognized the 520 Innovation candle lamp.

The actual patent lists the inventor as "Edgar W. Heisey, of Newark, Ohio, assignor to A. H. Heisey & Company of Newark, Ohio, a partnership." We are used to referring to the inventor as E. Wilson Heisey, son of A. H. Heisey and the second president of the company. Just as many of the earlier patents had A. H. Heisey's name on them, we now find E. Wilson's name on this patent. Again, we do not know how much involvement that E. Wilson had in developing this fascinating piece because it would have been standard practice at this time

to have the patent in the name of an officer of the company for anything that was developed by an employee. The application for this invention was filed on January 30, 1928.

The patent reads, "My invention relates to a holder for candles. It has to do, particularly, with a novel combination of a receptacle and a closure therefore, with the closure specifically designed to be both effective as a closure and to constitute a support for a candle.

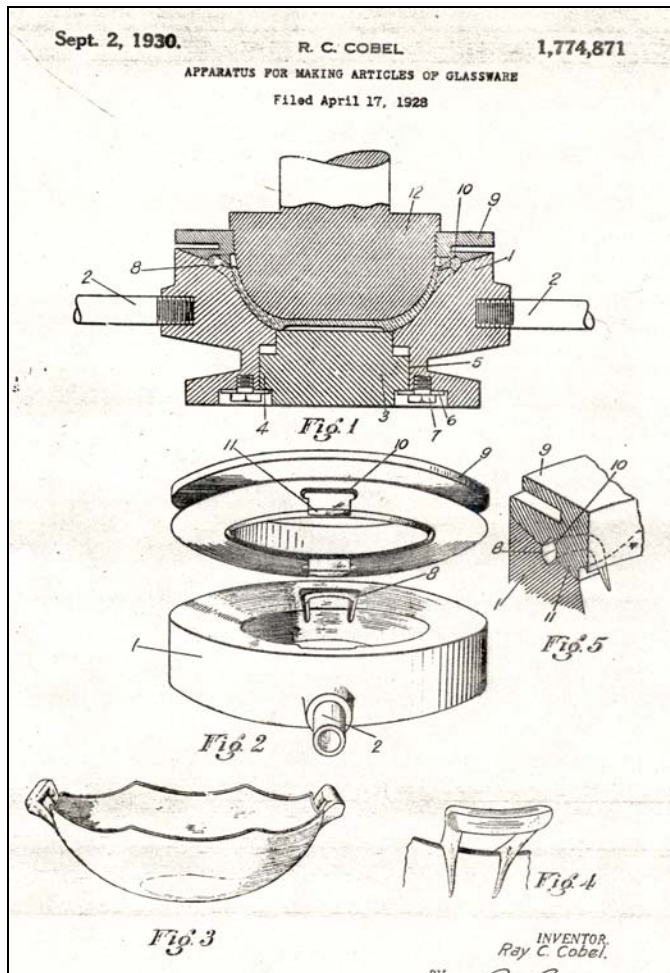
"One of the features of my invention consists in the fact that it comprises a receptacle which may be filled or partially filled with colored material of any type. Another feature of my invention consists in the fact that a fluid-tight stopper is provided. Another feature of my invention resides in the fact that a stopper is provided with a socket for the reception of a candle and with an apron to protect the receptacle from dropping candle grease. My entire structure is preferably designed to simulate, in a general way, a common type of candle holder."

The 520 Innovation candle lamp appears in catalog 109 which is usually dated 1929 but does not appear in the 1933 catalog. The lamp is not an uncommon piece; however, many of them that are found have been stained because of the water that was often put into the bottom receptacle. The Felt and O'Grady *Heisey Candlesticks, Candelabra, and Lamps* reports it being made as late as 1940.

Our next patent is number 1,774,871 granted on September 2, 1930 to Ray C. Cobel, of Newark, Ohio, Assignor to A. H. Heisey and Company. The patent is for an "apparatus for making articles of glassware." The application was filed on April 17, 1928.

I am going to quote from the patent a little more extensively than I do on most so that you can understand the reason for this innovation. The patent reads, "My invention relates to ... making articles of glassware, such as dishes or the like, that are provided with suitable handles."

“Heretofore, it has been customary to make handled glassware, such as dishes or the like, by forming the article by any of the well-known methods, for instance pressing, and then attaching and shaping the handle by hand.

“The attachment of handles to glass articles by hand method is a slow, laborious and consequently, expensive operation, requiring workmen of a high degree of skill. In addition to this, such method has practically precluded the idea of making glassware having handles thereon of such shape and designs as to add materially to the ornamental effect of the ware.

“Making handled glassware, such as dishes or the like, by forming the body portion and then attaching and shaping the handles has had the added disadvantage which results from attaching two pieces of glass together when such pieces of

glass are at different temperatures. A perfect weld is seldom, if ever, formed between the pieces of glass under such conditions and, in glassware having handles thereon, this has increased the possibility of the handles breaking away from the body portion of the article.

“One object of my invention is to provide a method and apparatus for making glassware, such as dishes or the like, having handles thereon whereby the handles are formed integrally and simultaneously with the body of the article.”

The drawings that accompany the patent display a mold and the final glass article made from the mold, in this case a 1229 Octagon jelly. The distinctive 1229 handles were formed within the mold using the process described in this patent. Given that separate parts of the mold were devoted solely to producing these handles, it is easy to see how these handles also appear on pieces of 1252 Twist rather than the traditional single point handles that are shown in the catalog drawings for the Twist pattern. Both styles of handles were made using this method.

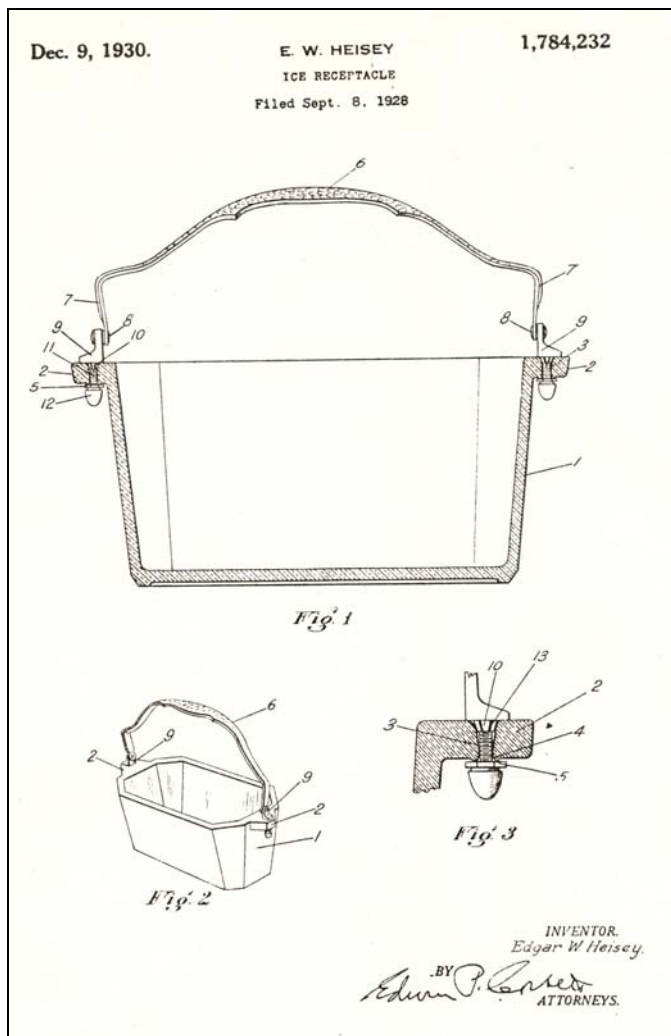
Patent 1,784,232 was granted on December 9, 1930 to Edgar Wilson Heisey for an “Ice Receptacle.” This patent was applied for on September 8, 1928. The patent reads, “My invention relates to ice receptacles. It has to do particularly with that type of article frequently referred to as an ice tub and used for the transportation of cracked ice, ice cubes, et cetera.

“One of the objects of my invention is to provide an ice receptacle which comprises a container portion formed of glass and a handle structure which is readily attachable to minimize the strains incident to the connection of the container and the handle structure.

“Another object of my invention is to produce a container structure of glass having lugs integrally formed thereon. These lugs are not only integrally formed but they are provided with specially shaped and reinforced apertures

designed for cooperation with a specially shaped and reinforced connecting bolt structure which forms a part of the handle structure of my device.

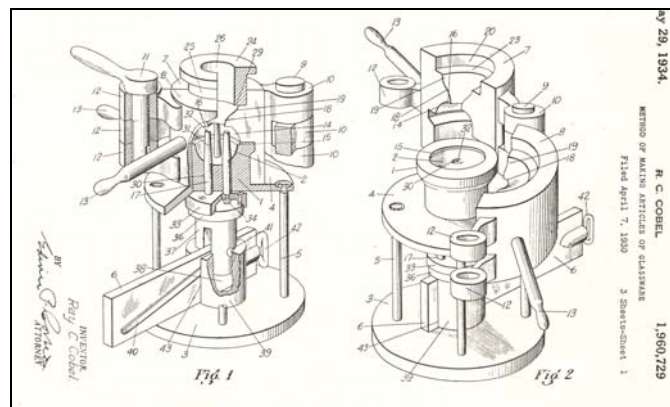
“More specifically, my invention comprises a container structure of glass having integral apertured lugs. These lugs preferably have their apertures formed on a taper and provided with a reinforcing annular lip at the bottom thereof. The handle structure preferably comprises a bowed member whose ends are pivotally connected to the L-shaped heads of bolts having tapered shanks which are adapted to be disposed with a wedging action in the apertures of the lugs.”

The design drawing shows the 500 Octagon ice bucket with its distinctive connectors for the handle. The patent was much more about the

connecting apparatus for the handle and bucket including the innovative lugs through which the connection was made. This same patent would covet the similarly designed connection on the 1252 Twist ice bucket.

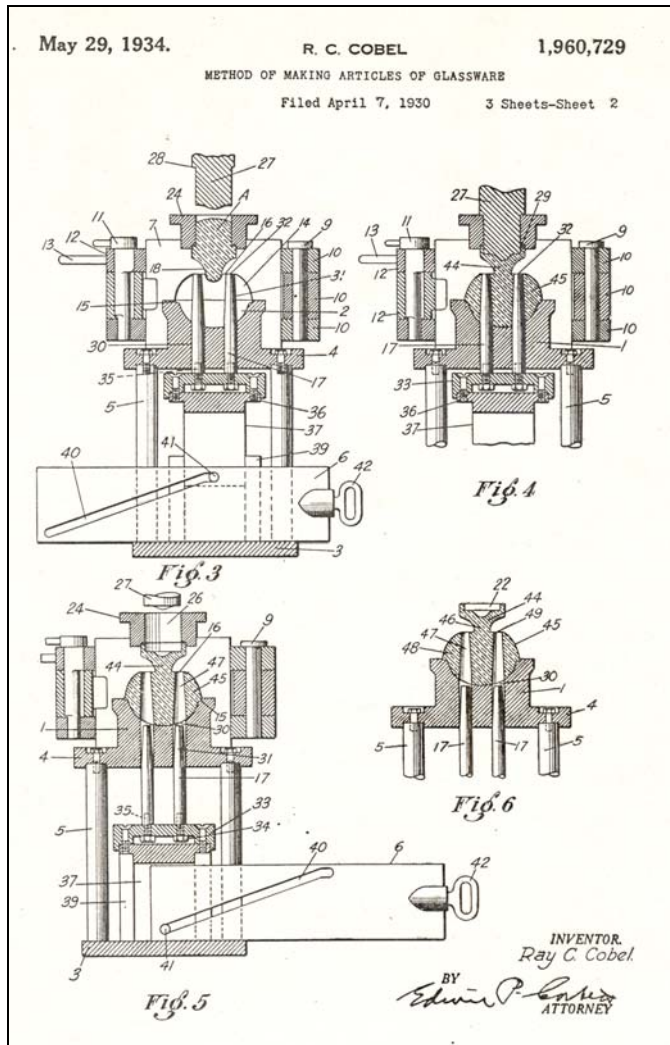


Patent 1,960,729 – Illustration 1

The final patent that we will look at this month is number 1,960,729 issued on May 29, 1934, to Ray C. Cobel for a “method of making articles of glassware.” This application was filed on April 7, 1930. The particular objects covered by this patent are flower blocks with the holes going all the way through the block. Heisey produced three different sized blocks with this process. The number 19 block is 4” (6 holes), the number 20 block is 5” (18 holes), and the number 21 block is 6” (19 holes). These blocks appear to have been made from 1930 to 1938 to be used with various sizes of floral bowls. Heisey also had a series of blocks (numbers 9, 10, and 11) in which the holes did not go all the way through. These were made starting in 1923 but even though production continued until 1938 like the other blocks, it must have been felt that a hole through block would be superior consequentially the newer ones were developed. As the patent explains it took a new process to be able to produce a satisfactory block with the holes going through.

The patent reads, “ One object of my invention is to provide a method of making glassware, such as flower blocks and the like having an apertured body portion, in such a way as to reduce the cost of making such blocks without sacrificing the quality of the blocks.

“Another object of my invention is to provide a method of making flower blocks or the like, whereby the openings therein will be entirely free from closed ends subsequent to the pressing operation, thus obviating the necessity for having a worker punch out the closed ends by hand.

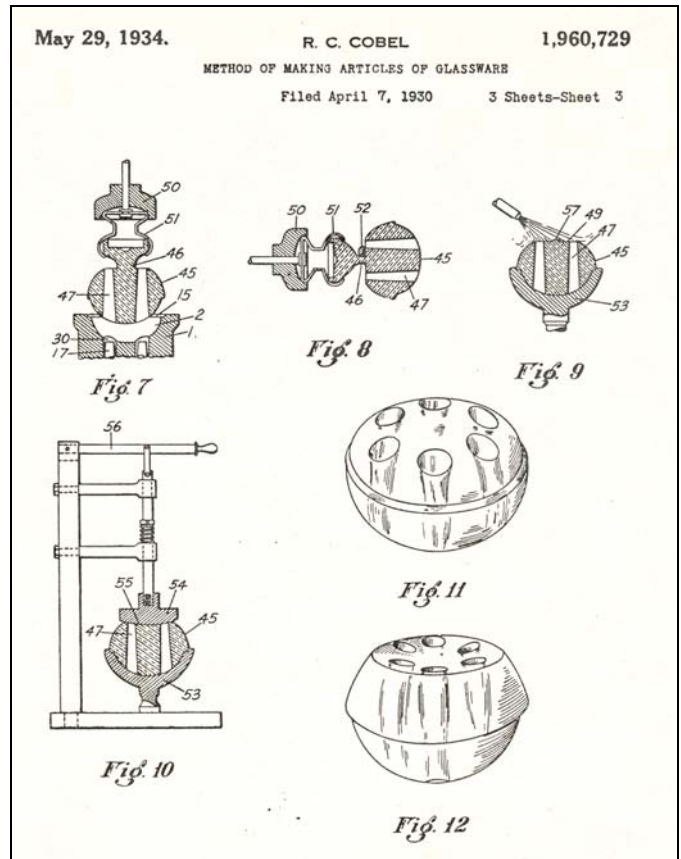

“Another object of my invention lies in the provision of a method for the manufacture of flower blocks, whereby the base of the finished article will be free from chips, cracks and other irregularities and, furthermore, will be smoothed and concave to present a surface of pleasing aspect to the eye.

“Still another object of my invention is to provide a flower block that will rest firmly on a support surface without danger of scratching or

marring the finish thereof, and furthermore, will not spin or rotate when placed thereon.

“My invention contemplates the provision of a method of manufacturing flower blocks and the like, wherein a charge of glass is pressed while in a plastic state in a mold having a plurality of pins disposed therein. These pins are movable into and out of the mold cavity independently of the plunger and, prior to the pressing operation, are adapted to be moved upwardly into the mold until their flattened heads are in firm contact with the flattened upper surface of the mold cavity. Thus, when the charge of glass is pressed in the mold it will be shaped by the contour of the mold cavity and will completely surround each of the pins, although the material will be precluded from entering between the flattened heads of the pin and the flattened upper surface of the mold cavity in view of the fact that these two surfaces lie in intimate contact during the formation of the article in the mold.

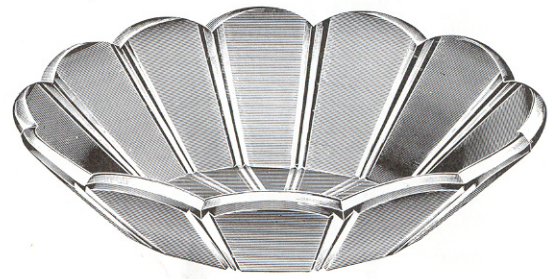
"After the molten material has become substantially fixed to allow the general contours of the openings in the article to retain their respective shapes, the pins are withdrawn therefrom by a suitable means forming a part of my invention, and the mold, which is preferably of the split section type is separated to allow ready access to the article. Furthermore, this mold is of the font type wherein the article that is formed therein will be equipped with a font by means of which the article may be readily lifted from the mold, and suitable means being employed to do this.

"At this time, the pressed article comprises a body portion having a plurality of open-ended apertures therethrough, and a substantially flattened base portion provided with a font formed integrally therewith. While the article is still in a semi-plastic state, it is rotated in contact with the proper tools for reducing the neck of the font, until the neck has been reduced sufficiently to permit ready severance of the font from the main body portion.

"The pressed article, thus far, retains the contour of the mold cavity of the split section mold. The next and final forming operation has to do with concaving and smoothing the base and removing the ragged fragments of material that might be left on the base subsequent to severance of the font. In order to accomplish this, I invert the blank in a former and the base thereof is reheated until the material becomes sufficiently plastic to allow a plunger to be forced downwardly thereon to concave and smooth this portion of the blank. This operation also tends to remove the mold marks from the base and the crown of the blank."

I quoted a lot of this patent because I felt it gave you the whole story on making one of these floral blocks. You can see that Heisey paid a lot of attention to the small details so that they produced a superior product.

Next month we will continue with additional utility patents that were awarded to A. H. Heisey & Company. ♦

466 Nappy

466 PANEL AND DOUBLE PLEAT

This is another short pattern consisting of nappies only. There were six nappies of diameters 4, 4 ½, 5, 7, 8, and 9 inches. Production life was 1914 to 1917 or about 4 years. The nappies were not listed separately as a pattern in the price list but were listed under Miscellaneous.

The design consists of plain panels with an arched top separated by two pleats. The panels carry into the flat bottom. The nappies are signed with the Diamond H. Vogel named the pattern Panel and Double Pleat.

In 1917, the Heisey Company assigned #466 to an 8 inch Fruit Basket. The life of the basket was 1917 to 1925.

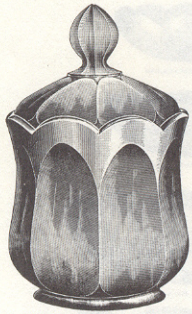

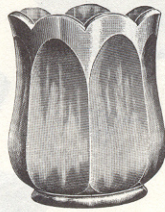

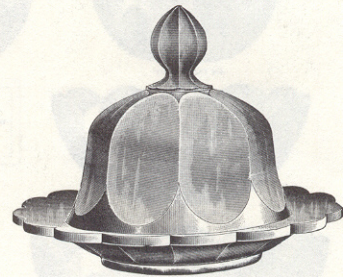
No. 341½ SQUAT SUGAR AND COVER



No. 341½ SQUAT SPOON



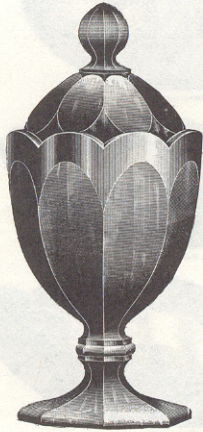
No. 341½ SQUAT CREAM
STUCK HANDLE



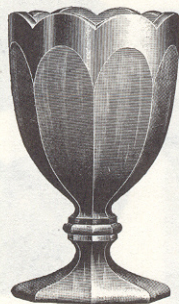
No. 341½ SQUAT BUTTER AND COVER

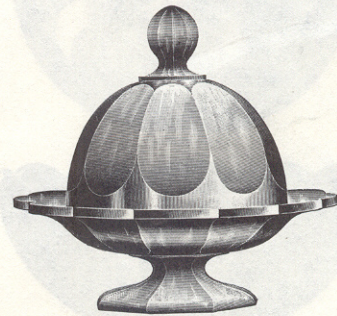
No. 341 FOOTED SUGAR AND COVER

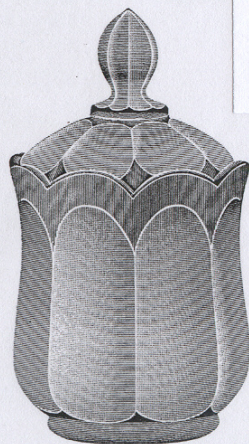

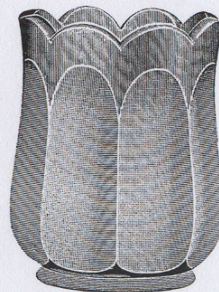
Top 341 ½ Puritan Table Set

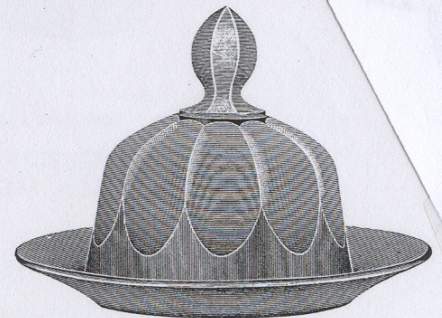

342 paneled colonial

The 342 Panelled Colonial pattern is very small consisting of only a four piece table set. The design was colonial with panels, arches, and scallops on the uncovered pieces. It was named by early Heisey researcher Clarence Vogel.

The 342 pattern design is very close to the table sets for the 341 and 341 ½ Puritan patterns. The knobs on the two covers are the same. The cream, sugar and spoon are similar with 8 panels and a raised bottom. The covered butters have differences. The 342 has 10 panels and the 341 and 341 ½ covers have 8 panels. The butter bottoms for 341 and 341 ½ have scallop edge while the bottom for 342 is round. Perhaps with some fine measurements you might find some other differences.

The 342 pattern life is estimated from 1920 to 1926 or seven years. By the time this set was made the 341 set had long been discontinued. Somewhere in the 1920s, the concept of a 4 piece table set became obsolete. I would guess 342 was made in crystal only and was marked with the Diamond H. The covered butter you can identify. Good luck on the other 3 items – it is very possible that these pieces are identical to the 341 ½ table set pieces.

2009 SELECT AUCTION PREVIEW

On page 13 of this Newsletter, you will find the catalog for the 2009 Select Auction. Boy, do we have a treat in store for you with this auction. The auction has something for everyone's taste and pocketbook. There are little things, there are early pieces, pieces from most of the major patterns. There are animals, vases, and candlesticks galore. Give the catalog a good going over because there is bound to be something that will please you. Now, I am going to go over some of the highlights of the auction which means that I will spotlight some of the rarer pieces because my room is limited and I want to be sure that you do not miss these beauties.

Right off the bat we have a rarely seen tumbler that is bound to tickle the fancy of the tumbler collector, a 1460 Flame tumbler (Lot 2). A couple lots below are two Hexagon Stem colognes with 693 Cloister cut. What distinguished the two colognes is that the stoppers are different but both were stoppers that Heisey offered on this cognie but that changes the pattern number. Lot 9 is the 486 Hexagon Stem cognie and lot 9A is the 493 Hexagon Stem cognie. A beautiful 1201 Fandango cake server (Lot 24) and a 1185/109 Petticoat Dolphin compote in Flamingo (29) follow soon after.

As I said there are a lot of candlesticks and we divided them into three different sections of the auction. But we lead off with some amazing pieces. A 300 Old Williamsburg 3 light candelabrum (single), 20 ½" (37) and a pair of 301 Old Williamsburg short base candelabrum with Cobalt short bases (38) are true standouts. Later in the auction we have a pair of 28 Elizabeth candlesticks, 9" (75) and a pair of 27 Daisy candlesticks, 9", grey cut (80). Late in the auction there is a single 20 Sheffield, 9" (157) and a pair of 1405 Ipswich candle centerpieces with vases (158).

A stunning 22 ½" 300 ½ Peerless swung vase (39) precedes a complete set of 365 Recessed candy jars (41 – 46). Another lovely early piece is a 1280 Winged Scroll 10" dresser tray with excellent gold trim (56). There are several Heisey baskets but probably the standout among them is a 459 Round

Colonial, 7" with frosted panels that have been cut to clear (68). You do not see such a piece often.

In Moongleam there are a couple of great pieces including a 419 marked Sussex goblet with a Moongleam stem and foot (86) (you usually only see this with a Moongleam bowl). The other great piece in Moongleam is a 1420 Tulip vase (87). Later on in the auction there is another 1420 Tulip vase but this time in crystal with a great cutting (142).

A couple of nice etched pieces include dinner bells in both 509 Orchid (101) and in 515 Heisey Rose (106). There is also a really nice 1519 Waverly fan vase with 515 Heisey Rose (103).

Zircon/Limelight is well represented with a 1489 Saturn flared vase, 8 ½" (110), a 1506 Provincial footed candy box (111), a 4085 Saturn 4" ball vase (112), and a 4085 Kohinoor wine with a zircon bowl (113). In Dawn we have a 1951 Cabochon butter (128) and in Tangerine a 3397 Gascony wine (131).

We have one of the rarer pieces of 1503 Crystolite in the auction: a 9" lily vase (120) – truly magnificent. In 1540 Lariat there is a 10 basket with the side loops (144).

The auction has several rarer pieces with deep plate etches including a 4054 Coronation martini pitcher with 510 Tavern etch (136), a 2052 1 ½ oz bar with 474 Circus – Clowns etch (139), and two different 4163 Whaley beer mugs, one with 465 Golfer etch (137) and one with 459 Fisherman etch (138).

Lot 141 is a tall 1540 Aristocrat candy jar with lid beautifully cut with 794 Riviere cutting. We have a set of 4 1401 Empress 8" square plates in Cobalt (150) and 7" and 8" 2323 Navy plates (151, 152).

Lot 161 is a 1401 Empress 8" square plate in Alexandrite with a Krall cutting. This is one of a set of 12 plates that was broken up many years ago. Also in Alexandrite we have a 1001 Maezene marmalade (162). The final two items I will mention is a 464 Ribbon Candy 2 qt. jug (163) and a 517 tumble up set with the pitcher having a nice floral cutting (164).

This is an outstanding auction. I hope you can make it here to Newark. If not, please consider sending in an absentee bid. As you know, it is for a good cause.

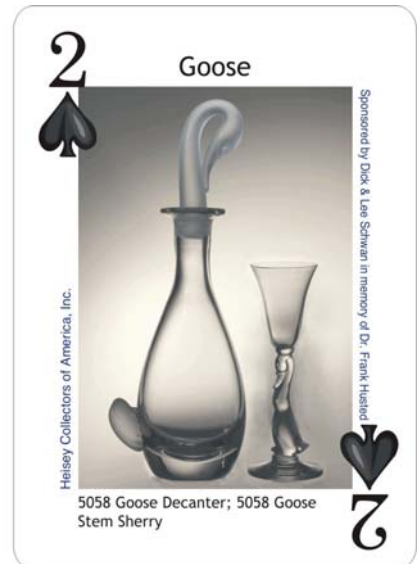
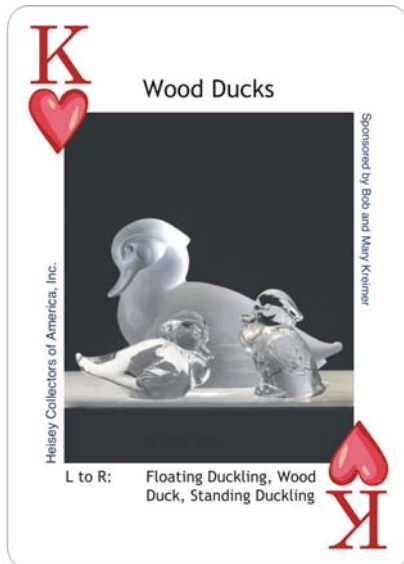
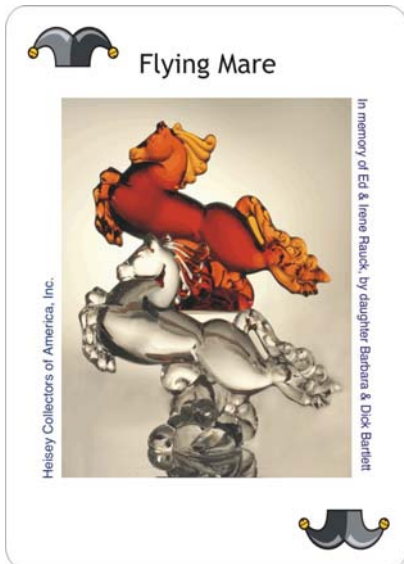
HEISEY GLASS MUSEUM PLAYING CARDS

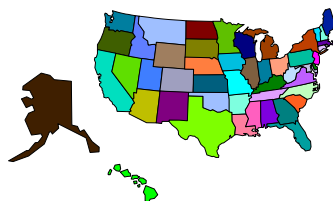

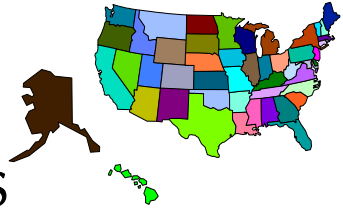

John's wife George Ann was at this meeting, so we knew she would know what would have pleased John. And she did, George Ann mention #503 Minuet etch was John Powell's favorite. So, we are writing to HCA, to see just what might be needed with this beautiful etching on it. John was a long time member in HCT and HCA, and very active member, I might add.

We had some delicious refreshments that Lynn had prepared, served on Heisey crystal, of course. And at this time we also checked out all the beautiful Heisey Lynn had in her home. Interesting note I want to share, brought back memories to Anne and Paul (HCT members now). They mention to me, that the first Heisey meeting they attended was at Lynn and her late husband Stan's home, back many years ago when they had just joined the National Capital Heisey Collectors Club. Both couples, after retirement, moved to Florida and were active in a Heisey Club there, and both have moved to Texas and joined HCT. Unfortunately Stan, Lynn's husband became ill and never was able to make it to a HCT meeting. But, isn't that wonderful to have such dedicated Heisey members through the years.

This "Show & Tell" was also our program this month, so many pieces were brought, and each one was described, which is how we learn to find that next piece of Heisey!

Candy & Greg went to Convention this year, so Greg gave us a mini-report on the 2009 Convention. So many things going on, they had a hard time getting to everything, but what they did get to was great, as usual! Many items they carried to the meeting came from the trip to Convention, before – during – after! How about a Sahara 4164 Gallagher jug with 447 Empress etch, and a Sahara 2351 Newton soda with 447 Empress etch! Dinner cup in No. 4044 New Era with a 825 Sea Glade cut, 1485 Saturn 2 light candleblock in crystal, 121 Pinwheel candlestick in Hawthorne, and a 126 Trophy candlestick in Flamingo. Also, a unusual 12" celery, only one person knew the pattern, it was 1447 Rococo. That is one you will have to check the book on!!! Salt shaker in 343 Sunburst, 112 Mars candlestick in Moongleam, 1552 Four Leaf candlestick and they had to get at least one animal, which was a cute little Heisey bunny head up! I would say they had quite a trip!

Sim did not go to the Convention, but he had some goodies too. First of all, I have to tell you about the piece that all of us were in shock. This was when he pulled out a 7 ½" Electro-portable satin shade with Heisey No. 1 cutting. We just so happen to have a few members in HCT that needs that Shade – but Sim needed it also. No one could talk Sim out of that one, but what a treat to see one, which I have to tell you, he found it at a big flea market, not a antique show or mall! More goodies, 1184 Yeoman 7" low footed comport with beautiful cutting, 9" high footed 1235 Beaded Panel & Sunburst bowl, 3362 Charter Oak 8oz. luncheon goblet in Flamingo, and a Moongleam 1405 Ipswich 2 handled sugar bowl and 6" underplate, a Sahara 1469 Ridgeleigh cigarette box and cover, a 1506 Whirlpool 2 ½" individual nut (really different), and a 300 Peerless spoon tray. Candlesticks in 22 Windsor 7 ½" with unknown cutting, and a pair of 100 Centennial 6", stained yellow with gold trim – cut to clear and signed HAWKES and with the Diamond H, this is something you don't find every day either!

How about having a friend whose crystal was Heisey Crystalite for years and she decides to give it to her friend, who also has the same pattern? That happen

to Madeline, and as she unpacked the boxes, the pieces she did not have she shared with us today, and this is the No.1503 1/2 coffee or tea cup with saucer, which is kind of the hard-to-find set. This is what I call a "great friend"!!!

Sim also enlighten us all with a beautiful Ruby Rose Bowl, No. 230 Neapolitan Line, circa 1890, by Hobbs, Brockunier. Sim collects a lot of different glass, and has a great library to identify pieces of glass from many glass companies. So, Sim and his wife Betty have invited us all to head south to their home in lola, TX in September. The program will be "ID," bring along any Heisey or other piece you may want to be identified! This will be very enjoyable learning experience; don't miss it – September 12 at 1 p.m. in lola, TX!

He also remembers working in the cooling area where the glass was immersed in water baths. His favorite story was about being hidden when inspectors came to the factory as he was under age. His supervisor hid him in the cooper shop until the inspectors were gone. He explained that in those days the cooper shop made barrels to ship the Heisey glass. Bill became familiar with the Heisey family much earlier than his employment at the factory however, because he delivered an abundance of telegrams to the Heisey's Granville Street home when he worked as a Western Union delivery boy. Bill resided at the corner of Russell and O'Bannon Streets with his parents and his sister Margaret (Cochran) and attended the Hazel Street School. Margaret who is now 92 was also an employee of the Heisey factory and she resides in Mt. Vernon, Ohio. She longs to see the Heisey Museum and would love to attend the former

employee's reception during Convention. We have given Bill our assurance that we will contact her and see to it that she gets to the reception, but only if we can stop by the Velvet Ice Cream factory. His eyes lit up with delight at the memory of the ice cream factory. Bill and Marie remain in good health, have never needed glasses and attribute their long lives to Marie's cooking; nothing store bought, cooked from scratch, always fresh and in moderation.
